Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Verida 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Verida 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes To Financial Statements

NOTE 1. PLAN DESCRIPTION

The following brief description of the Verida 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General

The Plan is a defined contribution plan formed to provide benefits exclusively for the employees of Verida, Inc. (the "Company") who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and is designed to comply with all regulations of the Internal Revenue Service ("IRS"). On September 1, 2023, the Plan name changed from Southeastrans 401(k) Plan to Verida 401(k) Plan.

Eligibility

Employees are immediately eligible to participate in the Plan on their date of hire. Nonresident aliens with no U.S. earned income, union employees, and leased employees are excluded.

Contributions

Employees of the Company participating in the Plan are entitled to make before and after-tax contributions to the Plan through payroll deductions in amounts up to the maximum percentage allowable not to exceed limits of the Internal Revenue Code (the "Code"). Maximum contributions in any calendar year are set by the IRS. Catch up contributions are permitted under the Plan in accordance with IRS limitations. Participants may also roll over contribution amounts representing distributions from other qualified defined benefit or defined contribution plans. Corrective distributions are netted against contributions received on the statement of changes in net assets available for benefits because they represent ineligible contributions for the plan year.

The Plan has an automatic enrollment provision for newly eligible employees on the first entry date. Employees have an automatic initial pre-tax deferral at 2% of eligible compensation. A participant may direct contributions to any of the Plan's eligible investment options. Participants may change their investment options at any time.

The Company, at its discretion, may make profit-sharing contributions and/or matching contributions each plan year. There were no profit-sharing or matching contributions for the year ended December 31, 2024. During the year, the Company made a discretionary employer contribution of \$-.

The Plan records employer and participant contributions receivable when compensation is paid. In accordance with ASC 326, *Financial Instruments - Credit Losses*, no allowance for credit losses has been recorded at December 31, 2024 and December 31, 2023, as employer and participant contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

NOTE 1. PLAN DESCRIPTION (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution, Company matching contributions and profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus (minus) earnings thereon, including rollover and transfer contributions. Vesting in any employer matching and/or nonelective profit-sharing contribution portion of their account is based on years of continuous service. After one year a participant is 20% vested. A participant continues to vest 20% for each successive year until they are 100% vested after five years of credited vesting service. Participants automatically become 100% vested upon total and permanent disability or death.

Payment of Benefits

On termination of service due to death, disability, or retirement, distributions under the Plan are made in lump-sum payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are permitted.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,297 and \$9,301, respectively. These accounts are available to pay administrative expenses and reduce future employer contributions. Also, in 2024, expenses totaling \$9,431 were paid and no employer contributions were reduced from forfeited nonvested accounts.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements that would have a material impact on its financial statements.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of shares held by the Plan and can be redeemed at NAV as of the measurement date.

Collective Investment Trusts: Valued at the net asset value (NAV) of shares held by the Plan and can be redeemed at NAV as of the measurement date.

NOTE 5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Principal Life Insurance Company is the trustee as defined by the Plan and, therefore, transactions with them qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in administrative expenses and net appreciation in fair value of investments. The Company pays directly any other fees related to the Plan’s operation.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the relevant taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8.**RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
