- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## *Notes to Financial Statements*

### **Note 1 - Description of the Plan**

The following description of the Charlesbank Capital Partners, LLC Money Purchase Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a non-contributory defined contribution plan covering all employees of Charlesbank Capital Partners, LLC ("Employer"), except residents of Puerto Rico, leased employees, employees classified as a student intern, cooperative student, project assistants, or those with a status as an independent contractor ("Participants"). Upon reaching the age of 21 and completing 1,000 hours of service, student interns and project assistants become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Investment options available under the Plan are determined by fiduciaries. Substantially all investments are participant-directed.

#### **Employer Non-Elective Contributions**

Each year, the Employer will contribute a non-elective contribution of 10% of each eligible participant's compensation, as defined. For the year ended December 31, 2024, the Employer's non-elective contribution amounted to \$3,687,898.

#### **Rollover Contributions**

Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans ("Participant Rollovers").

#### **Participant Accounts**

Each participant's account is credited with the Employer's contributions, their own rollovers and Plan investment earnings/losses thereon and charged with administrative expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

The Participant is always 100% vested in rollover contributions and Employer non-elective contributions, and any earnings thereon.

#### **Payment of Benefits**

Participants are entitled to their vested account balance upon death, disability, retirement or termination of employment. A participant may elect to receive a lump sum, installment payments or joint and survivor annuity. In-service withdrawals from a participant's vested account balance are permitted upon the attainment of age 59½.

***Payment of Benefits (Continued)***

If a participant's vested account balance is equal to or less than \$1,000, the Plan administrator will direct the Trustee to distribute the amount to the Participant in a lump sum without the Participant's consent. If the vested account balance is greater than \$1,000, the Participant may delay their distribution until they are required by law to receive Required Minimum Distributions.

***Note 2 - Summary of Significant Accounting Policies***

***Basis of Presentation***

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from those estimates.

***Benefits Paid***

Benefit payments to participants are recorded upon distribution.

***Subsequent Events***

The Plan has evaluated subsequent events through September 30, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

***Note 3 - Information Certified by Trustee and Custodian***

Plan investments are held by Fidelity Management Trust Company (“Fidelity”), the Plan’s trustee and custodian. Fidelity has certified to the fair value of investments as of December 31, 2024 and 2023 and investment transactions during the year ended December 31, 2024. Investment transactions include interest and dividend income, and net appreciation in fair values of investments. Information included in the supplemental schedule has also been derived from information certified by Fidelity. Participants may direct contributions to several investment options.

***Note 4 - Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds and Cash Equivalents (included in Self-directed brokerage accounts)***

Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Exchange Traded Funds (included in Self-directed brokerage accounts)**

Valued at the NAV of shares held by the Plan at year end, as quoted in the active market, and are classified within Level I of the valuation hierarchy.

**Common Stocks (included in Self-directed brokerage accounts)**

Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

***Note 5 - Risk and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events, such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

***Note 6 - Related-Party Transactions and Party-in-Interest Transactions***

Certain Plan investments are managed by Fidelity, the trustee and custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. During 2024, the Plan paid Fidelity \$4,824 for plan expenses.

***Note 7 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in all of their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

***Note 8 - Tax Status***

The Plan has adopted the volume submitter profit sharing plan of Fidelity Management and Research Company that received a favorable opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the form of the volume submitter profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.


