Note 1. Description of the Plan

The following description of the Plumb Supply Company 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Plumb Supply Company, LLC (Company) for the benefit of substantially all non-collectively bargained employees who have at least three months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company (Principal) serves as the Plan trustee and custodian of the Plan.

For purposes of employer contributions, employees of the Company are either part of the Iowa division or the Missouri division.

Contributions

The Plan permits eligible employees, through a salary deferral election, to make annual contributions of up to 50% of eligible compensation after three months of service, up to the maximum allowed by law. Employee rollover contributions are also permitted. The Plan permits non-elective contributions by the employer to the Plan on behalf of Iowa division personnel and this annual contribution to the Plan shall be determined at the discretion of the Company. The Plan permits matching contributions by the employer to the Plan on behalf of Missouri division personnel. This contribution is discretionary and currently is set such that the Company matches 50% of the first 6% of employee deferrals. Employees are eligible to receive a portion of the Company contribution and forfeitures of terminated participants' non-vested accounts after one year of credited service.

The Plan also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The elective deferrals of participants that were automatically enrolled are subject to a 1% annual increase until a cap of 5% is reached. Effective September 1, 2023, the automatic deferral feature was amended to begin at 6% subject to a 1% annual increase until a cap of 10% is reached. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Company's contribution, Plan earnings and forfeitures of terminated participants' nonvested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the portion of participants' accounts contributed by the Company, plus earnings thereon, is based on years of credited service.

For the portion of the participants' accounts contributed by the Company prior to the 2007 Plan year, a participant is fully vested after 7 years of credited service, with 20% vested after 3 years, 40% vested after 4 years, 60% vested after 5 years and 80% vested after 6 years.

For the portion of participants' accounts contributed by the Company for Plan years including and subsequent to 2007, a participant is fully vested after 6 years of credited service, with 20% vested after 2 years, 40% vested after 3 years, 60% vested after 4 years and 80% vested after 5 years.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his account, or a joint or survivor annuity. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan. Benefit payments to participants are recorded upon distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$101,879 and \$70,287, respectively. These accounts will be reallocated to eligible participants in the same manner as Company contributions. Forfeitures reallocated amongst eligible participants amounted to \$70,601 and \$113,795 for 2024 and 2023, respectively.

Notes Receivable From Participants

Participant loans are not permitted by the Plan.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interest in the collective trust investments are valued at NAV utilizing the practical expedient. Pooled separate accounts are valued at estimated fair value as provided by Principal utilizing quoted market prices of the underlying mutual funds on the last business day of the Plan year. There are no redemption restrictions, redemptions are daily and there are no unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by Principal Life Insurance Company. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date. The Plan has not obtained or requested a determination letter due to the prototype receiving a favorable opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Administrative Expenses and Mutual Fund Rebate Income

The cost and expense of administering the Plan shall be paid by the Plan to the extent that the Company does not pay such expenses. The Plan invested in certain mutual funds which charged fees to participants where those fees were in turn, rebated. The rebate income from these investments is reported as other income and for the years ended December 31, 2024 and 2023, was \$10,906 and \$8,472, respectively.

Subsequent Events

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Note 5. Party-in-Interest Transactions

The Plan invests in certain funds of the Plan trustee. Administrative fees paid to the Plan trustee totaled \$139,220 and \$123,174 for the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that
