Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Manitou Americas Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Manitou Americas Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Manitou Americas Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Notes to Financial Statements

Note 1: Description of Plan

The following description of Manitou Americas Savings Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a defined contribution plan sponsored by Manitou America Holding, Inc. (the Sponsor). The Sponsor is the Plan Administrator. Investments are all participant-directed. The custodian of the Plan is Matrix Trust Company (Matrix). The recordkeeper of the Plan is OneAmerica Retirement Services LLC (OneAmerica).

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Eligibility

Eligible employees include all non-union part-time and full-time U.S. employees of Manitou North America, LLC and Manitou Equipment America, LLC having completed two months of employment and were scheduled to work 40 hours per week. As of January 1, 2024, long-term part-time (LTPT), non-union employees who worked more than 500 hours in three consecutive years are eligible to participate in the Plan. Prior to January 1, 2024, LTPT employees who weren't scheduled to work 40 hours per week were eligible if they completed at least 1,000 hours of employment in the Plan year. Once employees become eligible, they are able to enter the Plan on the first day following the quarter-end.

Contributions

Participants may make elective deferral contributions to the Plan. Participants are automatically enrolled to make contributions of 3% of eligible compensation upon becoming eligible to participate in the Plan unless the participant elects a different percentage. Any participant who has been previously auto enrolled will also have their deferral escalated by 1% each year to a maximum of 6%, providing the participant does not elect a different deferral election. A participant may make contributions of 1%, or any whole multiple thereof, up to a combined total of 75% of defined annual compensation, subject to an annual limitation defined by the Internal Revenue Service (IRS). Participants may elect to make pre-tax contributions, after tax Roth contributions, or a combination of both. The Plan allows qualifying rollover contributions, as defined.

Sponsor contributions to all eligible participants of the Plan are 2% of eligible compensation regardless of their contribution level. The Sponsor also matches employee contributions dollar for dollar for the first 2% of income deferred, and fifty cents on the dollar for the next 4% of income deferred.

In 2024, the Plan received \$1,053,416 from a qualified pension plan sponsored by the Company that terminated in 2023. These funds were placed into the Plan's unallocated forfeiture account to be used to fund Sponsor contributions. These funds are included as a contribution receivable on the Statement of Net Assets Available for Benefits. All of the funds were used or will be used to offset Sponsor contributions in 2024 and 2025.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor contributions, and allocation of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Sponsor contributions are fully vested after two years of service. Participants are automatically fully vested upon attainment of age 65 or upon retirement due to death, disability, or termination of the Plan.

Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment prior to becoming fully vested. Forfeitures are used to reduce Sponsor contributions or to offset administrative expenses. The Plan provides for restoration of forfeited funds upon re-employment of former participants in certain circumstances. Unallocated forfeitures were \$118,289 and \$105,938 as of December 31, 2024 and 2023, respectively. Forfeitures of \$104,163 were used to reduce the Sponsor's matching contributions during the year ended December 31, 2024.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participant accounts with values of less than \$1,000 will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment and accounts with values of \$1,000 to \$7,000 will be automatically rolled into an IRA unless the participant directs otherwise.

Administrative Expenses

Custodian fees, investment management fees, recordkeeping fees, and other administrative expenses of the Plan are paid by the Plan, unless voluntarily paid by the Sponsor. Fees paid to administer the Plan by the Sponsor are excluded from these financial statements.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through August 19, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end registered mutual funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Putnam stable value collective trust fund: Valued using audited financial statements and derived NAV per share of the collective trust at year-end. The stable value fund can be redeemed on a daily basis at its NAV. The fund doesn't have any unfunded commitments.

Note 3: Fair Value Measurements (Continued)

The stable value fund invests in traditional and synthetic guaranteed income contracts with various crediting formulas. The investment objective of the stable value fund is to maintain safety of principal while generating a level of current income that is consistent with that of a money market fund. The fund seeks to maintain a stable \$1.00 unit value, although there is no guarantee it will be able to do so. There are no valuation reserves.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Information Prepared and Certified by Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Matrix as of December 31, 2024.

Note 5: Tax Status

The IRS has determined and informed the Plan by a letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Party-In-Interest Transactions

Custodian and recordkeeping fees involving Matrix and OneAmerica, are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under Section 29 CFR 408(b) of the ERISA regulations.
