## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Mirabito Holdings, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Mirabito Holdings, Inc. and Subsidiaries and Affiliates (collectively, the Company). The Plan contains both 401(k) and profit-sharing provisions. Unless otherwise indicated, the Plan provisions are identical for both components. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Company is the sponsor and administrator of the Plan. Ameritas Life Insurance Corp. (Ameritas) is the custodian, third-party administrator and recordkeeper of the Plan. Two members of management and NBT Bank serve as the trustees of the Plan.

#### **Eligibility**

Employees are eligible to participate in the Plan upon the attainment of age twenty-one. Employees participate in the Plan as soon as administratively feasible upon completion of eligibility requirements.

#### **Participant Contributions**

Participants may make voluntary tax-deferred contributions up to 100% of eligible compensation to the Plan, up to the maximum amount allowable in accordance with applicable sections of the Internal Revenue Code (IRC).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation and their contributions treated as a pre-tax deferral. Participants who are automatically enrolled in the Plan have the option to cease contributions and withdraw funds contributed to the Plan within 90 days of the first automatic deferral.

The Plan also includes an auto-increase provision whereby, after the third year of participation, on January 1<sup>st</sup> of each Plan year, participants' deferral rates will increase by 1% up to a maximum of 10% of eligible compensation. The auto-increase provision applies only to those participants who were auto-enrolled and have not opted out of the auto-increase or completed a salary deferral agreement electing an alternative deferral amount. Participants may complete a salary deferral agreement to elect an alternative deferral amount or to elect not to defer under the Plan in accordance with the deferral procedures of the Plan.

#### **Employer Matching Contributions**

The Plan includes a qualified automatic contribution arrangement safe harbor provision. The employer matching safe harbor contributions is equal to 100% of the first 1% of a participant's salary deferral plus 50% of a participant's salary deferral between 1% and 6%.

## 1. DESCRIPTION OF PLAN (Continued)

### **Employer Matching Contributions (Continued)**

The Company may also make matching contributions on behalf of its employees on a discretionary basis. Employer discretionary matching contributions are based on a discretionary percentage or amount to be determined by the Company and applied on a uniform basis for all participants. The Company did not make any discretionary matching contributions to the Plan during 2024 or 2023.

### **Employer Discretionary Profit-Sharing Contributions**

The Company may also make discretionary profit-sharing contributions on behalf of participants as determined annually by the Company. The Company made no discretionary profit-sharing contributions to the Plan for the years ended December 31, 2024 and 2023.

### **Participant Accounts**

Participants direct the investment of their contributions and Company contributions into the various investment options offered by the Plan. Each participant's account is credited with the participant's contribution, employer matching contributions, actual account earnings/losses, and allocations of (a) the employer discretionary profit-sharing contributions, and (b) Plan expenses. Allocations of profit-sharing contributions and Plan expenses are allocated based on participant compensation and account balances, respectively, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. The Company's discretionary matching and profit-sharing contributions vest 50% after one year of service and are fully vested after two years of service. Employer matching safe harbor contributions are 100% vested after two years of service.

Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year for those participants for whom hourly records are kept. Other participants for whom hourly records are not kept, the Plan uses an equivalency method. Under this method, participants are credited with 45 hours of service for each week during the Plan year in which they would otherwise be credited with at least 1 hour of service. A participant also becomes fully vested upon attaining normal retirement age, death, or total and permanent disability.

### **Forfeitures**

Forfeitures of non-vested account balances are used to reduce Company contributions or pay plan expenses. Forfeitures, including appreciation (depreciation) thereon, totaled \$130,900 and \$185,948 during 2024 and 2023, respectively. Forfeited non-vested accounts totaled \$6,326 and \$14,683 at December 31, 2024 and 2023, respectively. The Company applied \$139,257 and \$188,075 of forfeitures to reduce Company matching contributions in 2024 and 2023.

### **Notes Receivable from Participants**

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes receivable are payable over a period not to exceed 5 years, except when used to acquire a principal residence. Notes receivable are secured by the participant's account and bear interest at a fixed rate of Prime plus 1% at the first business day of the month that the loan is originated. Principal and interest are paid ratably through weekly payroll deductions over the term of the loan.

## 1. DESCRIPTION OF PLAN (Continued)

### **Benefit Payments**

The Plan provides for benefit payments upon termination of service due to death, disability or attainment of retirement age. Participants may elect disbursement of their vested account balance in a lump-sum amount or direct rollover into an individual retirement account or another qualified plan. The normal retirement age is the date a participant reaches the age of 65. Participants whose vested account balance is \$5,000 or less at the time of termination are subject to the involuntary cash-out provisions of the Plan.

### **In-Service Withdrawals**

Participants may elect disbursement of all or part of the elective deferral portion of their account balance upon the attainment of age 59 ½. Employer contributions may not be disbursed until the attainment of age 65, unless the participant is fully vested in the employer contributions and has attained the age of 59 ½. Participants may also withdraw their rollover contribution account balance at any time.

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted from a participant's account under certain circumstances. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Administrative Expenses**

The Plan pays most of the administrative expenses associated with the administration of the Plan. Certain administrative expenses are paid by the Company.

### **Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investments and Income Recognition**

The Plan's investments in the pooled separate accounts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

The Plan's investment in the guaranteed investment contract is a fully benefit-responsive investment contract stated at contract value as reported by Ameritas. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value Measurements - Definition and Hierarchy**

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### **Benefit Payments**

Benefits are recorded when paid.

### **Risks and Uncertainties**

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 4. FAIR VALUE MEASUREMENTS

For the year ended December 31, 2024, the Plan's investments in pooled separate accounts are presented at net asset value (NAV) as a practical expedient in accordance with ASC 820. For the year ended December 31, 2023, these investments were included within the fair value hierarchy as Level 2. Management has determined that presentation at NAV more appropriately reflects the nature of these investments, and accordingly, prior year disclosures have been reclassified to conform to the current year presentation.

The following is a description of the valuation methodology used for assets measured at fair value.

*Pooled separate accounts:* valued at fair value using the NAV per share (or unit) as a practical expedient. The NAV is determined by the insurance company and is based on the fair value of the underlying investments, investment income, and expenses attributable to the account. The investment strategies of the pooled separate accounts are to invest in underlying funds with the goal of providing long-term growth and returns consistent with the stated investment objectives. There are no restrictions on redemptions of the pooled separate accounts, and there are no unfunded commitments.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in different fair value measurements at the reporting date.

#### 5. GUARANTEED INVESTMENT CONTRACT

The Plan's investment in the guaranteed investment contract is a fully-benefit responsive investment contract (Guaranteed Account) with Ameritas that is reported at contract value. Ameritas maintains the contributions in a general account. The Guaranteed Account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average yield in the Plan is the percentage earnings credited in the Guaranteed Account for the year, based on the end of year fair value of Guaranteed Account assets. These earnings represent the entire investment return of the Guaranteed Account within this contract. The weighted average interest crediting rate is the weighted average of all new and renewal rates of the contract for each calendar quarter. These rates are guaranteed for the entire duration of the guaranteed period and do not vary with the subsequent performance of assets of the Ameritas general account which back these guarantees. The average yields for the investment contract and weighted average interest crediting rates on the investment contract as reported by Ameritas were 3.51% and 2.19%, and 3.61% and 3.88%, respectively, for the years ended December 31, 2024 and 2023, respectively. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the issuer's ability to meet its financial obligation, which may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan Sponsor and/or Plan participants to transact at contract value with Ameritas. Examples of these events would include (but would not be limited to) premature termination of this contract and termination of the Plan. In these examples, the contract value could be reduced by any applicable surrender charges upon distribution of contract's funds.

The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable.

#### 6. PARTY-IN-INTEREST TRANSACTIONS

Plan investments include pooled separate accounts and a guaranteed investment contract managed by Ameritas, the custodian of the Plan. Therefore, transactions involving these securities qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions.

## **7. INCOME TAX STATUS**

The Plan adopted a pre-approved plan offered by Ameritas Life Insurance. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. RECONCILIATION TO FORM 5500**

While net assets available for benefits and change in net assets available agree between the financial statements and Form 5500 in total as of and for the years ended December 31, 2024 and 2023, certain classifications differ between the financial statements and Form 5500.

## **9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.
