**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Thrift Plan for Employees of the American Bar Association and Affiliates (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

**NOTE A - DESCRIPTION OF THE PLAN**

***General***

The Thrift Plan for Employees of the American Bar Association and Affiliates (the Plan) is a defined contribution plan covering substantially all eligible employees of the American Bar Association, the American Bar Endowment, the National Judicial College, the ABA Retirement Funds and the American Lawyers Insurance Plans, Inc. (formerly American Bar Insurance Plans Consultants, Inc.) (collectively, the Sponsors). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

***Plan Administration***

The Plan is administered by the Committee for the Thrift Plan for Employees of the American Bar Association and Affiliates. Fidelity Management Trust Company (FMTTC) is the trustee of the Plan and Fidelity Workplace Services is the recordkeeper of the Plan.

***Eligibility, Contributions and Vesting***

All employees who have completed 30 days of employment may participate in the Plan. Leased employees, nonresident aliens and any individual who performs services outside of the United States of America as a volunteer of the Sponsors are not eligible to participate in the Plan. Eligible employees may begin participating in the Plan on the first day of the month after having met the Plan's eligibility requirements. Participants may voluntarily contribute 1% to 50% in whole percentages of their covered compensation, which excludes severance pay and certain fringe benefits. These contributions can be made using pretax dollars or can be designated as Roth contributions. The maximum employee deferral contribution is 50% of an employee's covered compensation, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained the age of 50 may make additional catch-up contributions to the Plan. Participants may also make contributions representing distributions from other qualified plans or individual retirement account (rollovers) to the Plan. The Sponsors match 50% of deferral contributions up to 6% of compensation. This match is calculated on a pay period basis. Employees must have completed one year of employment to be eligible for the Sponsors' matching contribution. For certain eligible employees, the Sponsors will also make a non-elective contribution of 5% of compensation. These employees must have completed one year of employment to be eligible for the Sponsor's non-elective contribution.

Participants are immediately vested in their contributions. Effective January 1, 2018, vesting in the Sponsors' matching and non-elective contributions is based on years of service. Participants are 20% vested after one year of service, increasing in 20% increments for each subsequent year, and are 100% vested after completion of five years of service.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Sponsors' contributions (based on the employee's contributions) and the Plan's earnings or losses (based on the participant's account balance relative to the total account balances). Forfeited balances of terminated participants' non-vested accounts are used to reduce future Sponsors' contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Benefit Payments***

Upon termination of service, the distribution of the participant's account shall be made in a lump sum, a rollover or installment payments.

**NOTES TO FINANCIAL STATEMENTS - CONTINUED**

**December 31, 2024 and 2023**

If employment is terminated for reasons other than death and the participant's vested balance exceeds \$1,000, the participant may choose to leave the account balance in the Plan or may elect to receive a distribution of the vested account balance. Effective January 1, 2024, the minimum vested balance subject to automatic lump sum cashout is increased to \$7,000. Upon termination of employment if the participant's vested account balance is over \$1,000 but less than \$7,000 the Plan Administrator will direct the Trustee to distribute participant's vested account balance to an Individual Retirement Account or Annuity (IRA).

In-service withdrawals from all or a portion of the participant's vested account balance are also permitted for reason of financial hardship or attainment of age 59½. A participant may also withdraw all or any portion of his or her vested employer 100% match pre-1999 and pre-2016 employer match accounts.

***Forfeitures***

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$500,184 and \$383,019, respectively. Forfeitures were used to reduce Sponsors' contributions by \$366,343 and \$263,830 in 2024 and 2023, respectively.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

***Investment Options***

Participants may invest their account balance in any of the Plan's investments options. Investment elections may be changed daily. All amounts in participant accounts are participant-directed.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Valuation of Investments***

Investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note C for further discussion of fair value measurements.

#### ***Notes Receivable from Participants***

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default based on the provisions of the Plan, the participant's loan balance is reduced, and a benefit payment is recorded.

#### ***Investment Income***

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Administrative Expenses***

Reasonable expenses relating to the administration of the Plan are paid using plan assets. Such expenses include, but are not limited to, management, participant loan, distribution and consulting fees. Unless otherwise paid by the Plan, certain expenses of maintaining the Plan are paid directly by the Sponsors and are excluded from these financial statements.

#### **NOTE C - INVESTMENTS**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**December 31, 2024 and 2023**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation techniques and inputs used by the Plan for each major class of assets measured at fair value are summarized as follows. There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

*Mutual funds* - Valued at quoted market price, which represents the net asset value (NAV) of shares held by the Plan at year end.

*Collective trust fund* - Valued using the NAV provided by the administrator of the fund. NAV is used as a practical expedient for fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

#### NOTE D - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FMTC, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE E - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE F - PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by Fidelity Investments, a company related to FMTC. Since FMTC is the Plan's trustee, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as permitted party-in-interest transactions under ERISA.

#### NOTE G - INCOME TAX STATUS

The Plan adopted the pre-approved plan document sponsored by FMR LLC, which received an advisory letter from the IRS on June 30, 2020. This letter stated that the pre-approved plan document is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Sponsors have determined that the Plan is eligible and have chosen to rely on the current IRS advisory letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsors have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their accounts.

**NOTE I - SUBSEQUENT EVENTS**

Plan management evaluated the Plan's December 31, 2024, financial statements for subsequent events through October 1, 2025, the date the financial statements were available to be issued. On June 3, 2025, the Plan Administrator determined that a partial termination of the Plan had occurred. In accordance with IRS guidance, all participants whose employment was terminated during the Plan year beginning January 1, 2025, and ending December 31, 2025, are considered affected and therefore fully vested. Other than the partial plan termination, Plan management is not aware of any subsequent events, which would require recognition or disclosure in the financial statements.

SUPPLEMENTAL INFORMATION
