NOTE 1: DESCRIPTION OF PLAN

The following description of ARC 401k Employee Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established January 1, 2006 and most recently restated effective April 12, 2022, covering all eligible employees of The August Jackson Company and Hosts Destination Services, LLC (collectively the Employer), which are wholly owned by ARC Holdings Unlimited, Inc. Prior to January 1, 2014, eligible employees were those who had completed three months of service and were at least twenty-one years of age. Effective January 1, 2014, the required period of eligibility service was extended to one year (as defined). Effective January 1, 2020, the required period of eligibility service was reduced to six months (as defined). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute a portion of their annual eligible compensation (as defined) to the Plan. This elective contribution is limited to the lesser of 50% of compensation or the maximum allowed by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans. The Employer will make a safe harbor contribution each year equal to 100% of each participant's elective deferral not exceeding 3% of the participant's compensation, plus 50% of each participant's elective deferral in excess of 3% but not to exceed 5% of participant's compensation. The Employer contributed \$601,478 in safe harbor matching contributions in 2024.

The Employer may also make a discretionary employer match contribution and a discretionary nonelective employer contribution to the Plan on behalf of qualifying participants. There was no discretionary employer match or nonelective employer contribution made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Employer's contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in all contributions, except the Employer discretionary nonelective contribution, plus actual earnings thereon. Vesting in the Employer's discretionary nonelective contribution is based on years of service. A participant is 100% vested after six years of credited service. During the year ended December 31, 2020, the Employer reduced the workforce which represented a partial plan termination as defined in the Internal Revenue Code. As a result of the partial plan termination, all accumulated benefits of affected employees became fully vested.

Investment Options

The Plan invests participant directed contributions in a number of mutual funds, common/collective trusts, and a guaranteed investment contract. Each participant's elective contribution will be invested into those funds selected by the participant. The Employer's contribution will be invested into the same funds as the elective contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Principal and interest is paid ratably through payroll deductions.

Forfeitures

Non-vested amounts will be forfeited by participants upon termination, and may be used to pay administrative expenses of the Plan or to reduce the Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$32 and \$104, respectively. For the year ended December 31, 2024, \$73 was used to pay administrative expenses.

Payment of Benefits

Upon termination of employment or termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in installments over time. In-service distributions are also permitted upon meeting certain requirements as defined by the Plan. Vested balances less than \$7,000 are paid out in a lump sum amount.

Expenses

Certain Plan expenses are assumed by the Employer and are not reflected in the accompanying financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to third party administrative services, investment advisory services, recordkeeping services, and specific participant transactions are charged directly to the participant's account and are included in administrative expenses.

The Plan has a revenue sharing agreement with Fidelity Management Trust Company to which a Revenue Credit Program (RCP) account has been set up to deposit a portion of fees on a quarterly basis to pay Plan expenses. Asset based payments will be calculated based upon an average daily balance for the quarter. The Employer is obligated to determine if and how any remaining RCP assets at Plan year-end should be allocated after expenses are paid. During 2024, there were no significant excess amounts.

Tax Status

The Plan has been recognized by the Internal Revenue Service (IRS) as a qualified non-standardized pre-approved profit sharing plan under the Internal Revenue Code (IRC) Section 401(a) and 401(k) and is exempt from federal income taxes under the provisions of IRC Section 501(a). A determination letter has been obtained, dated June 30, 2020, for the qualified non-standardized pre-approved profit sharing plan; however, no application has been made for a determination letter for this specific plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Subsequent events

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants (loans) are reported at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from Plan participants and the Employer are recorded in the year in which the employee contributions are withheld from compensation or in which participant compensation is earned.

The fair value measurement accounting literature provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy are described as follows:

- Level 1 Fair value is based on observable inputs such as quoted prices for identical assets or liabilities in active markets.
- Level 2 Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Fair value is based on unobservable inputs that reflect management's own assumptions.

In accordance with Accounting Standards Update No. 2015-07 certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefit.

Following is a description of the valuation methodologies that are used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

The fair value of mutual funds is based on quoted net asset values of shares held by the Plan at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common/Collective Trust

The fair value of the collective trust funds as of December 31, 2024 are based upon the net asset value of units held by the Plan at year-end as determined by the investment manager of the fund. The common collective trust funds and their investment strategies are as follows:

Lord Abbett Core Bond CIT - The fund objective is to deliver current income and the opportunity for capital appreciation by investing primarily in U.S. investment grade corporate, government and mortgage- and asset-backed securities. The fund was redeemable on a daily basis without restriction, and there are no unfunded commitments related to the fund.

Invesco International Small-Mid Cap - The fund seeks capital appreciation by investing primarily in equity securities of small and mid-cap companies that are domiciled, or have their primary operations, outside of the United States.

Mid Cap Value Fund - The fund seeks long-term capital gains and income by investing initially entirely in the American Century Mid Cap Value CIT.

Stable Value Fund Fee Class - The fund seeks to preserve principal and achieve high current income through a diversified portfolio of investment contracts.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE 5: INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2018, the Plan entered into a benefit-responsive investment contract with Lincoln National Life Insurance Company. Lincoln National Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln National Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. However, the minimum guaranteed rate is 1.00%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not have a defined maturity date. Rather, the contract value continues in force until terminated by either the Plan or by Lincoln National Life Insurance Company.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 8: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by the trustee. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. Fees are also paid indirectly through revenue sharing. The Plan made direct payments of \$24,370 to Fidelity Investment Institutional for recordkeeper services and \$14,000 to Kestra Investment Services, LLC for investment advisory services. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
