## INDEPENDENT AUDITORS' REPORT

To the Retirement Committee and Participants  
Standard Process Inc. 401(k) and Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Standard Process Inc. 401(k) and Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. ## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The Standard Process Inc. 401(k) and Profit Sharing Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through August 30, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - Standard Process Inc. is the plan sponsor, employer and the plan administrator. T. Rowe Price Retirement Plan Services, Inc. is the third party administrator and performs various compliance tests as tax counsel. T. Rowe Price Trust Company is the trustee that holds custody of the plan's investments and maintains investment records. The two T. Rowe Price entities are collectively referred to as "T. Rowe". Francis Investment Counsel, LLC is the plan's investment advisor.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in the fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market prices as reported by the funds. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

**Common/collective trusts** - Valued at the NAV based on units of the common/collective trusts. The common/collective trusts held by the plan are all individual direct filing entities. The NAVs are used as practical expedients to estimate fair value. The NAVs are generally based on the fair values of the underlying investments held by the common/collective trusts less their liabilities. These practical expedients would not be used if it were determined to be probable that the common/collective trusts would sell the investments for amounts different than the reported NAVs.

## 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

**General** - The plan was adopted effective October 17, 1952 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees are eligible to make elective contributions and receive employer contributions immediately upon hire.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contribution contributions. Newly eligible employees are automatically enrolled in the plan and have 5% of compensation withheld as deferral contributions. These participant deferral percentages automatically increase by 1% each year until they reach a maximum of 15%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer safe harbor matching contributions are made equal to 100% of the first 5% of compensation that a participant contributes to the plan. These contributions are funded coinciding with each payroll with an annual true-up contribution. The employer safe harbor matching contributions, prior to forfeitures being utilized, were \$2,768,000 and \$2,664,000 for 2024 and 2023.
- d. Employer nonelective contributions may be made at the employer's discretion on an annual basis. In order to share in the employer nonelective allocation, the participant must be employed on the last day of the plan year in which the contribution relates. This requirement is waived upon death or disability during the year to which the contribution relates. The employer nonelective contributions were \$3,792,000 and \$5,045,000 for 2024 and 2023.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral contributions, employer safe harbor matching contributions, rollover contributions, and related earnings. Participants vest in nonelective contributions and related earnings upon completing two full years of service at which time they are 20% vested. The participants then vest at the rate of 20% for the next two years. Upon reaching five years of service, a participant will be 100% vested. Upon death, disability or attainment of early retirement (defined as 55 with five completed years of service) or normal retirement age while employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions may be made in the form of a single lump sum, installment payments or partial withdrawals. In-service withdrawals can commence upon attaining the age of 59½. In addition, hardship withdrawals are permitted under certain circumstances.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the plan sponsor and are not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed charges are allocated to the participants on an account value basis.

**Forfeitures** - Forfeited nonvested accounts are used to reduce the amount of the employer contributions. Forfeitures used were \$72,000 and \$153,000 in 2024 and 2023. Unapplied forfeitures were \$289,000 as of December 31, 2024. Forfeitures were insignificant as of December 31, 2023.

**Notes receivable from participants** - Loans to participants are not permitted under the plan.

### 3. PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan, plan sponsor and T. Rowe qualify as party-in-interest transactions. T. Rowe receives revenue from mutual fund service providers for services T. Rowe provides to the funds. Certain revenues received by T. Rowe from such service providers are remitted to the plan in the form of service credits (as part of an administrative services agreement between the plan sponsor and T. Rowe). Such service credits received by the plan are used to pay service and administrative fees and other plan fees. There are also certain other plan expenses that T. Rowe charges that are paid directly by the plan. Direct fees paid by the plan to T. Rowe, recorded as a component of administrative expenses in the accompanying financial statements were \$64,000 and \$68,000 in 2024 and 2023.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

### 5. INCOME TAX STATUS

The plan adopted the T. Rowe Price Retirement Plan Services Inc. pre-approved profit sharing plan that received a favorable opinion letter on August 19, 2020. The letter from the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan, however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

### 6. INFORMATION CERTIFIED BY T. ROWE

Management has obtained certifications from T. Rowe, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such as of December 31, 2024 and 2023;
- b. Dividends from investments and net appreciation (depreciation) in fair values of investments during 2024 and 2023;
- c. Purchases and sales of investments during 2024 and 2023; and
- d. Contributions to, investment income (loss) credited to, benefits paid from and transfers between investment accounts during 2024 and 2023.
