Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Scripps Health Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the Scripps Health Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

Effective July 1, 1983, the Plan was established as a defined contribution money purchase pension plan to cover all eligible employees of Scripps Health (the “Organization” or “Plan Sponsor”). Employees are eligible to join the Plan following the completion of six months of service, provided they have attained age 21 and are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Plan is administered by the Scripps Health Retirement Committee (the “Committee”). The Committee has been given all powers necessary to carry out its respective duties by the Board of Trustees, including, as applicable, but not limited to, the power to administer and interpret the Plan and to answer all questions affecting eligibility of participants in the Plan and to authorize disbursements for the payment of benefits. The Trustee, Fidelity Management Trust Company, holds all of the assets of the Plan.

Contributions

The Plan provides participants with the opportunity to make nondeductible, after-tax contributions pursuant to Section 401(a) of the Internal Revenue Code (the “Code”). Each year, a participant may make contributions to the Plan, in increments from 1% up to 60% of eligible compensation for the plan year, as defined in the Plan. Participants may make rollover contributions, representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a money market fund, mutual funds, and common collective trusts as investment options for participants. Participants may select the BrokerageLink option, whereby they direct their contributions and/or transfer amounts from other investment options offered by the Plan into a separate brokerage account maintained by Fidelity. Contributions for participants who make no investment election are included in the Plan’s default investment, Vanguard Target Retirement target date funds.

Scripps Health Retirement Savings Plan

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Following the end of each plan year, the Organization makes a matching contribution to the account of each participant still employed on the last day of the year in an amount equal to 100% of the eligible contributions made by a participant during the contribution period up to 3% of the participant's compensation for the plan year. If the participant has completed more than ten years of service and contributes 3% or more to the Plan, the Organization's matching contribution increases to a range from 4% to 6% based upon the employee's accumulated years of service. The Organization matches employee contributions regardless of the Organization's profits or losses. Under the Plan, employer matching contributions may be invested in any of the investment options available under the Plan, as directed by the participants. Contributions are subject to certain limitations of the Code.

The Organization makes an annual contribution following the end of each plan year to the account of each eligible participant in an amount equal to 1% of the employee's eligible compensation. The Organization contributed \$14,753,837 in annual contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's matching contributions, the Organization's annual contribution, and allocations of Plan earnings, and charged with an allocation of administrative expenses and Plan losses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested at all times in employee contributions, and any earnings thereon, immediately upon entry into the Plan. Vesting in the Organization's contribution portion of their accounts is based on years of service. Participants vest in the Organization's contributions and earnings thereon at 25% after one year of service and 50% after two years of service. A participant is 100% vested upon normal retirement age, after three years of service, or immediately upon death, disability, or termination of the Plan.

Scripps Health Retirement Savings Plan

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Payment of Benefits

On termination of service, a participant, or participant's beneficiary in the event of death, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in installments. While in service, a participant may elect to withdraw up to 100% of the participant's after-tax account. When a participant attains age 62, the participant may elect to withdraw up to 100% of the participant's vested account balance.

If the value of a participant's account is greater than \$7,000, the participant may elect to receive benefit payments in a single lump sum, in monthly installments over a specified period, or in the form of an annuity. If the account is valued between \$1,000 and \$7,000, the balance may be automatically rolled to an Individual Retirement Account held at Fidelity Investments Institutional Operations Company, LLC (FIIOC), if participant direction is not received. Accounts less than \$1,000 are automatically paid directly to the terminated participant if participant direction is not received. Required minimum distributions commence for all participants no later than April 1 of the calendar year following the year in which the participant attains the age of 73 and has terminated employment.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$684,000 and \$534,000, respectively. The Committee may allocate those accounts to pay plan expenses or to reduce employer contributions for the plan year in which the forfeiture occurs. Nonvested contributions forfeited (net of reinstated forfeited balances), and actual earnings thereon during 2024, totaled approximately \$673,000 and \$19,000, respectively, and during 2023, totaled approximately \$536,000 and \$14,000, respectively. The Organization used forfeitures to reduce 2024 employer contributions by approximately \$542,000.

Plan Expenses

Administrative expenses, investment management fees, asset-based fees, and trustee fees, if any, are paid by the Plan and may be reimbursed to the Plan by the Organization at the discretion of the Organization. Investment management and trustee fees are netted against investment income, including approximately \$2,616,000 of fees paid to the Trustee and its affiliates for the year ended December 31, 2024.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

FIIOC provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Organization and FIIOC. FIIOC receives revenue from mutual fund and collective trust fund service providers for services FIIOC provides to the funds. This revenue is used to offset certain amounts owed to FIIOC for its administrative services provided to the Plan.

If the revenue received by FIIOC from such mutual fund or collective trust fund service providers exceeds the amount owed under the MSA, FIIOC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. During 2024 and 2023, excess amounts were applied to pay plan administrative expenses with the remainder allocated to participant accounts, and are shown as other additions on the statement of changes in net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides for various investment options in a money market fund, mutual funds, common collective trusts, and self-directed brokerage accounts. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur, and such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Investments in a money market fund, mutual funds, and self-directed brokerage accounts are valued based upon quoted market prices on the last business day of the year. Common collective trusts are valued at their net asset value practical expedient provided by the issuer. Participant-directed redemptions of common collective trusts have no restrictions; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the Fidelity Managed Income Portfolio II investment.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year.

Benefit Payments

Benefit payments to participants are recorded when paid.

3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The following tables present information about the Plan's assets that are measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the fair value hierarchy of the valuation techniques the Plan utilized to determine such fair value. In general, fair values determined by Level 1 inputs utilize quoted prices (unadjusted) in active markets for identical assets or liabilities. Fair values determined by Level 2 inputs utilize data points that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Fair values determined by Level 3 inputs utilize inputs that are unobservable and significant to the fair value measurement. The Plan holds no Level 3 assets. The common collective trusts are excluded from the fair value hierarchy levels because they are valued using the net asset value practical expedient.

Assets and liabilities measured at fair value are valued based on the market approach. The market approach takes prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities.

4. Investments

5. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS), dated June 10, 2015, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

Certain investments of the Plan are shares of a money market fund and mutual funds managed by affiliates of the Trustee, and units of a common collective trust managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions for which a statutory exemption exists.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Organization contributions and participants would receive a distribution of their account balance as soon as practicable.

8. Subsequent Events

Management evaluated subsequent events for the Plan through September 30, 2025, the date the financial statements were issued.
