Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Scripps Health 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the Scripps Health 403(b) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

Effective September 1, 2010, the Plan was established as a defined contribution plan. Employees of Scripps Health (the “Organization” or “Plan Sponsor”) are immediately eligible to join the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Plan is administered by the Scripps Health Retirement Committee (the “Committee”). The Committee has been given all powers necessary to carry out its respective duties by the Board of Trustees, including as applicable, but not limited to, the power to administer and interpret the Plan and to answer all questions affecting eligibility of participants in the Plan and to authorize disbursements for the payment of benefits. The Trustee, Fidelity Management Trust Company, holds all of the assets of the Plan.

Contributions

Each year, participants may make contributions to the Plan on a pretax or Roth (after-tax) basis, as defined in the Plan. Pretax and Roth contributions are subject to a limitation under Section 402(g)(1) of the Internal Revenue Code (the “Code”). Age 50 catch-up contributions under Section 414(v) are permitted in this Plan. In addition, the special catch-up election under Section 402(g)(7) is also allowable. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may select the BrokerageLink option, whereby they direct their contributions and/or transfer amounts from other investment options offered by the Plan into a separate brokerage account maintained by Fidelity. Contributions for participants who make no investment election are invested in the Plan’s default investment, Vanguard Target Retirement target date funds. Contributions are subject to certain limitations of the Code.

Scripps Health 403(b) Plan

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participants may elect to make an in-plan transfer of all or part of the participant's vested account to a Roth account as provided under the American Taxpayer Relief Act.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Plan earnings, and charged with an allocation of administrative expenses and Plan losses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested at all times in employee contributions, and any earnings thereon, immediately upon entry into the Plan.

Participant Loans

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with market rates. At December 31, 2024, interest rates ranged from 4.25% – 9.50% on the participants' loan balances, which mature through November 2039. Principal and interest are paid ratably through biweekly payroll deductions.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant or his or her beneficiaries may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period not to exceed the assumed life expectancy of the participant or his or her beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Subject to Internal Revenue Service (IRS) safe harbor rules, participants may take hardship distributions. In addition, participants may also take in-service distributions upon attainment of age 59.5 years.

1. Description of Plan (continued)

Plan Expenses

Administrative expenses, investment management fees, asset-based fees, and trustee fees, if any, are paid by the Plan and may be reimbursed to the Plan by the Organization at the discretion of the Organization. Investment management and trustee fees are netted against investment income, including approximately \$1,617,000 of fees paid to the Trustee and its affiliates for the year ended December 31, 2024.

Fidelity Investments Institutional Operations Company, LLC (FIIOC) provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Organization and FIIOC. FIIOC receives revenue from mutual fund service providers for services FIIOC provides to the funds. This revenue is used to offset certain amounts owed to FIIOC for its administrative services provided to the Plan.

If the revenue received by FIIOC from such mutual fund service providers exceeds the amount owed under the MSA, FIIOC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. During 2024 and 2023, excess amounts were applied to pay plan administrative expenses with the remainder allocated to participant accounts, and are shown as other additions on the statement of changes in net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Risks and Uncertainties

The Plan provides for various investment options in a money market fund, mutual funds, and self-directed brokerage accounts. Investment securities, in general, are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Investments in a money market fund, mutual funds, and self-directed brokerage accounts are valued based upon quoted market prices on the last business day of the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments to participants are recorded when paid.

3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The following tables present information about the Plan's assets that are measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the fair value hierarchy of the valuation techniques the Plan utilized to determine such fair value. In general, fair values determined by Level 1 inputs utilize quoted prices (unadjusted) in active markets for identical assets or liabilities. Fair values determined by Level 2 inputs utilize data points that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Fair values determined by Level 3 inputs utilize inputs that are unobservable and significant to the fair value measurement. The Plan holds no Level 2 or Level 3 assets.

Assets and liabilities measured at fair value are valued based on the market approach. The market approach takes prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities.

4. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

5. Tax Status

The underlying volume submitter specimen plan has received an opinion letter from the IRS, dated August 7, 2017, stating that the written form of the underlying pre-approved document is qualified under Section 403(b) of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 403(b) of the Code and, therefore, the related accounts are tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related accounts are tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

Certain investments of the Plan are shares of a money market fund and mutual funds managed by affiliates of the Trustee and, therefore, these transactions qualify as party-in-interest transactions for which a statutory exemption exists.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event the Plan is terminated, participants would receive a distribution of their balance as soon as practicable.

8. Subsequent Events

Management evaluated subsequent events for the Plan through September 30, 2025, the date the financial statements were issued.
