NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Supportive Living Services, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a comprehensive description of the Plan's provisions.

General - The Plan is a defined contribution plan covering employees of Supportive Living Services, Inc. ("the Company") who have completed six months of service, provided they have worked at least 1,000 hours of service during that twelve-month period and are 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year participants may contribute up to the maximum percentage or dollar amount allowed by law. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The employer will match the elected deferrals up to 5% of compensation.

Participant accounts - Each participant's account is credited with both the participant's contribution and the employer's contribution, as well as allocations of (a) Plan unrealized investment gains or losses, and (b) Realized interest and dividend earnings reinvested. Each contribution is allocated at the time it is received by the custodian. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - All participant contributions to the Plan are vested 100% immediately. Employer matching contributions are vested using a three-year graded vesting schedule based on participant's years of service. A three-year graded vesting schedule stipulates 33.3% vesting of employer contributions per year for participants' first three years of service.

Notes receivable from participants - Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates that are 1% above the current prime rate at the time the loan is made. A participant in the Plan may only have one outstanding loan at any time. Principal and interest is paid ratably through payroll deductions. Interest on notes receivable from participants is recognized when received.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits - On termination of service due to death, disability or retirement, a participant must receive a lump-sum amount distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows participants to request an in-service distribution if they have not separated from service and have attained the age of 59 ½ and are fully vested.

Forfeited Accounts – Forfeitures of \$2,814 and \$8,180 occurred for the years ended December 31, 2024 and 2023, respectively. The Plan document specifies that funds from forfeited accounts are to be used to reduce future administrative costs of maintaining the Plan or to reduce employer matching contributions made by the sponsor.

Funding Policy – Participant contributions are made through payroll withholdings and are remitted to the Plan on a bi-weekly basis. Employer matching contributions are remitted to the Plan at the same time as participant contributions.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

The Plan's investments are reported at fair market value. Fair market value is the amount that would be received for an asset if it were sold in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net investment gain (loss) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

C. Notes Receivable from Participants

Notes receivable from participants are reported at the outstanding principal balance plus any accrued unpaid interest.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

D. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

E. Payment of Benefits and Administrative Expenses

Benefits are recorded when they are paid. As provided in the Plan agreement, administrative expenses may be paid by the Plan or the sponsor. The sponsor has historically paid the operating expenses of the Plan.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's investments are participant-directed and are made through American Funds' Mutual Funds investment options. Plan assets are held by Capital Bank and Trust Company, parent company of American Funds. Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – TAX STATUS

The Plan's original effective date was January 1, 1998. The most recent determination letter was obtained January 27, 2015. The Internal Revenue Service states that the Plan prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (section 401). This prototype is utilized by the 401(k) Profit Sharing Plan. Although the Plan has been amended since the date of the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provision under ERISA. In the event of Plan termination, the participants' accounts would become fully vested.

NOTE 8 – CONCENTRATION RISK AND UNCERTAINTY

The Plan maintains all of its investments at the Capital Bank and Trust Company, parent company of American Funds. The balances are not insured and all mutual fund investment securities are inherently subject to risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. The maximum amount of loss that could occur due to the aforementioned risks is the total fair value of investments, since no collateral exists for the value of the investment securities.

NOTE 9 – TRANSACTIONS WITH PARTIES-IN-INTEREST

Fees paid during the year for administrative services rendered by parties-in-interest were based on customary and reasonable rates for such services and are paid by the Plan sponsor.

Two trustees of the Plan were also plan participants during 2024. No prohibited transactions occurred between the Plan and these parties-in-interest.

NOTE 10 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 30, 2025, the date which the financial statements were available to be issued.
