Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Potato King, Inc. 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 Description of Plan

The following description of the Potato King, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Potato King, Inc (the "Company") who have at least one year of eligible service and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes.

Many of the provisions of the SECURE 2.0 are effective on January 1, 2023, and beyond and will require significant changes to plan administration and recordkeeping.

Eligibility

Employees shall become a participant of the Plan on the first day of January or July of the Plan year during which the employee meets the eligibility requirements. Participation occurs upon completion of one year of service, credited with 1,000 hours of service, and reaching at least 21 years old. To receive the Company's discretionary contribution, active employment is required on the last day of the Plan year.

Contributions

Each year participants may contribute pretax or Roth annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans. The Company contributes a discretionary matching contribution that is allocated based on a participant's contributions and a minimum 3% safe harbor contribution. Additional amounts may be contributed at the discretion of the Company's Board of Directors. The Company may not make a contribution to the Plan for any Plan year to the extent the contribution would exceed the participant's maximum permissible amount. For the Plan years ended December 31, 2024 and 2023, the Company matched the first 3% of compensation contributed by a participant.

Participant Account

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All investments of the Plan are participant-directed. Participants have the option of directing their account balance to one or more different investment options.

Note 1 Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear interest at a rate of 4.25%-9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. Notes receivable from participants had a balance of \$121,263 and \$166,405 at December 31, 2024 and 2023, respectively.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000, it can be distributed only in a single lump sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Effective January 1, 2020, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans. Written amendments to the Plan to reflect these operational changes have been adopted in accordance with applicable law and IRS guidance.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures may be reallocated to participants in the same manner as Company contributions or may be used to pay administrative expenses in accordance with the Plan document. At December 31, 2024 and 2023, unallocated forfeitures from nonvested accounts totaled \$0 and \$21,794, respectively.

Note 2 Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses charged by the Trustee of the Plan and investment advisory fees are paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through September 18, 2025, which is the date the financial statements were available to be issued.

Note 3 Fair Value Measurements

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that provides the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs, other than quoted prices, that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Certain investments are measured at net asset value (NAV) per share (or its equivalent) as a practical expedient. In accordance with ASU 2015-07, such investments are not categorized in the fair value hierarchy table but are disclosed separately.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on the number of shares held at year end at the fund closing price quoted in an active market.

Collective investment trusts (CITs): Bank-maintained commingled funds valued daily at NAV per unit, which is the basis for participant transactions. Reported under the NAV practical expedient.

Guaranteed investment contract (KeyBank EB Managed GIC): Valued at fair value by discounting estimated future cash flows using current market yields of similar instruments. Classified as Level 2. Contract value is also disclosed because it represents the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Stable value fund (KeyBank EB MaGIC 50): A pooled separate account invested in traditional and synthetic investment contracts, valued at NAV per unit. Reported under the NAV practical expedient.

Collective Investment Trusts (CITs): CITs are valued daily at NAV per unit, which represents the basis for participant transactions. There are no unfunded commitments. Units are generally redeemable daily at NAV.

Stable Value Fund (2023 only): The EB MaGIC 50 Stable Value Fund invests in traditional and synthetic guaranteed investment contracts. Units are issued and redeemed daily at NAV. While participant transactions occur at NAV, employer-initiated events such as plan termination, mergers, or significant layoffs may restrict the ability to transact at NAV. The fund had no unfunded commitments at year-end.

Note 4 Fully Benefit-Responsive Investment Contract

The Plan holds a traditional investment contract with KeyBank, N.A. (the “Contract Issuer”). The contract is included in the Plan at its fair value; however, since the contract is fully benefit-responsive, contract value is also disclosed.

Nature of Investment:

The KeyBank EB Managed Guaranteed Investment Contract is a traditional guaranteed investment contract issued by KeyBank. The contract is backed by the general account of the issuer, which guarantees repayment of principal and interest at the credited rate. Participants may ordinarily direct transfers to and from the contract at contract value.

Crediting Rate:

As of December 31, 2024, the contract had a crediting rate of 2.36%, which is reset quarterly. Crediting rates are established based on the issuer’s current portfolio yields, fees, and expected cash flow patterns.

Contract Value vs. Fair Value:

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals. Fair value is based on the present value of future cash flows using current discount rates for similar instruments.

Liquidity and Withdrawal Provisions

Participants may withdraw or transfer funds at contract value for plan benefits. However, certain employer-initiated events (e.g., plan termination, significant layoffs, or mergers) may restrict transactions at contract value, in which case settlement may occur at fair value.

Fair Value Hierarchy Classification

The KeyBank EB Managed Guaranteed Investment Contract is classified within Level 2 of the fair value hierarchy.

Note 5 Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Life Insurance Company, the current Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statement of Net Assets Available for Benefits and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from November 1, 2024 through December 31, 2024. Capital Bank and Trust Company, the previous Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statement of Net Assets Available for Benefits as of December 31, 2023, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through October 31, 2024. Together, these certifications cover the full year ended December 31, 2024.

Note 6 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 7 Tax Status

The Company adopted a nonstandard prototype document with an IRS opinion letter dated June 30, 2020, which states the prototype Plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan remains open to examination through the applicable statutory periods.

Note 8 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 Parties-in-Interest Transactions

Certain Plan investments are managed by the Trustees, and therefore, these transactions qualify as party in interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participants account balances. These transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 10 Reconciliation of Financial Statements to Form 5500

For the years ended December 31, 2024 and 2023, there were no differences between the audited financial statements and the Form 5500.
