## Report of Independent Auditors

To the Administrator of

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of CC Industries and Affiliates Retirement Savings Plan for Salaried Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### ***Opinion***

### ***Basis for Opinion***

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The following description provides general information on the provisions of the CC Industries and Affiliates Retirement Savings Plan for Salaried Employees (the “Plan”), a multiple-employer plan, sponsored by Henry Crown and Company S LLC, d/b/a CC Industries (the “Company”). Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### **General**

The Plan, a defined contribution (401k) plan, was established effective October 1, 1965. The Plan currently covers all salaried employees of the Company, Longview Asset Management, LLC and all employees of Golden Oaks Farm (each as “Employer”) who have completed 30 days of service with no minimum age requirement.

The Plan also covers former employees of the following discontinued or sold operations, some of whom continue to maintain account balances in the Plan:

- Woodard, LLC
- Petroleum and marine operations
- CHF Industries, Inc. including its Aberdeen, Cameo and Joanna Divisions
- American Envelope Company and its various divisions
- Independent Cellular Network Group

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

### **Contributions**

The Plan provides for participating employees to elect to make, through payroll deductions, a pre-tax salary deferral contribution of between 1% and a maximum of 50% of eligible compensation (not to exceed the annual contribution limit, as set by the Internal Revenue Service, (“IRS”)). Each Employer has a discretionary pre-tax matching contribution. Currently, the discretionary match is 50% of the first 6% of the employee’s eligible compensation, as defined. The matching contribution for employees of Golden Oaks Farm is equal to 50% of the first 5% of the salary deferral contribution of active participants.

Golden Oaks Farm makes a supplemental contribution of 3% of each eligible employee’s compensation each year.

Effective January 1, 2024, participating employees may elect to designate all or any portion of their elective deferral contributions as after-tax. Until January 1, 1989, the Plan also provided for participating employees to elect to make after-tax savings contributions. Some employees retain after-tax account balances.

##### **Vesting**

A participant is always 100% vested in salary deferral contributions, Employer matching contributions and rollover contributions. Eligible employees of Golden Oaks Farm become 20% vested in the supplemental contribution of 3% after completion of two years of service (as defined) and continue to vest annually until 100% vesting is attained after six years of service. The supplemental discretionary contributions for certain non-highly compensated Golden Oaks Farm employees who attained age 51 by January 1, 2003, are always 100% vested.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (1) the Employers' contributions, (2) investment earnings and losses after allocation of investment management fees and (3) forfeitures of terminated participants' nonvested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### **Forfeitures**

Forfeited nonvested accounts are reallocated to current participants in the same manner as the Employers' contributions. Forfeiture balances as of December 31, 2024 and 2023 amounted to \$1,603 and \$3,728, respectively. Forfeitures in the amount of \$3,935 were reallocated to participants during 2024.

##### **Investment Options**

The Company administers the Plan. Principal Trust Company ("Principal") is the trustee of the Plan. Principal Financial Group is the recordkeeper of the Plan.

Participants self direct the investment of their accounts into registered investment company funds and common/collective trusts offered by the Plan with the option to reallocate account balances.

##### **Notes Receivable from Participants**

Participants (except for Golden Oaks Farm) may borrow from their vested account balance a minimum of \$1,000, up to a maximum equal to the lesser of 50% of their total vested account balance or \$50,000. Interest on these notes is charged at prime plus 1%, at date of the note, and the balance generally must be repaid over five years, or fifteen years if the note is used for the purchase of a primary residence. Interest rates on outstanding notes ranged from 4.25% to 9.50% at December 31, 2024 and 2023.

##### **Payment of Benefits**

On termination of service, retirement or total and permanent disability, a participant may elect to receive payment in the form of either a lump-sum distribution, annual installments or a direct rollover to an Individual Retirement Account ("IRA") or another IRS qualified plan equal to the value of the participant's vested account. Participants with vested account balances of \$7,000 or more, excluding rollover balances, can take a distribution or defer the distribution. Participants with a vested account balance, excluding rollover balances, greater than \$1,000 but less than \$7,000 must make a distribution election within 60 days otherwise the balance is automatically rolled to an IRA. Balances of \$1,000 or less but greater than \$100 require a distribution election within 60 days

otherwise, a check is issued for the balance. Balances less than \$100 are issued a check. Under Federal law, benefit payments must begin on the April 1<sup>st</sup> following the calendar year in which the participant reaches age 73.

Benefit payments received before age 59 ½ may be subject to a 10% tax penalty unless the amount is rolled over. In the event of death, the participant's beneficiary will receive a lump-sum distribution. Participants who are age 59 ½ are permitted to make an in-service withdrawal which can be rolled over to an IRA or another IRS qualified plan.

#### **Administrative Expenses**

Expenses of administration, such as legal, accounting, recordkeeping and trustee fees, are paid entirely by the Company. Investment management fees are paid from the accounts of participants. Initial note processing fees are deducted from the participant's account balance.

#### **Plan Termination**

Although they have not expressed any intent to do so, each Employer has the right under the Plan to discontinue their contributions at any time and the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be fully vested in their accounts and the trustee will distribute Plan assets to participants or their beneficiaries in accordance with the Plan agreement.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **Net Appreciation (Depreciation) in Fair Value of Investments**

Net realized and unrealized appreciation (depreciation), which includes gains and losses on investments bought and sold, as well as held during the year, is recorded in the accompanying Statement of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in fair value of investments.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions.

##### Payment of Benefits

Benefits are recorded when paid.

##### Subsequent Events

The Plan evaluated the impact of events that have occurred subsequent to December 31, 2024, through October 3, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in those financial statements. There were no events identified.

### 3. Investments

The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

### 4. Fair Value

The Plan follows guidance defined in Accounting Standards Codification (“ASC”), *Fair Value Measurement (Topic 820)*, which provides a framework for measuring fair value under GAAP. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Quoted market prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan’s investments are valued at fair value using the following methodology:

- **Registered investment companies:** valued at net asset value (“NAV”) per share, using available inputs to measure fair value by such companies or funds, for shares held by the Plan at year-end. Generally, mutual funds have a quoted market price in an active market.
- **Common/collective trusts:** valued at NAV of the units held by the plan. NAV is used as a practical expedient to estimate fair value. NAV is based upon the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidation will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in economic conditions may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan does not hold any investments measured as Level 2 or 3.

**5. Income Tax Status**

The IRS has determined and informed the Company in a letter dated February 12, 2014, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since the date of the letter, the Company and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. There are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.
