### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SBA Defined Contribution Plan for Skyline National Bank (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SBA Defined Contribution Plan for Skyline National Bank's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

## **Basis for Opinion**

### Note 1 – Plan Description

---

The following description of the SBA Defined Contribution Plan for Skyline National Bank (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Skyline National Bank (the “Company”) who have completed at least three months of service. The Plan excludes interns, leased or owner employees, or self-employed individuals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Each year, participants may contribute up to 96% of their compensation as a pre-tax or Roth deferral as defined by the Plan, not to exceed the maximum allowable under the *Internal Revenue Code (IRC)*. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan permits catch-up contributions to be made by participants who have attained age 50 before the end of the year. For 2024, the Company made a safe harbor matching contribution of 100% of the first 3% of compensation and 50% on the next 2% of compensation, up to a maximum matching contribution of 4%. Additional amounts may be contributed at the discretion of the Company. The Company made no additional discretionary contributions for 2024. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, allocations of earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon and are also immediately vested in the Company’s safe harbor matching and discretionary profit-sharing contributions plus earnings thereon.

#### *Notes from Participants*

Participants may borrow from their vested balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Note terms range from one to five years unless the note is for purchase of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant’s account and bear interest at a rate of 2 points over the Wall Street Journal Prime Rate, as defined. Interest rates ranged from 5.25% to 10.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

### *Payments of Benefits*

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum or partial distribution, as defined. Vested account balances less than \$5,000 will be automatically distributed in a lump-sum payment upon termination. Effective July 1, 2024, the automatic distribution threshold increased to \$7,000 in accordance with Secure Act 2.0. Hardship withdrawals and in-service distributions at age 59½ are also permitted, subject to plan provisions described in the Plan document.

### *Administration*

The Plan Sponsor administers the Plan through an agreement with SBA Benefits Corporation (formerly VBA Benefits Corporation). Voya Institutional Trust Company (Voya) acts as trustee and manages the Plan assets as well as retains custody.

### *Administrative Expenses*

Administrative expenses may be paid by the Plan or the Company. A portion of these expenses were paid by the Plan for the year ended December 31, 2024. Investment-related expenses are included in net appreciation in fair value of investments.

---

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Valuation of Investments and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

### *Benefit Payments*

Benefits are recorded when paid.

### *Subsequent Events*

Subsequent events have been evaluated through September 29, 2025, the date the financial statements were available to be issued.

---

### **Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

### *Level 1 Fair Value Measurements*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

### *Level 2 Fair Value Measurements*

The fair value of the common collective funds are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. While underlying asset values are quoted prices, the net asset value (NAV) of a unit in this fund is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are included in the computation of the NAV and are realized by the participant upon withdrawal. No distributions of income and gain or loss are made to participants.

## **Note 4 – Investment Contract**

---

At December 31, 2024 and 2023, the Plan has investments in the Goldman Sachs Stable Value Collective Trust (the "Fund"). Included in this fund are wrap agreements and insurance company separate account agreements. Under the Stable Value Contract, the issuer agrees, subject to contract conditions, to make payments representing redemptions from the Fund for participant-initiated benefit payments at book value.

Because the collective investment trust is benefit-responsive and a stable value investment, it is presented at fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The objective of the stable value collective trust is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive plan or participant payments. The percentage of contributions allocated to the stable value collective trust is determined by the participants.

---

### Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

SBA Benefits Corporation is the Plan’s Administrator. Certain Plan investments are managed by Voya Institutional Trust Company, the trustee and recordkeeper for the Plan, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$81,876 in administrative fees in 2024.

---

### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

---

### Note 7 – Tax Status

The non-standardized pre-approved profit-sharing plan document sponsored by State Bankers Association obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is designed in accordance with applicable sections of the *IRC*. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
