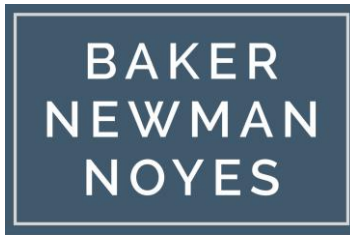

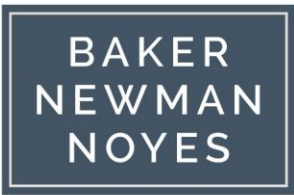

INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants
Catholic Charities New Hampshire 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Catholic Charities New Hampshire 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. Plan Description

The following description of the Catholic Charities New Hampshire 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and covers substantially all employees of New Hampshire Catholic Charities (CCNH) who have attained age 18 and completed one year of service, as defined. Employees not eligible to participate in the Plan include residents of Puerto Rico, leased employees and employees of St. Jacinta Healthcare Staffing.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE Act 2.0) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

The SECURE Act 2.0 expanded eligibility for certain long-term part-time (LTPT) employees. Effective January 1, 2024, part-time employees who have completed 500 - 999 hours of service in the three most recent consecutive years (2021 - 2023) are eligible to participate in the Plan. Effective January 1, 2025, the requirement is being reduced from three to the two most recent consecutive years (2023 - 2024).

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Eligible employees may contribute to the Plan through salary deferrals on a pre-tax and post-tax basis. Participating employees are allowed to contribute any amount up to the maximum dollar amount as prescribed by law. In addition, an automatic enrollment provision applies, whereby 1% of the eligible employee's compensation will be deferred into the Plan unless otherwise elected by the employee. The Plan also provides for automatic annual escalations of 1%, up to a maximum of 3%.

The Plan is a safe harbor plan. As a safe harbor plan, CCNH shall make a nonelective contribution of 3% of each eligible participant's compensation, as defined. CCNH may also make additional discretionary contributions. No discretionary contributions were made for 2024.

Rollover contributions are subject to conditions stated in the Plan and in the appropriate sections of the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the contributions of the participant and CCNH and an allocation of earnings or losses and administrative expenses of each fund based on the participant's relative account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description (Continued)

Vesting

Participants are immediately 100% vested in their contributions and CCNH's contributions, plus actual earnings or losses thereon.

Payment of Benefits

Benefits may be distributed to participants upon termination of employment by reason of separation, layoff, retirement, or death. Distributions may be made in lump sums or installments. No annuities are allowed under the Plan. The Plan also provides for withdrawal upon attainment of age 59 1/2 and in the event of hardship or disability, as defined.

Terminated participant accounts with balances less than \$5,000 may be automatically distributed to an IRA on the participant's behalf unless the participant elects otherwise. Effective January 1, 2024, the Plan provided for the optional provision with the SECURE Act 2.0 to increase the mandatory cash out threshold from \$5,000 to \$7,000.

Investment Options

All contributions to the Plan are invested in the various investment options offered by the Plan at the election of the participants. Each participant selects the fund(s) to which contributions will be allocated.

Notes Receivable From Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are repayable generally over five years unless the loan is for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate of interest as determined by the Plan. Interest rates range from 5.25% – 10.50% at December 31, 2024 with various maturities through March 2030.

Administrative Expenses

CCNH pays certain expenses incurred in the administration of the Plan. Certain fees incurred by the Plan for investment management and certain administrative services are paid through revenue sharing rather than direct payment.

Plan Termination

Although it has not expressed any intention to do so, CCNH has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, the trustee, once notified by CCNH of the termination date, will distribute to each participant his or her account balance on that date in accordance with the terms of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment options which are exposed to various risks, such as interest rate, market, liquidity and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Participant contributions are recorded in the period in which payroll deductions are made. CCNH safe harbor contributions are determined for each payroll period, and are recorded in the period in which related payroll deductions are made.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are carried at the unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through September 29, 2025, which is the date the financial statements were available to be issued.

3. **Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Fidelity Management Trust Company (Fidelity), the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certifications from the trustee as of and for the year end December 31, 2024 and as of December 31, 2023 stating that the information provided to the Plan Administrator by the trustee is complete and accurate. Such information includes investments, net appreciation in fair value of investments, interest and dividend income, investment transactions, notes receivable from participants, interest income on notes receivable from participants and notes receivable transactions.

Collective Trust

The Plan holds an investment in the Managed Income Portfolio II (MIP Fund), which is a stable value collective trust. The MIP Fund is a commingled pool managed by Fidelity as a trustee. The MIP fund seeks to preserve principal investment while earning a level of interest income that is consistent with principal preservation. The MIP Fund seeks to maintain a stable net asset value (NAV) of \$1.00 per unit. The MIP fund invests in fixed income securities, including U.S. Treasury and agency bonds, corporate bonds, mortgage-backed securities, asset-backed securities, and collective investment vehicles and shares of investment companies that invest primarily in fixed income securities, as well as investment contracts with insurance companies. The MIP Fund may also invest in derivative instruments, including futures contracts, option contracts, and swap agreements. There are no restrictions on participant redemption, which may occur daily. If the Plan were to initiate a full redemption of the collective trust, then the issuer reserves the right to require twelve months' advance notice. There are no unfunded commitments related to this collective trust at December 31, 2024.

4. Fair Value Measurements

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the NAV of shares held (based on quoted market prices) by the Plan at year end, which shares are traded in an active market.

Collective trust fund: The units of collective trust are valued at fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund (see Note 3).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. Transactions With Parties-in-Interest

Certain Plan investments are managed by Fidelity (or its affiliates), the trustee of the Plan. Net administrative expenses charged to the Plan for the year ending December 31, 2024 were \$7,132 and include amounts paid for investment management and recordkeeping fees. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rule under ERISA. In addition, notes receivable from participants qualify as party-in-interest transactions.
