## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Orscheln Industries Retirement Program (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule of assets held at year end as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

# ORSCHELN INDUSTRIES RETIREMENT PROGRAM

## NOTES TO FINANCIAL STATEMENTS

### 1. DESCRIPTION OF THE PLAN

The following description of the Orscheln Industries Retirement Program (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

*General:* The Plan is a defined contribution plan covering employees of Orscheln Management Co. and certain affiliated companies (the Company). The Plan was established September 1, 1986, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Eligibility:* Employees who have completed one year of service are eligible to participate in the Plan. A year of service is defined as a year in which a salaried employee or an hourly paid employee has worked or been compensated for more than 1,000 hours.

*Contributions:* Participants may contribute up to 50% of pretax annual compensation, as defined in the Plan, not to exceed maximum amounts specified by the Internal Revenue Service (IRS), in accordance with a participant deferral agreement. Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$7,500 for 2024 and 2023, under certain conditions. Participants may also contribute amounts representing rollover distributions from other qualified plans and make voluntary nondeductible contributions. The Company must make matching contributions of 50% of participant salary deferrals, not to exceed 2% of eligible participant compensation. The Company is required to contribute 3% of eligible participant compensation for participants as a safe harbor contribution. The Company met the required funding minimums. Participants direct the investment of contributions into various investment options offered by the Plan.

If, at the time a participant becomes eligible, the participant does not make an affirmative deferral election, the Company will automatically defer 3% from the participant's compensation. Unless participants with a deferral election for less than 10% of compensation affirmatively elect otherwise, the participants' deferral percentage will increase by 1% each April 1 until a deferral rate of 10% is reached.

*Participant accounts:* Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings, and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are automatically 100% vested in the portion of their accounts resulting from participant salary deferrals and earnings thereon. Participants become 100% vested in the Company's safe harbor contributions after two years of vesting service, and become 100% vested in the Company's matching contributions after three years of vesting service.

Participants become automatically 100% vested in employer matching and safe harbor contributions upon retirement, total disability, or death.

*Forfeitures:* Forfeitures of Company matching contributions are used to pay Plan expenses or reduce employer matching contributions. At December 31, 2024 and 2023, forfeited nonvested amounts available to pay future Plan expenses or reduce future employer matching contributions totaled \$24,431, and \$41,210, respectively. During 2024 and 2023, forfeitures totaling \$27,090 and \$16,558, respectively, were used to pay Plan expenses. During 2024 and 2023, no forfeitures were used to reduce employer matching contributions.

*Revenue holding account:* The Plan has a separate account established in the name of the Plan for the purpose of collecting revenue from Plan investment options to be used to pay Plan expenses. This account is considered a Plan asset and is included in the investment balance. During the years ended December 31, 2024 and 2023, the Plan received revenue sharing of \$34,657 and \$38,099, respectively, and paid Plan expenses of \$34,657 and \$38,099, respectively.

*Distribution of benefits:* Upon termination of service, a participant or his/her beneficiary may receive benefit distributions in one of the following forms:

- 1) A single lump sum payment (required for vested balances less than \$1,000), which may be in the form of a cash payout or rolled over into another qualified pension plan.
- 2) A partial payment, which may be in the form of a cash payout or rolled over into another qualified pension plan.

*Administration:* Previously, the Plan contracted with Prudential Retirement Insurance and Annuity Company (PRIAC), to provide professional and administrative services. Empower Annuity Insurance Company acquired Prudential's full-service retirement business on April 1, 2022. On October 3, 2022, PRIAC was renamed Empower Annuity Insurance Company of America (Empower). Empower holds the Plan's assets, administers investment activity, and invests contributions into funds designated by each participant. Empower also maintains the individual participant accounts, including cash transactions, and provides records of balances and transactions to the Plan administrator and participants. A portion of the administrative and recordkeeping costs are paid by the Company to the extent not paid from participants' forfeitures and the revenue holding account. The Company's Board of Directors is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

*Basis of accounting:* The financial statements of the Plan are prepared under the accrual basis of accounting.

*Valuation of investments:* Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the declaration date. Interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Contributions:* Contributions from plan participants and the matching contributions from the Company are recorded in the year which the employee contributions are withheld from compensation.

*Payment of benefits:* Benefits are recorded when paid.

*Expenses:* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Investment related expenses are included in net appreciation in fair value of investments.

*Estimates:* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Subsequent events:* Events that have occurred subsequent to December 31, 2024, have been evaluated through September 26, 2025, which represents the date the Plan's financial statements were approved by management and, therefore, available to be issued.

### **3. TERMINATED PARTICIPANTS**

Net assets available for benefits at December 31, 2024 and 2023 include \$8,084,280 and \$13,555,652, respectively, allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts may be paid within the next year, at the request of the participants. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

### **4. TAX STATUS**

The Plan obtained a favorable determination letter dated December 2, 2016, in which the IRS stated that the Plan, as amended through September 22, 2015, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC, and the Plan administrator believes that the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **5. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## 6. CERTIFICATION OF INVESTMENT INFORMATION

Certain information in the accompanying financial statements and the ERISA-required supplemental schedule of assets held at year-end related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income, and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, qualified institutions.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## 7. FAIR VALUE OF INVESTMENTS

Plan investments are held in a custodial account managed by Empower Annuity Insurance Company of America and Empower Trust Company, the Plan's custodians, and are unsecured. Investments are participant-directed and held by parties-in-interest.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of financial instruments that are required or permitted to be measured at fair value for reporting in financial statements. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets recorded at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund on an active market which is based on the underlying net asset value (NAV) of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV of shares held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. The pooled separate accounts are not publicly traded. Individual participant accounts invested in the pooled separate accounts are maintained on a unit value basis. The pooled separate accounts held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 8. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a traditional investment contract with Empower. Empower maintains the contributions in a guaranteed income fund. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following: the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code; premature termination of the contracts; Plan termination or merger; changes to the Plan's prohibition on competing investment options; and bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: an uncured violation of the Plan's investment guidelines; a breach of material obligation under the contract; a material misrepresentation; and a material amendment to the agreement without the consent of the issuer.

## 9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include transactions with fiduciaries or employees of the Plan, any person providing services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, and relatives of parties-in-interest. The Plan has various parties-in-interest. Investments are held with parties-in-interest and certain fees are paid to parties-in-interest.

## **10. PLAN SPIN-OFF**

Effective October 12, 2022, Orscheln Farm and Home LLC was acquired by Tractor Supply Company. Effective as of that same date, the Plan was amended to remove Orscheln Farm and Home LLC as a participating employer in the Plan. Since the employees of Orscheln Farm and Home LLC became participants in the Tractor Supply Company 401(k) Retirement Savings Plan in connection with the acquisition transaction, the Plan engaged in a trustee-to-trustee transfer of assets and liabilities to the Tractor Supply Company 401(k) Retirement Savings Plan (a "Spin-Off"). As a result of the Spin-Off, plan assets and liabilities of \$50,480,524 were transferred out of the Plan to the Tractor Supply Company 401(k) Retirement Savings Plan (in conformity with Section 414(l) of the Internal Revenue Code) on January 30, 2023.
