**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Manatt's, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established by Manatt's, Inc. (the Plan Sponsor) effective December 31, 2018. The Plan year end is December 31. The Plan provides health and other benefits to eligible employees (and covered dependents) of Manatt's, Inc. and the following related companies under common control: Pelco Enterprises, Ltd.; L.L. Pelling Company; WAMS, Ltd.; Wendling Quarries, Inc.; Beneficial Technologies, L.L.C.; Valley Environmental Services, Inc.; MAS, Inc.; and Cunningham-Reis, L.L.C. (collectively, the covered employers). A general description of the Plan is included in a Summary of Benefits Statement provided to employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In general, all full-time year round and full-time seasonal employees scheduled to work at least 30 hours per week on a regular basis are eligible to participate.

**Contributions**

The Plan is funded by participant and employer contributions. Participant premium contributions paid to the Plan are deducted from the employee's wages on a pre-tax basis (if eligible to participate in their participating employer's cafeteria plan) or on an after-tax basis. The employee is eligible for coverage on the first of the month following completion of 30 calendar days of full-time or full-time seasonal employment (30 or more hours per week). The contributions are specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of dental, vision, supplemental and dependent life insurance, long-term disability, accident, and critical illness benefits based on the current group rate premium costs. The participating employers pay the full cost of basic life insurance, basic accidental death and dismemberment insurance, and employee assistance program. The participating employers pay the majority of the cost of short-term disability. Flexible spending account contributions are determined by an election made by the employee and are fully funded by the participant. Flexible spending account contributions are subject to certain Internal Revenue Service (IRS) limitations.

Any deficit in the net assets available for benefits over benefit obligations is expected to be recovered through future contributions.

**Benefits**

The Plan provides benefits to full-time or full-time seasonal employees. The Plan provides health (dental and vision), life insurance, short and long-term disability, accidental death and dismemberment, accident, critical illness, and employee assistance program benefits to eligible members and to their beneficiaries and dependents. The Plan also offers healthcare and dependent care flexible spending accounts to eligible employees.

**Benefits (Continued)**

The Plan provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Current dental claims of active participants, beneficiaries, dependents, and participants covered under COBRA arrangements are provided for by funding from employee contributions. It is the present intention of the Plan Sponsor to continue the funding arrangements for dental benefits.

**Insured Benefits**

The Plan fully insures vision, life insurance (basic, supplemental, and dependent), basic accidental death and disability benefits (employee and dependents), long-term disability, accident, critical illness, and employee assistance program benefits. The Plan Sponsor purchases annual insurance contracts for these insured benefits which are paid to the insurance companies from the assets of the Plan.

**Self-insured Benefits**

All other Plan benefits are self-insured (dental and short-term disability). The claims for self-insured benefits (other than short-term disability) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by either the Plan's assets or the general assets of the Plan Sponsor. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

**Flexible Spending Accounts, Forfeitures, and Rollovers**

Healthcare and dependent care flexible spending account net assets available for benefits were \$148,434 and \$125,510 at December 31, 2024 and 2023, respectively.

Employees are allowed 90 days after the end of the Plan year to submit healthcare and dependent care flexible spending account claims for reimbursement. Amounts withheld from employees and not subsequently claimed or rolled over are forfeited to the Plan. Forfeitures for the years ended December 31, 2024 and 2023 were \$60,787 and \$47,373, respectively. Forfeitures can be used to pay administrative expenses.

Internal Revenue Bulletin 2013-47 (the Bulletin) modified the "use-or-lose" rule for health flexible spending arrangements. Accordingly, the Plan Sponsor amended its Section 125 Cafeteria Plan Document to provide for the carryover to the immediately following plan year of up to \$640 of any amounts remaining unused as of the end of the plan year and runout period (90 days following year end).

At December 31, 2024 and 2023, the Plan carried forward \$48,794 and \$53,827, respectively, in net assets available for benefits under these plan provisions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

The determination of plan benefit obligations involves certain significant estimates. Management reviews these estimates routinely but it is reasonably possible that circumstances that existed at December 31, 2024 may change in the near future and that the effect could be material to the financial statements.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. See Note 4 for discussion of fair value measurements.

**Administrative Expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and insurance costs. These expenses are reported on the statements of changes in net assets available for benefits and changes in benefit obligations as Administrative Expenses.

**Payment of Benefits**

Claim payments are recorded when paid by the Plan. Amounts due to service providers are claim payments that have yet to be paid by the Plan and are recorded in the accompanying statements of net assets available for benefits and benefit obligations. Short-term disability payments are processed through the payroll system of the participating employers and paid from the general assets of the participating employers. These payments are recorded as claim payments in the accompanying statements of changes in net assets available for benefits and changes in benefit obligations.

Premiums paid by the Plan Sponsor and covered employers are recorded as insurance premiums in the accompanying the statements of changes in net assets available for benefits and changes in benefit obligations.

**NOTE 3 BENEFIT OBLIGATIONS**

The Plan “self-funds” dental benefits provided to participants. As of each December 31, there are self-funded dental claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for amounts due to service providers and claims incurred but not reported (IBNR) are estimated by Plan management based on available information including actual subsequent claims submitted. Plan management believes these claims will be paid during the following Plan year. Thus, the cost of such claims would be approximately equal to the present value, and, therefore, these claims will not be discounted. The ultimate actual claims could differ significantly from these estimates.

Healthcare and dependent care flexible spending account claims submitted for reimbursement in the 90 days following year-end for claims incurred prior to year-end total \$38,853 and \$24,310 as of December 31, 2024 and 2023, respectively.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Interest Bearing Checking Account:* Valued at cost which approximates fair value.

**NOTE 5 FINANCIAL INSTRUMENT RISK**

The Plan maintains cash primarily in an interest bearing bank deposit account, which at times during the year, may exceed the federally insured limit of \$250,000 for interest bearing accounts. The Plan Sponsor believes it is not exposed to any significant credit risk on its cash deposit account as a result of a balance which may exceed the federally insured limit.

**NOTE 6 TAX STATUS**

The Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Plan Sponsor or covered employers or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are managed by the Plan Sponsor. As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

The Plan Sponsor will periodically advance funds to the trust as needed to cover claims processed and these advances are repaid by the trust monthly. As of December 31, 2024 and 2023, the Plan Sponsor advanced contributions of \$5,144 and \$17,220, respectively, related to these advances as reflected in the statements of net assets available for benefits and benefit obligations.

**NOTE 9 RISKS AND UNCERTAINTIES**

The estimated Plan benefit obligation for IBNR claims is reported based on lag reports provided by the claims administrator and historical claims trends. Due to the uncertainties in the estimations and assumptions process, it is at least reasonably possible that the ultimate settlement of claims could differ materially from the amount recorded in the financial statements.
