Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of LRK Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 - Description of Plan

The following description of LRK Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined contribution 401(k) retirement plan available to substantially all employees of LRK, Inc. (the "Company") with the exception of leased employees and those employees who are covered by a collective bargaining agreement, who are twenty-one (21) years of age or older, and have completed four (4) consecutive months of service to qualify for employee deferrals. Eligible employees must also be employed at year-end to receive the Company matching and profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may elect to defer any percentage of their eligible annual compensation either as pre-tax 401(k) deferrals or Roth 401(k) deferrals, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age fifty (50) before the end of the plan year are eligible to make catch-up contributions. The Company makes a safe harbor contribution equal to three percent (3%) of eligible compensation. There is no year-end employment requirement for employer safe harbor contributions. The Plan also allows the Company to make discretionary matching and discretionary profit sharing contributions to the Plan in amounts determined by the Company. The Company made matching contributions equal to fifty percent (50%) of eligible employee's elective deferrals up to six percent (6%) of such eligible employee's compensation for the Plan years ended December 31, 2024 and 2023. There were no discretionary profit sharing contributions for the plan years 2024 and 2023.

Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among different pooled separate accounts and common/collective trust funds offered by John Hancock Life Insurance Company (John Hancock).

Participant accounts

Each participant's account is credited with the participant's deferral contributions, the Company's safe harbor contributions, an allocation of the Company's discretionary matching and profit sharing contributions, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested and charged with an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

December 31, 2024 and 2023

Note 1 - Description of Plan (continued)

Vesting

Participants are immediately vested in their deferral contributions, the Company's safe harbor contributions, and rollover contributions, plus earnings and losses thereon. Participants vest in the Company's discretionary matching and profit sharing contributions based upon years of service, with 100% vesting occurring after six (6) years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon termination of service for any reason, a participant may request account distributions in the form of a lump sum payment or equal installments, as defined by the plan document. Withdrawals of a participant's vested balance while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon attainment of age 59½.

Forfeited accounts

If an employee terminates before his or her Company discretionary matching or profit sharing contribution accounts have become fully vested, such portion of the accounts are forfeited. Participant forfeitures are used to reduce future Company contributions. At December 31, 2024 and 2023, employer contributions were reduced by \$11,201 and \$21,204, respectively, from forfeited nonvested accounts.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of significant accounting policies (continued)

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The Company's match and safe harbor contributions are recorded in the year of the related participant contributions or compensation to which they pertain.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the respective participant's account. Certain investment related expenses are included in net appreciation of fair value of investments.

Note 3 - Information prepared and certified by the custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that security liquidations will be carried out in an orderly business manner.

Note 5 - Related party transactions and party-in-interest transactions

Plan investments represent interests in certain pooled separate accounts and common/collective trust funds managed by John Hancock. John Hancock is the custodian for the Plan and provides the Plan with certain recordkeeping and administrative services. These services provided and the investments and related investment transactions qualify as party-in-interest transactions. Fees paid directly to the custodian and parties-in-interest totaled \$97,459 and \$84,019 in 2024 and 2023, respectively. The plan sponsor pays directly any other fees related to the Plan's operations.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Tax status

The IRS has determined that the Prototype profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and has stated such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, plan management believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 8 - Risks, uncertainties and concentrations

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 17% and 16% of the Plan's investments were invested in the John Hancock Multimanager Growth Fund, respectively.
