Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CVS Health Puerto Rico Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of CVS Health Puerto Rico Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of CVS Health Puerto Rico Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CVS Health Puerto Rico Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CVS Health Puerto Rico Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – The Plan and its Significant Accounting Policies

General – The following description of the CVS Health Puerto Rico Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established in 2005 by Caremark Corporation (Caremark). Effective March 22, 2007, Caremark merged with CVS Corporation. Effective September 23, 2008, sponsorship of the Plan transferred from Caremark to CVS Health Corporation (CVS) to provide benefits to eligible employees, as defined in the plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code for a New Puerto Rico (the Code), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, CVS sold its retail stores in Puerto Rico to a third party. Participants whose employment with CVS ended as a result of the sale were eligible to transfer their plan account (including outstanding loans) to the successor employer's 401(k) plan or, subject to the Plan's terms, continue to keep their account in the Plan.

Administration – CVS has appointed the Benefit Plans Committee (the Committee) to manage the operation and administration of the Plan. Effective January 2009, the Committee further named the Administrative Subcommittee and the Investment Subcommittee and delegated certain fiduciary duties to each of the Subcommittees. CVS has contracted with Oriental Bank and Trust (Oriental) to act as the Trustee, with Vanguard Fiduciary Trust Company (Vanguard) to act as the Custodian, and with an affiliate of Vanguard to act as the recordkeeper. Substantially all expenses incurred for administering the Plan are paid by CVS.

Estimates – The preparation of Financial Statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of accounting – The Financial Statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Forfeited accounts – Forfeited accounts may be used to pay Plan administrative expenses or reduce employer contributions.

Investment valuation and income recognition – The investments are reported at fair value. The Plan's Custodian, Vanguard, certifies the fair market value of all investments. Quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants (notes receivable) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the Plan document. No allowance for credit losses had been recorded as of December 31, 2024 or 2023.

Income taxes – The Plan has been amended since receiving the most recent determination letter from the Commonwealth of Puerto Rico Treasury Department dated September 26, 2016, stating that the Plan meets the requirements of Section 1081.01(d) of the Code, and that the trust established will be entitled to exemption from local income taxes. The plan administrator believes the Plan is being operated in compliance with applicable requirements of the currently effective Code, and therefore believes that the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the Financial Statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Under terms of the Vanguard administrative contract, certain asset-based fees are assessed by Vanguard on behalf of the Plan. These fees are maintained in a separate account and used to cover the Plan's administrative expenses. Participants are assessed separate fees for the administration of loans and certain distributions. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and uncertainties – The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Subsequent events – The Plan has evaluated subsequent events through May 28, 2025, which is the date the Financial Statements were available to be issued.

Note 2 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

What follows are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust – Units held in the collective trust (CT) are valued using the NAV practical expedient of the CT as reported by the CT manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The CT has no restrictions and may be redeemed daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3 – Participation and Benefits

Eligibility – For participant contributions, employees of CVS are eligible to participate in the Plan the first day of the month following employment provided that they have attained age 18. Prior to January 1, 2022, employees of CVS were eligible to participate in the Plan upon reaching age 18 and completing 90 days of service.

For employer contributions, participants must complete one year of service (at least 1,000 hours in a 12-month period) to be eligible to receive such contributions.

Participant contributions – Participants may elect to have CVS contribute their eligible pre-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulation. Participants who have CVS contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other Puerto Rico tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions – CVS matches 100% of each eligible participant's contribution up to a maximum of 5% of the participant's eligible compensation on a per-payroll period basis. In addition, CVS may make qualified matching, qualified nonelective, and discretionary employer contributions, as defined in the Plan.

Participant accounts – Each participant’s account is credited with the participant’s contribution, Plan earnings or losses, and an allocation of CVS’s contributions, if any. Allocations of CVS’s contributions are based on participant contributions and eligible employee compensation, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Vesting – Participants are immediately vested in their entire account, including employer contributions.

Payment of benefits – Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total benefits in partial or a lump sum amount equal to the value of the participant’s interest in their account. The Plan allows for the automatic distribution of participant account balances that do not exceed \$5,000.

Notes receivable from participants – The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their account balance. The notes receivable are secured by the participant’s balance. Such notes receivable bear interest at the available market financing rates and must be repaid to the Plan within a period not to exceed five years, unless the proceeds are used for the purchase of a principal residence, in which case the maximum repayment period may not exceed 15 years. The specific terms and conditions of such notes receivable are established by the plan administrator. Outstanding notes receivable at December 31, 2024, carried interest rates ranging from 4.25% to 9.50% with various maturities through September 2032.

Note 4 – Related-Party Transactions

Certain Plan investments are managed by an affiliate of Vanguard, the Custodian and recordkeeper of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 5 – Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard has certified to the completeness and accuracy of:

- Investments reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividends, and interest and interest on notes receivables from participants reflected in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and
- Investments reflected on the Schedule of Assets (Held at End of Year).

Note 6 – Plan Termination or Modification

CVS intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA.
