## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Strata-G Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the adoption agreement for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan established effective January 1, 2002 and amended and restated effective as recently as January 1, 2022. The Plan covers substantially all full-time employees of Strata-G, LLC (the "Sponsor"). There are no minimum service or age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Basis of Accounting* - The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates* - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in assets during the reporting periods. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are carried at their fair value based on published quotations. The Plan presents net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on these investments, in the statements of changes in assets available for benefits. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation or depreciation in fair value of investments.

*Notes Receivable from Participants* – Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000. The notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. The notes receivable are secured by the balances in the participants' accounts and bear interest at fixed rates reflective of general rates available to individual borrowers for

similar loans from commercial sources at the time of the loan. Repayment is required within five years or within a reasonable period of time if the loan is for a primary residence. Principal and interest are paid through regular payroll deductions. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. As of December 31, 2024 and 2023, interest rates on loans outstanding ranged from 4.25% to 9.50%.

*Contributions* - Participants may elect to make pre-tax or after-tax (Roth) contributions of up to 100% of their compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code. Employee contributions are recorded in the period during which the Company makes payroll deductions from the plan participants' earnings.

The Plan provides for employer safe harbor matching contributions that are immediately 100% vested. The Company matches, at each payroll date, 100% of elective deferrals up to 3% of compensation plus 50% of elective deferrals between 3% and 5% of compensation.

The Sponsor may elect to make discretionary matching and profit-sharing contributions to the Plan. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Company profit-sharing contributions are recorded by the Plan when and if approved by the Sponsor. There were no profit sharing contributions for the year ended December 31, 2024 or 2023.

*Fair Value Measurements* - U.S. GAAP establishes a framework for measuring the fair value of financial assets and liabilities. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

At December 31, 2024 and 2023, plan investments consist of mutual funds that are valued based on published quotations in active markets (level 1 measurement).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

There have been no changes in the methodologies during the year ended December 31, 2024 or 2023.

*Participant Accounts* - Participants direct the investment of their account balances and contributions and may change their elections at any time. Each participant's account is credited with the participant's contribution and an allocation of the Sponsor's contribution and plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Risks and Uncertainties* - The Plan's funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits and of changes in assets available for benefits.

*Vesting* - Participants are immediately vested in their voluntary contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting of employer profit sharing contributions and earnings thereon occurs according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 but less than 2	25%
2 but less than 3	50%
3 but less than 4	75%
4 or more	100%

*Forfeitures* - Forfeitures represent the non-vested benefits remaining in the Plan for terminated employees. Forfeitures are used to reduce employer matching contributions and pay plan expenses. For the years ended December 31, 2024 and 2023, forfeitures of \$7,551 and \$2,129, respectively, were utilized to pay plan expenses. Furthermore, for the year ended December 31, 2024, forfeitures of \$7,356 were utilized to reduce employer contributions. At December 31, 2024 and 2023, forfeitures of \$414 and \$8,016, respectively, were available.

*Payment of Benefits* - On termination of service due to death, disability or retirement, or upon the attainment of age 59½ and subject to certain restrictions, a participant or designated beneficiary may elect to receive either a lump-sum equal to the vested value of his or her account, a rollover to another qualified plan or individual retirement account, or partial withdrawals, subject to applicable tax withholding requirements. On termination of service due to other reasons, a participant may elect to receive an amount equal to the vested interest in his or her account as a lump-sum distribution or in installments if the balance exceeds \$5,000.

*Administrative Expenses* - The Plan's expenses are paid by the Sponsor or by the Plan as provided by the plan agreement.

*Subsequent Events* - The Sponsor has evaluated subsequent events through October 2, 2025, the date which the financial statements were available to be issued.

## **2. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

## **3. INCOME TAX STATUS**

The Plan is a non-standardized, pre-approved plan sponsored by Tennessee Pension Administrators LLC. The Internal Revenue Service has stated in a letter dated June 30, 2020 that the plan is designed in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for years prior to December 31, 2021.

#### **4. CERTIFIED FINANCIAL INFORMATION**

Capital Bank and Trust Company has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Income on investments and notes receivable from participants, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The accompanying schedule of assets held for investment purposes as of December 31, 2024.

#### **5. RELATED PARTIES AND PARTIES IN INTEREST**

Capital Bank and Trust Company serves as custodian of the Plan and also provides access to the American Funds mutual funds. Capital Bank and Trust Company and American Funds are part of Capital Group and, accordingly, are considered parties-in-interest.

Neither the administrator nor the trustees of the Plan receive compensation from the Plan.
