## Independent Auditor's Report

To the Administrative Committee of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Palm Beach Health Consulting LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Transamerica Financial Life Insurance Company Inc., a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### **Note A – Description of Plan**

The following description of Palm Beach Health Consulting LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan covering substantially all employees of Palm Beach Health Consulting LLC (the Sponsor) and its affiliates, who have completed one year of service and are age twenty-one or older. Employees covered under a collective bargaining agreement or are a leased employee, a resident of Puerto Rico, or a non-resident alien are excluded from participating in the Plan. Participation in the Plan is entirely voluntary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions.** Participants may contribute both pre-tax and after-tax (Roth) deferral amounts up to the maximum percentage allowable not to exceed the limits of Code Sections 401(k). For 2024, the maximum deferral amount is \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Each year, the Company has the option of making a discretionary matching contribution. In determining the matching contribution, only 2% of a participant's compensation will be matched. No matching contributions were made for the plan year ending December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts.** Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based upon years of continuous service. A participant is 100 percent vested after six years of credited service.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by their vested account balances and bear interest at 1 percentage point over the prime interest rate at the time of loan origination. The term of the loan may not exceed five years, except for loans made for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits.** On termination of service due to death, disability or retirement, a participant shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeited Accounts.** Generally, when a participant terminates in the plan, the nonvested portion of the participant's account, as defined by the plan, represents a forfeiture. Pursuant to the provisions of the plan, these accounts can be used to reduce any employer contributions. There is no balance in the forfeiture account as of December 31, 2024 and 2023.

### **Note B – Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. For the plan's fully benefit-responsive investment contract, contract value approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Financial Life Insurance Company Inc. (the trustee of the Plan).

### Note D – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note E – Transamerica Stable Value Fund

The Plan invests in the Transamerica Stable Value Fund (the "Fund"), a collective trust managed by Transamerica. The Fund seeks to preserve principal and provide a stable return by investing in a diversified portfolio of fixed income securities and wrap contracts issued by insurance companies and banks. The wrap contracts are designed to provide stability by allowing participant transactions at contract value, regardless of the fair value of the underlying investments.

The Fund is deemed to be fully benefit-responsive. Accordingly, investments in the Fund are reported at contract value in the accompanying financial statements. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses, and is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. For this Fund, contract value equals fair value.

The Fund is credited with earnings from the underlying investments and charged for participant withdrawals and administrative expenses. The crediting rate is determined based on the Fund's earnings and the relationship between the fair value and contract value of the underlying investments, and is reset periodically, but will not be less than zero percent.

Participant transactions (purchases and sales) may occur daily at contract value. However, the Fund imposes certain restrictions on transfers to competing options, such as money market funds, which require a 90-day equity wash provision.

The Fund is subject to risks, including the credit risk of the issuers of the underlying securities and wrap providers, as well as interest rate risk. While these risks could affect the Fund's ability to achieve its objective, management believes the occurrence of events that would limit the Fund's ability to transact at contract value is not probable.

### **Note F – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit-sharing contributions.

### **Note G – Related Party and Party in Interest Transactions**

Certain Plan investments were managed by Transamerica Life Insurance Company ("Transamerica"). Transamerica was the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$12,820 for the year ended December 31, 2024.

### **Note H – Tax Status**

The Plan has adopted a nonstandardized form of a prototype plan sponsored by Ascenus LLC. The prototype plan has received an opinion letter from the IRS, dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note I – Nonexempt Transactions**

During 2024, the plan sponsor did not remit \$483 of participant loan repayments to the plan in a timely manner, as defined by ERISA. Late contributions, in the amount of \$262, were remitted to the plan on August 4, 2025. The plan sponsor intends to remit the remaining balance of late contributions to the plan during 2025.

During 2023, the plan sponsor did not remit certain participant contributions to the plan in a timely manner, as defined by ERISA. These late contributions, in the amount of \$14,365 were remitted to the plan on May 16, 2024. The Company calculated lost earnings on this in the amount of \$1,789 and remitted this to the plan on July 31, 2024.

These contributions are considered nonexempt party-in-interest transactions and do not affect the tax status determination of the plan.

### **Note J – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **Note K – ERISA Bond Requirement**

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024, the Plan's sponsor maintained bond coverage in the amount of \$1,000,000.

### **Note L – Subsequent Events**

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.
