Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Peregrine Sports, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Description of Plan

The following description of the Peregrine Sports, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all non-union employees of Peregrine Sports, LLC (the Company). Full-time employees are eligible after they have completed three consecutive months of service with a minimum of 250 hours of service with the Company and are at least 21 years of age. The Plan excludes employees covered by a collective bargaining agreement and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

The Plan provides for employee pre-tax deferral contributions, after-tax Roth deferral contributions, or a combination of both. A participant may elect to contribute up to the maximum allowed under the Internal Revenue Code (IRC), each year instead of receiving that amount in cash. The Plan has an automatic enrollment feature whereby a participant who meets the eligibility requirements of the Plan will have 6% of their pay withheld which will increase by 1% on the 1st day of each calendar year up to a maximum of 10%, unless the participant elects to decline enrollment. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). The pre-tax amount deferred will not be subject to income tax until it is actually distributed to the participant. The amount deferred is, however, subject to Social Security tax at the time of deferral. The participant may change their deferral election each pay period.

Matching contributions are based upon the amount of contribution dollars contributed by each participant. The matching contribution is a discretionary amount determined by the Company on an annual basis. Matching contributions were 50% of the participant’s contributions up to 8% of eligible compensation in 2024. Effective May 1, 2024, matching contributions were changed to the following:

Additionally, the Company may elect to make a separate discretionary profit-sharing contribution to the Plan at the end of the Plan year. In 2024, the Company did not elect to make a separate discretionary profit-sharing contribution.

Investment Elections

The participant may choose from several combinations of registered investment companies offered by Ascensus, LLC (the Trustee) as selected by the Plan Administrator. Upon enrollment in the Plan, participants may individually direct their investments. The Target Date Funds (based on estimated participant retirement date) are currently the Plan’s designated default funds for those participants who have not otherwise selected an investment option. Employees have the opportunity to change their investments daily.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s matching contribution, (b) the Company’s discretionary profit-sharing contribution and, (c) Plan earnings (losses) and expenses. Allocations are based on participant wages or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Excess Contributions Payable

Excess contributions payable represent amounts withheld from participants in excess of IRC limitations that were refunded to participants subsequent to year end. Excess contributions are netted against contributions in the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant’s vested account balance. The loans are secured by the vested balance of the participant’s account and bear interest at a rate of prime plus 1%, which is commensurate with local prevailing rates. At December 31, 2024, the outstanding loans bear interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans are not permitted from Roth deferral contributions.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service, according to the following schedule:

Participants shall become 100% vested in their account balances upon attainment of normal retirement age (65 years), death, or permanent disability.

Forfeitures

At December 31, 2024, forfeit nonvested accounts totaled \$15,080 and none at December 31, 2023. During the year ended December 31, 2024, forfeitures of \$10,363 were used to reduce employer contributions.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of their vested account balance, rollover the account into another qualified plan or individual retirement account, take partial withdrawals, or maintain the account without the ability to contribute additional amounts. Hardship distributions are allowed based on financial need as well as in-service distributions for participants meeting certain requirements. The Plan will make mandatory distributions for terminated participants with account balances of less than \$5,000. Account balances for terminated participants of less than \$1,000 are automatically distributed in a lump sum; otherwise, mandatory distributions will be subject to automatic rollover.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and third-party administrator.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to investment management, distribution, and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events have been evaluated through October 2, 2025, the date the financial statements were available to be issued.

Note 3 - Information Certified by the Trustee

The Plan's investments are held by Ascensus Trust Company, the Trustee of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses as allocated based on the Plan document. The Plan Administrator has obtained certifications from the Trustee as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the following information provided to the Plan Administrator by the Trustee is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants

Note 4 - Fair Value Measurements

Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of inputs may be used to measure fair value:

Level 1 - quoted prices in active markets for identical assets or liabilities.

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Interest-Bearing Cash: Includes a money market account. Valued at the closing balance, plus accrued interest.

Registered Investment Companies (Mutual funds): Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions.

Note 6 - Tax Status

The Internal Revenue Service (IRS) has determined by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan With CODA Plan sponsored by Ascensus, LLC which has been adopted by the Plan, is acceptable pursuant to section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements as of December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Party-in-Interest Transactions

Certain Plan investments are shares of registered investment companies managed by The Vanguard Group, Inc. The Vanguard Group, Inc. is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Cambridge Investment Research, LLC are the investment managers for the Plan. Recordkeeping and investment management fees were included in administrative expenses in the statement of changes in net assets available for benefits. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
