MinuteClinic 401(k) Plan Notes to Financial Statements

Note 1 – The Plan and its Significant Accounting Policies

General – The following description of the MinuteClinic 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a multiple employer defined contribution plan covering employees of MinuteClinic, L.L.C. (the Primary Sponsor), and unrelated entities that have adopted the Plan and Trust (collectively referred to as the Company) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration – The Primary Sponsor has delegated to the Benefit Plans Committee (the Committee) of CVS Health Corporation (CVS) the responsibility to manage the operation and administration of the Plan. Effective January 2009, the Committee further named an Administrative Subcommittee and Investment Subcommittee and delegated certain fiduciary duties to each of these Subcommittees. The Company has contracted with Vanguard Fiduciary Trust Company (Vanguard) to act as the Custodian and Trustee, and an affiliate of Vanguard to act as the third-party administrator to process and maintain the records of participant data. Substantially all expenses incurred for administering the Plan are paid by the Plan.

Estimates – The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Basis of accounting – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America.

Forfeited accounts – Forfeited accounts may be used to pay Plan administrative expenses or reduce future employer contributions.

Investment valuation and income recognition – The investments are reported at fair value. Vanguard has certified the fair value of all investments as of December 31, 2024 and 2023 and for the year ended December 31, 2024. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants (notes receivable) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

MinuteClinic 401(k) Plan Notes to Financial Statements

Income taxes – The Plan has been amended since receiving the latest favorable determination letter dated December 3, 2013. The Plan Administrator believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Under terms of the Vanguard administrative contract, certain asset-based fees are assessed by Vanguard on behalf of the Plan. These fees are maintained in a separate account and used to cover the Plan's administrative expenses. Participants are assessed separate fees for the administration of loans and certain distributions. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and uncertainties – The Plan provides for various investment options in a combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Subsequent events – The Plan has evaluated subsequent events through May 28, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the name of the Plan was changed from the MinuteClinic 401(k) Plan to the CVS Health Care Delivery 401(k) Plan.

Note 2 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 –Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

What follows is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts – Units held in the collective trusts (CTs) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. There are no restrictions on the CTs and they are redeemable daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3 – Related-Party Transactions

Certain Plan investments are managed by an affiliate of Vanguard, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 4 – Participation and Benefits

Eligibility – Employees of the Company are eligible to participate in the Plan and make contribution deferrals on the first day of the month following employment provided that they have attained age 18.

Participants must complete one year of service (at least 1,000 hours in a 12-month period) to be eligible to receive employer contributions.

Participant contributions – Participants may elect to have the Company contribute their eligible pre-tax or Roth compensation to the Plan up to the amounts allowable under the Plan document and current Internal Revenue Service (IRS) limits. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable or taxed compensation. Contributions withheld are invested in accordance with the participant’s direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

Employer contributions – The Company matches 100% of each eligible participant’s contribution up to a maximum of 5% of the participant’s eligible compensation on a per payroll basis, subject to IRS limits.

Participant accounts – Each participant’s account is credited with the participant’s contribution, investment earnings or losses, and an allocation of the employer contribution, if any. Allocation of the employer’s contribution is based on participant contributions and eligible employee compensation, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Vesting – Participants are immediately vested in their contributions and employer contributions allocated to their accounts.

Payment of benefits – Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their benefits in installments or in a lump sum amount equal to the value of the participant's interest in their account. The Plan allows for the automatic lump sum distribution of participant account balances that do not exceed \$1,000 and automatic rollovers for participant account balances over \$1,000 up to \$7,000, effective January 1, 2024.

Plan to plan transfers – Participants who transfer employment, either in or out of the Company, to a different job within the CVS controlled group are allowed to make a one-time plan to plan transfer of their full account balance.

Notes receivable from participants – The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their account balance. The notes receivable are secured by the participant's balance. Such notes receivable bear interest at the available market financing rates and must be repaid to the Plan for up to a five-year period, unless the proceeds are used for the purchase of a principal residence, in which case the maximum repayment period may be longer. The specific terms and conditions of such notes receivable are established by the Plan Administrator. Outstanding notes receivable at December 31, 2024, carry interest rates ranging from 4.25% to 9.50%, with various maturities through July 2037.

Note 5 – Certified Information

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividends and interest (including interest income from notes receivable) reflected in the accompanying Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investments reflected on the Schedule of Assets (Held at End of Year).

Note 6 – Plan Termination or Modification

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA.
