NOTE A - DESCRIPTION OF PLAN

The following description of the 401 (A) Thrift Plan ("Plan") of Golden Age, Inc. ("Company") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan, started January 1, 1979, is a defined contribution plan covering employees who have over one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Contributions are integrated at a level of \$15,000. This first \$15,000 receives a contribution of 2%. The excess receives a contribution of 4%. The Company expense is paid annually following the annual date of December 31<sup>st</sup>. The forfeitures are a reduction in the annual expense payment. Rollover and Transfer Contributions are not permitted.

Participant Accounts:

Each participant's account is credited with: the Company's contribution and the Plan's earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants:

Participant loans are not permitted under the Plan.

Payment of Benefits:

A participant who terminates employment with the Employer prior to his early retirement date may elect to receive his retirement benefit as of a benefit commencement date prior to his early retirement date.

Unless an optional form a benefit is selected pursuant to a Qualified Election with the 90-day period ending the Benefit Commencement Date, a married participant's vested account shall be paid in the form of a Qualified Joint and Survivor Annuity and an unmarried participant's vested account shall be paid in the form of a Non-Refund Life Annuity. The participant may elect to have such an annuity distributed upon attainment of the Earliest Retirement Age under this Plan.

Forfeited Accounts:

At December 31, 2024, forfeited nonvested accounts totaled \$2,062. This will be used to offset employer contributions. At December 31, 2023, forfeited nonvested accounts totaled \$3,671.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment committee determines the Plan's valuation policies. See Note C for discussion of fair market value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as during the year.

Notes Receivable from Participants:

Participant loans are not permitted under the Plan.

Payment of Benefits:

Benefit payments are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Date of Management's Review of Subsequent Events:

Subsequent events were evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

#### NOTE C – FAIR VALUE MEASUREMENT AND INVESTMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to value techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses the appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements:

The fair values of the mutual funds are based on closing price reports in the active market where the individual securities are traded, when available.

Level 2 Fair Value Measurements:

The fair value of Guaranteed Interest Account is treated as cash. The account is based on the original cost plus accrued interest.

NOTE F – RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

The Plan paid administrative expenses to Mutual of America Financial Group of \$2,309 and \$1,331, for the years ending December 31, 2024 and 2023, respectively. Mutual of America Financial Group served as the third-party administrator.

In addition to the expenses listed above, Golden Age, Inc. paid administrative expenses to BFMW Group, PLLC for audit fees of \$11,974 and \$10,594 for 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.
