Notes to Financial Statements

Note A – Description of Plan

The following description of the Total Component Solutions Corporation 401(k) Retirement Plan for Total Component Solutions Corporation (hereinafter referred to as the Plan) is provided for general purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a 401(k)-retirement plan covering all employees of Total Component Solutions Corporation, who have at least six months of service, work at least 500 hours per year and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and has been created pursuant to Section 401(k) of the Internal Revenue Code. The Board of Trustees is responsible for the oversight of the Plan.

Contributions and Vesting

An employee who is eligible to participate in the Plan may file an elective deferral agreement for a specified amount of weekly or semi-monthly pay to contribute. Total Component Solutions Corporation 401(k) Retirement Plan made an employer match of 62.5% of the first 2% an employee contributed to the Plan and 25% of employee contributions between 2% and 5% through December 31, 2024. The participants become vested in their portion of the employer's contribution over a 4-year period at 25% per year. All years of service are counted for vesting purposes, except years with less than 1,000 hours.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations, and plan earnings. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Payment of Benefits

On termination of service, a participant may elect to receive either in a lump sum or in annual installments an amount equal to the value of his or her account.

Hardship Distributions

There is no minimum amount set for hardship distributions or in-service distributions. The hardship distributions are limited only to an immediate and heavy financial need. No excess distributions are allowed unless it is to help pay any federal, state, or local income taxes resulting from the distributions. Once a hardship distribution is withdrawn, the employee is not allowed to make any salary deferrals and after-tax voluntary contributions for at least six months after receipt of the hardship distribution.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,258 and \$2,089 respectively. These accounts will be used to reduce future employer contributions or administrative expenses.

Notes Receivable from Participants

Loans are available to participants in the event of a hardship or to help participants meet certain specified financial situations. Plan Administrator will determine if a participant qualifies for a loan. Loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023.

The loan cannot exceed 50% of his or her non-forfeitable account balance. Also, an aggregate participant's loan balance may not exceed \$50,000. No loan will be issued for less than \$1,000. A participant can only have two loans currently outstanding from the plan. The term of the loan cannot exceed 5 years, unless for a purchase of a principal residence.

Note B – Summary of Significant Accounting Policies

Preparation of the Financial Statements

The Plan prepares its financial statements in accordance with the Department of Labor's rules and regulations on an accrual basis.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing the information provided by the investment advisers, custodians and insurance company. See note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note B – Summary of Significant Accounting Policies (Continued)

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note C – Investments

The Plan's custodians have provided certifications to the plan administrator regarding the accuracy and completeness of certain information related to investment holdings of the Plan and the income and expenses of the Plan. The following information certified by the custodians has been used in the preparation of the accompanying financial statements. This information is unaudited.

Note D – Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by John Hancock USA; therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Certain Plan investments are shares of mutual funds of the Trustee which amounted to \$8,935,621 and \$8,239,765 as of December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment services to the trustee amounted to \$30,114 and \$26,308 for the years ended December 31, 2024 and 2023, respectively.

Note E – Fair Value Measurements

GAAP defines fair value, establishes a framework for measuring fair value, and requires disclosures about fair value measurements. Fair value is based on an exit price, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP also establishes a hierarchal disclosure framework which prioritizes and ranks the level of market price observability used in measuring financial statements at fair value. Market price observability is affected by a number of factors, including the type of instrument and the characteristics specific to the instrument. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note F – Rollover Contributions

An aggregate of \$5,917 and \$4,003 was rolled in the Plan during the year ended December 31, 2024 and 2023 and is included in rollovers on the statement of changes in net assets available for benefits.

Note G – Tax Status

The IRS has determined and informed the Company by a letter dated May 15, 2003, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the US Department of Revenue. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
