We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Notes to Financial Statements**  
**Year Ended December 31, 2024**

**Note 1 – Description of Plan**

The following description of the B. Riley Financial, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. B. Riley Financial, Inc. (the “Company”) is the plan sponsor. Fidelity Management Trust Company (“Fidelity”) is the trustee of the Plan. Fidelity holds the Plan’s investments and executes investment transactions through the trust established pursuant to the Plan. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan. Employees can contribute to the plan the first day after completion of one full month of service. The Plan was established on January 1, 1999, and includes all eligible employees of the Company that are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Each year, participants may contribute up to 100 percent of their compensation, as defined in the Plan agreement, subject to a maximum annual limit by the Internal Revenue Service. In 2024, pre-tax contributions are subject to a limitation of \$23,000, plus a catch-up contribution of \$7,500 for participants age 50 or older. The Plan also permits Roth 401(k) contributions and effective January 1, 2022, has a Roth 401(k) conversion feature. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for Company matching contributions equal to 25% of the participant contributions up to 6% of each eligible employee’s annual compensation as defined. For the year ended December 31, 2024, the Company made matching contributions of \$2,469,636.

Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover contributions). Rollover contributions into the Plan are not eligible for a Company matching contribution. During the year ended December 31, 2024, rollover contributions of \$2,552,958 were made into the Plan.

**Participant accounts**

Individual accounts are maintained for each participant in the Plan. Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, if any, as well as allocations of Plan earnings and allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant

transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. Company matching contributions vest at the rate of 33% for each year of employment, and are 100 percent vested after three years of credited service. Company's contributions are also fully vested upon death or termination for permanent disability. Some participants formerly in predecessor plans are vested immediately in current Company contributions.

### **Investment options**

The Plan offers various investment options which are managed by Fidelity. Upon enrollment in the Plan, participants may direct their contributions in any of the investment options offered at the time. Participants may change their investment options daily. Participants should refer to the investment literature provided by the Company for a complete description of the investment options and for the detailed composition of each investment fund.

### **Notes receivable from participants**

Participants may borrow from their accounts in amounts ranging from \$1,000 to \$50,000, but not in excess of 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence and are repayable ratably through payroll deductions. At December 31, 2024 and 2023, interest on notes receivable from participants ranged from 4.25% to 9.50% per annum, with various maturities through June 2034.

### **Payment of benefits**

Upon termination of service due to death, disability, retirement, termination of employment, or financial hardship, participants with vested account balances of up to \$1,000 will receive a single lump sum payment equal to the value of the vested interest in his or her account. Participants with vested account balances greater than \$1,000 may elect to receive either a single lump sum payment equal to the value of the vested interest in his or her account, rollover such amount to another qualified plan or defer benefits. If subject to required minimum distributions in accordance with the Plan's provisions, participants may receive distribution payments in installments.

### **Forfeited Accounts**

Forfeited balances of terminated participants' nonvested Company contributions are used to reduce future Company contributions and to pay administrative expenses of the Plan. At December 31, 2023, forfeited non-vested accounts totaled \$190,744. During the year ended December 31, 2024, additions included amounts forfeited by terminated participants of \$166,266, and earnings of

\$2,582, offset by \$215,672 used to reduce the Company's contributions, and \$17,691 used to pay administrative expenses of the Plan. At December 31, 2024, forfeited non-vested accounts totaled \$126,229.

## **Note 2 – Summary of Accounting Policies**

### **Basis of accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### **Use of estimates**

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Significant estimates include the fair value of certain investments. Actual results could differ from those estimates.

### **Investment valuation and income recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes receivable from participants**

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. At December 31, 2024 and 2023, there was no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' vested account balances.

### **Payment of benefits**

Benefits are recorded when paid in accordance with ERISA reporting requirements.

## **Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **Note 3 – Fair Value Measurements**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are defined as follows:

Level 1 – Unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.

Level 2 – Quoted prices other than those included in Level 1 that are observable either directly or indirectly. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or that can be corroborated by observable market data for substantially the full term of the financial instrument.

Level 3 – Inputs are unobservable and significant to the fair value measurement. Unobservable inputs reflect the Plan's own judgements about assumptions that market participants would use in pricing the asset or liability.

The following are descriptions of the valuation methods and assumptions used for investments of the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported on the active market on which the individual funds are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* The fair value of investments held in the self-directed brokerage accounts (which consist primarily of common stocks and mutual funds) are determined by obtaining quoted prices on a nationally recognized securities exchange.

*B. Riley Financial Inc. Common stock:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Interest-bearing cash:* Short-term money market instruments are valued at cost, which approximates fair value based on quoted market prices available on an active market.

*Limited partnership pooled assets:* The investment in a limited partnership is valued based on the fair value of the underlying investments. The underlying investments are carried at fair value based on Level 3 inputs.

*Stable value collective trust fund:* At December 31, 2024, the Plan had an investment in T. Rowe Price (“TRP”) Stable Value Fund A, which is a common collective trust fund valued using the net asset value (“NAV”), as provided by the administrator of the fund. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Trusts participating in the fund are subject to restriction on withdrawals from the fund. Withdrawals needed for benefit payments and loan advances of participating employee benefit plans are generally permitted daily. If the Plan initiates a full redemption of the funds, the trustee reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments as of December 31, 2024 or December 31, 2023.

During the year ended December 31, 2024, there were no transfers of assets between Levels 1, 2 and 3. The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023:

#### **Note 4 – Certified Investment Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (“Fidelity”), the trustee of the Plan.

As of December 31, 2024 and 2023, \$210,638 and \$285,431, respectively, of investments in limited partnership were not held by Fidelity.

#### **Note 5 – Related Party and Party-In-Interest Transaction**

The Plan allows participants to invest funds in the common stock of B. Riley Financial Inc., the Plan sponsor, and therefore, these transactions qualify as party-in-interest. At December 31, 2024 and 2023, participants in the Plan held 336,455 and 254,913 shares, respectively, of common stock of B. Riley Financial Inc., the Plan sponsor, with a cost basis of \$8,644,552 and \$8,331,846, respectively, and a fair value of \$1,548,120 and \$5,354,420, respectively. Participants are not required to make investments in the common stock of B. Riley Financial Inc. Notes receivable

from participants also qualify as party-in-interest and related party transactions, which are exempt from the prohibited transaction rules.

Certain Plan investments during 2024 and 2023 were shares of mutual funds that were managed by Fidelity. Therefore, the transactions with Fidelity Investments are party-in-interest transactions, but these transactions are exempt by ERISA.

#### **Note 6 – Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### **Note 7 – Tax status**

The Plan is based upon a prototype plan drafted by Fidelity. The IRS has determined and notified Fidelity in a letter dated June 30, 2020, that the form of the prototype plan is acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024, the plan had two investments which exceeded 10% of total investments: Fidelity Growth Company Fund Class K - 19%, and Fidelity 500 Index Fund – 15.5%. At December 31, 2023, the plan had two investments which exceeded 10% of total investments: Fidelity Growth Company Fund Class K - 15.8%, and Fidelity 500 Index Fund – 14.7%.
