## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrators of

Hartford, Connecticut

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Whittlesey P.C. 401(k) Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### NOTE 1. PLAN DESCRIPTION

The following description of Whittlesey P.C. 401(k) Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of Whittlesey P.C. (the Employer or Company) who are at least 21 years of age and have completed six months of service. Entry date is the first day of the month coinciding with or next following date requirements are met.

The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). Additionally, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participant Accounts and Contributions:** Participants may elect to contribute to the Plan a specific percentage or dollar amount of compensation as elective deferrals and/or Roth elective deferrals. Total participant contributions are subject to annual limits under the IRC. The maximum participant deferral limit was \$23,000 and \$22,500 for calendar years 2024 and 2023, respectively. Catch-up contributions of \$7,500 for both calendar years 2024 and 2023 were available to participants who had attained age 50 or older during the calendar year, and had not exceeded the contribution limit for the Plan year.

The Company may make annual discretionary matching and/or profit sharing contributions to the Plan, which are to be allocated to participants employed on the last day of the Plan year who completed at least 1,000 hours of service in that year, on the basis of their relative compensation to the total compensation of all eligible participants. The Company made discretionary profit sharing contributions, net of forfeitures, of \$1,388,406 and \$1,317,307 to the Plan for the years ended December 31, 2024 and 2023, respectively.

**Participant Accounts:** Each participant's account is credited or charged with the participant's contributions, Company contributions, and an allocation of earnings or losses resulting from the participant's investments.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in Company discretionary matching and profit sharing contributions is subject to completion of at least 1,000 hours of service in a calendar year, and is based on years of continuous service. A participant is 20% vested after two years of service and continues to vest 20% per year thereafter. Participants are fully vested after six years of service.

Notwithstanding the above, if a participant dies or terminates employment by reason of permanent disability, the Company discretionary matching and profit sharing contributions amount becomes 100% vested without regard to years of service.

**Benefit Payments:** Distributions of a participant's account can be made upon termination of service, death, disability, or retirement. Distributions are made in a lump-sum payment unless a partial payment needs to be made in compliance with the minimum distribution requirements. Installment payments are allowed from assets held under Empower SecureFoundation contract. If a participant's vested account balance is \$5,000 or less, such balance will be automatically distributed without participant consent. An in-service distribution can also be made to participants who have attained the age of 59-1/2, upon disability or when experiencing financial hardship. Such withdrawals are subject to applicable excise and income taxes, and may only be made with the approval of the Plan Administrator.

### NOTE 1. PLAN DESCRIPTION (Continued)

**Administrative Expenses:** The Company incurs certain expenses in administering the Plan, which if not paid by the Plan are borne by the Company. Administrative expenses include investment advisory and contract administration fees and charges associated with investment transactions and benefit payments.

**Notes Receivable from Participants:** Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested balance. The notes receivable from participants are secured by the vested balance in the participant's account and bear interest at a rate of one percent above the Prime rate in effect at the time of loan origination. Principal and interest are paid ratably through payroll deductions not less frequently than quarterly over a term not to exceed five years, except notes receivable used to purchase the participant's primary residence, which may be permitted a longer term by the Plan Administrator.

**Forfeitures:** Forfeitures of terminated participants' unvested Company contributions may be used to reduce future Company contributions or administrative expenses. For the years ended December 31, 2024 and 2023, forfeitures of \$-0- and \$12,000, respectively, were applied to reduce Company contributions, and forfeitures of \$14,000 and \$13,500 for the years ended December 31, 2024 and 2023, respectively, were used for Plan expenses. Forfeitures of approximately \$30,000 and \$11,000 were available at December 31, 2024 and 2023, respectively, for future use.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The accompanying financial statements have been prepared using the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Valuation of Investments and Income Recognition:** Investments are reported at fair value except for the fully benefit-responsive investment contract in the guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Realized and unrealized appreciation is based on the market value of the assets at the end of the Plan year compared to the market value of the assets at the beginning of the Plan year, or at the time the assets were purchased or exchanged during the Plan year.

**Benefit Payments:** Benefits are recorded when paid.

**Subsequent Events:** Management has evaluated subsequent events for recognition and disclosure through September 18, 2025, which is the date the financial statements were available to be issued.

Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, investment transactions, investment income, notes receivable from participants, and the schedule of assets held at end of year have been derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (Empower), the custodian of the Plan, in accordance with Section 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **NOTE 4. GROUP ANNUITY CONTRACT**

The Plan has a group annuity contract with Empower. The group annuity contract, Key Guaranteed Portfolio Fund, is a fixed account that is part of the general account of Empower which is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest credit rate is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate (which will never be less than 0% as stated in the contract), and prevailing market conditions. Interest crediting rate is reset quarterly. The average yield earned by the Plan is derived by averaging the quarterly gross interest rates for the fund over the year. That average yield was 1.41% and 1.23%, respectively, for 2024 and 2023.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value.

Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

### NOTE 5. INCOME TAX STATUS

The Internal Revenue Service has informed the Plan, through the Volume Submitter program, by an opinion letter dated May 26, 2021, that the Plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

### NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### NOTE 7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are investment funds managed by Empower. Therefore, these transactions qualify as party-in-interest transactions.

### NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 9. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

- Level 1* Observable quoted prices in active markets for identical assets and liabilities.
- Level 2* Observable quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3* Model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.

### NOTE 9. FAIR VALUE MEASUREMENTS (Continued)

The following methods and assumptions were used to estimate the fair value of each class of assets that are recognized at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

*Mutual Funds:* Valued using quoted market prices, which represent the net assets value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
