Independent Auditors' Report

To the Pension Committee of
The Rehabilitation Center Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The Rehabilitation Center Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Rehabilitation Center Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years ending December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Rehabilitation Center Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Rehabilitation Center Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements (continued)

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of The Rehabilitation Center Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Rehabilitation Center Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF PLAN

The following description of The Rehabilitation Center Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The plan is a defined contribution plan established to provide retirement benefits for the employees of Cattaraugus Rehabilitation Center, Inc. (the Company). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company administers the Plan through the board approved Retirement Plan Committee.

The Plan has invested its assets with TIAA-CREF, Lincoln Financial Group (Lincoln) and Corebridge Financial (Corebridge). The portion of plan assets managed by Lincoln Financial Group is held by Lincoln Financial Group Trust Company. The remaining plan assets are managed and held by the Teachers Insurance and Annuity Association of America (TIAA), the College Retirement Equities Fund (CREF), and Corebridge Financial. The Retirement Plan Committee engages the services of OneDigital to assist with fiduciary responsibilities and compliance.

During 2023, management of the Plan approved a change of third party recordkeeper, asset manager and co-trustee, from Lincoln Financial Group to Corebridge Financial (Corebridge). The transfer of all assets except for the Lincoln Stable Value Fund (which were transferred April 23, 2024) to Corebridge occurred on December 4, 2023, with the first employee deferrals and matching employer contributions made to Corebridge with the December 14, 2023 payroll.

Eligibility

Employees become eligible to contribute to the plan and receive employer matching contributions at the conclusion of their three-month employment introductory period. Employees become eligible to receive employer discretionary contributions after attainment of age 21 and upon completing one year and 1,000 hours of service. Participation commences on the first day of the semi-annual plan entrance date, January 1st or July 1st, following attainment of eligibility requirements. Employees are not required to participate in the voluntary contribution to be eligible for the discretionary contribution, should there be one.

Contributions - Employer

On an annual basis the employer reviews the options of providing a discretionary contribution and/or employer matching contribution.

1. DESCRIPTION OF PLAN

Contributions - Employer

For the years ended December 31, 2024 and 2023, the Company made employer matching contributions in amounts equal to 100% of the first 2% of compensation that employees contributed to the Plan. These contributions totaled \$347,027 and \$277,385, respectively, for the years ended December 31, 2024 and 2023. If the Company opts to make a discretionary contribution, the amount of the contribution is approved by the Board of Directors and is recorded as a receivable in the year it is declared. No discretionary contributions were approved for the years ending December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the Company's contribution and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employer matching contributions and employee contributions, plus the earnings they generate, are always 100% vested. Participants are not vested in employer discretionary contributions until they have completed three years of service, at which time they will become 100% vested.

Administrative Expenses

The Company pays a portion of the administrative expenses of the Plan.

Notes Receivable from Participants

The Plan does not provide for participant loans.

Forfeitures

The forfeiture account balance can be used to offset plan expenses, the employer's matching contribution or the employer's discretionary contribution. At December 31, 2024 and 2023, forfeited nonvested accounts were \$-0-. Forfeitures used to offset plan expenses or employer contributions during the years ended December 31, 2024 and 2023 were \$-0-.

Automatic Rollover of Distributions

In the event of an involuntary distribution greater than \$1,000 but less than \$5,000 made in accordance with the provisions of the Plan, when a terminated participant does not request either a rollover or lump sum distribution timely, the Plan permits the plan administrator to pay the distribution in the form of a direct rollover into an individual retirement account as designated by the plan administrator.

1. DESCRIPTION OF PLAN

Payment of Benefits

Upon termination of services due to death, disability, or retirement, participants become fully vested in, and have a 100% nonforfeitable right to their account balances. Distributions are required to occur no later than April 1st of the calendar year following the calendar year in which the participant attains age 73. The normal retirement age is 65. Participants are also allowed to withdraw funds from their vested accounts if they meet criteria for financial hardship.

Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth by ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting and are in conformity with accounting principles generally accepted in the United States.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Investment Valuation and Income Recognition

All investments are participant directed. Before January 1, 2009, all employee and employer contributions to the Plan were invested with TIAA-CREF. After January 1, 2009, all contributions to the plan were invested with the Lincoln Financial Group. Effective December 14, 2023 all employee and employer contributions to the Plan are now invested with Corebridge.

TIAA Traditional Annuity

The Plan maintains investments in the TIAA Traditional Annuity account. The TIAA Traditional Annuity is a fixed annuity contract (see Note 6) that is fully and unconditionally guaranteed by Teachers Insurance and Annuity Association of America (TIAA), a New York domiciled non-profit legal reserve life insurance company. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but in some recent contracts between 1% and 3%), and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year”, which begins each March 1. Additional interest is not guaranteed for future years.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

TIAA Traditional Annuity

When the contract value accumulation of TIAA Traditional is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The TIAA Traditional Annuity is reported at contract value. The contract value of the TIAA Traditional Annuity equals the accumulated cash contributions, interest credited to the plan's contracts, and transfers, if any, less any withdrawals and transfers, if any. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable.

The Plan has provided no reserves against such contract value for credit risk of the contract issuer.

TIAA Real Estate Account

The TIAA Real Estate Account (REA) is an insurance company separate account of Teachers Insurance and Annuity Association of America (TIAA) investing mainly in real estate and real estate-related investments. The REA funds variable annuity contracts issued by TIAA.

The REA generally invests in real estate properties and real estate-related investments. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business. Although the underlying assets of the REA cannot be quickly sold and converted to liquid assets, the TIAA General Account provides the REA with a liquidity guarantee that it will have the funds available to meet participant redemption, transfer or cash withdrawal requests executed at quoted unit values.

CREF Accounts

College Retirement Equities Fund (CREF) is registered with the Securities and Exchange Commission under the Investment Company Act of 1940 as an open-end management investment company. It consists of eight investment portfolios: the Stock, Global Equities, Growth, Equity Index, Bond Market, Inflation-Linked Bond, Social Choice and Money Market Accounts (individually referred to as the "Account" or collectively referred to as the "Accounts"). The CREF accounts fund are mutual funds issued by CREF.

The Accounts invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

CREF Accounts

CREF Money Market Account holdings are generally valued at amortized cost. Each Account determines its unit value each day. Accumulation units in CREF Accounts are available for transactions at the closing accumulation unit value on any day the NYSE is open for business.

Lincoln

The Plan provides employees various investment options including stable value accounts and stock and bond based mutual funds. Participants can designate asset allocations by choosing a Lincoln LifeSpan allocation model or designing their own investment portfolio by choosing what percentage of contributions will be invested in each of the funds available in the plan.

If participants do not designate their investment choices, contributions will be invested in the appropriate LifeSpan model based on date of birth and the age closest to the employee's normal retirement age.

Stable Value Account

The Lincoln NY Stable Value Account is a group fixed annuity contract (see Note 6) that is fully benefit-responsive and is valued at the contract value.

Mutual Funds

The mutual funds held by Lincoln are stated at fair value.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of the basis for the fair value of the mutual funds.

Purchases and sales of the funds are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Corebridge

The Plan provides employees various investment options including stable value accounts and stock and bond based mutual funds. Participants can designate asset allocations by choosing an allocation model or designing their own investment portfolio by choosing what percentage of contributions will be invested in each of the funds available in the plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

Corebridge

Corebridge Fixed Interest Option

The Corebridge Fixed Interest Option is a group fixed annuity contract (see Note 6) that is fully benefit-responsive and is valued at the contract value.

Mutual Funds

The mutual funds held by Corebridge are stated at fair value.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of the basis for the fair value of the mutual funds.

Purchases and sales of the funds are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The plan invests in various investment securities and contracts. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in their values could occur in the near term and such changes could materially affect the participant's account balances and the amounts reported in the statements of net assets available for benefits.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Date of Management's Review

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

During the years ended December 31, 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$1,033,526 and \$808,036, respectively.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds held by CREF's variable annuities and by Lincoln is based on quoted net asset values of the shares held by the Plan at year-end, as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

The underlying mutual funds of the pooled separate account is traded in public markets and are valued at their adjusted unit values on the last business day of the fiscal year based on unadjusted quoted market prices within active markets.

4. FAIR VALUE MEASUREMENTS

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1, 2 and 3.

5. TAX STATUS

The Plan uses a prototype plan of Lincoln Financial Group which has been designed in accordance with the applicable section of the Internal Revenue Code (IRC). The prototype plan has been issued a tax determination letter. In addition the Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan administrator had analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. INVESTMENT CONTRACTS

Lincoln Financial Group

The Plan has entered into the Stable Value Account, a benefit-responsive group fixed annuity contract, with Lincoln Life & Annuity Company of New York (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the group fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the group fixed annuity contract. The contract is included in the financial statements at contract value as reported to the Plan by Lincoln. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

6. INVESTMENT CONTRACTS

Lincoln Financial Group

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed periodically for resetting.

The approximate average yields for the years ended December 31, 2024 and 2023 were .78% and 2.05%, respectively.

Corebridge

The Plan has entered into the Stable Value Account, a benefit-responsive group fixed annuity contract, with Corebridge Financial (Corebridge). Corebridge maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the group fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the group fixed annuity contract. The contract is included in the financial statements at contract value as reported to the Plan by Corebridge. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed periodically for resetting.

The approximate average yield for the year ended December 31, 2024 and 2023 were 2.79% and 2.85%, respectively.

TIAA-CREF

The Plan has also entered into a fixed annuity contract, benefit-responsive investment contract, with Teachers Insurance and Annuity Association of America (TIAA) and the College Retirement Equities Fund (CREF). TIAA-CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

6. INVESTMENT CONTRACTS

TIAA-CREF

As described in Note 2, because the fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the fixed annuity contract. The contract is included in the financial statements at contract value as reported to the Plan by TIAA-CREF. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The fixed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The approximate average yield for the years ended December 31, 2024 and 2023 was 4.61% and 4.85%, respectively.

Certain events limit the Plan's ability to transact at contract value with Lincoln, TIAA-CREF, or Corebridge. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.
