Opinion

Notes to the Financial Statements
For the Years Ended December 31, 2024 and 2023

NOTE A: DESCRIPTION OF THE PLAN

The following description of Mid-Continental Restoration Company, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is the retirement plan provided for employees of Mid-Continental Restoration Company, Inc. (“Organization”).

- 1) General - The Plan was established March 1, 1995, amended in April 2007, and October 31, 2012. The Plan is a defined contribution plan covering all full-time employees of the Organization who have worked sixty days and attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings.
- 2) Contributions - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to the maximum dollar limit for the year set forth by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization contributes 100% of employee contributions up to 1% and 50% of contributions for the next 5% of eligible compensation. Contributions are subject to certain IRS limitations. Roth contributions are allowed.
- 3) Participant Accounts - Each participant's account is credited with the participant's contributions and Organization matching contributions as stated in 2) above. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 4) Vesting - Participants are vested immediately in their contributions plus actual earning thereon. Vesting in the Organization's portion of their accounts is based on the number of years of service. The plans vesting schedule is as follows: Years of Service: 0-2 years = 0%, 2 years and beyond = 100%. Vesting is not continuous service; break-in-service rules are recognized.
- 5) Payment of Benefits - On termination of services due to death, disability, or retirement, a participant may elect to receive either a lump sum or rollover amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or rollover.
- 6) Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0.00 and \$0.12 respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$19,786.14 from forfeited nonvested accounts.

NOTE B: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are recorded at fair value, except for the stable value fund which is valued based on the Net Asset Value from the funds audit (contract value) and the pooled separate accounts which are valued based on their Net Asset Value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements and Note E for discussion of contract value measurements.

Purchases and Sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Third Party Administrator Duties

Organization contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation of the fair value of investments.

Payments of Benefits

Benefit payments are recorded when paid.

NOTE C: TAX STATUS

The Internal Revenue Service has determined and informed the plan sponsor by a letter dated December 23, 2013, that the Plan's prototype being used qualifies under Section 401(k) of the Internal Revenue Code and, therefore, the Plan is not subject to tax under present income tax laws. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts: Pooled Separate Accounts (PSAs) of the custodian invest in registered investment companies, which are invested in debt and equity securities of U.S. and foreign companies at various levels of market capitalization. Units held in PSAs are valued using the NAV of the fund. The NAV is based on fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund. Accordingly, the unit value for a collective investment fund is classified outside of the valuation hierarchy but are included below to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.

Mutual Funds – Valued at the closing price reported on the active market on which the individual securities are traded and are therefore classified as level 1 investments.

NOTE E: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

MetLife Reliance Trust Stable Value Class 25053 Fund with MetLife meets the fully benefit-responsive criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Upon termination of the investment contract, the lump sum liquidation value of the guaranteed account portion of the participant's accumulation value shall be equal to the product of (a) the participant's guaranteed account accumulation value of the liquidation date, reduced by the liquidation charge applicable on the liquidation date and (b) a market value adjustment percentage. There are no reserves against contract value for credit risk of the contract issuer or otherwise. This portion of the investment contract is included in the financial statements at contract value as reported to the Plan by Principal at \$1,772,320.35 and \$1,759,404.18 on December 31, 2024 and 2023, respectively.

Certain events limit the ability of the plan to transact at contract value with the issuers.

NOTE E: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)

Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the plan's prohibition on competing investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the plan's normal operations; (4) the failure of the plan to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA. The plan administrator believes that no events are probable to occur that might limit the ability of the plan to transact at contract value with the contract issuer, and that also would limit the ability of the plan to transact at contract value with the participants.

The guaranteed investment contract does not permit MetLife to terminate the agreement prior to the scheduled maturity date.

NOTE F: PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their Plan account.

NOTE G: RELATED PARTY/ PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of common collective trusts and pooled separate accounts managed by Principal Life Insurance Company. Principal is the Plan Administrator as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Other service providers include Jarred, Gilmore, and Phillips, PA, the plan auditor, Infintas, investment advisor, and Mid-Continental Restoration Company, Inc., the plan sponsor.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE H: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As of the date of this report, compliance testing with IRS and DOL requirements has not been completed by the Third Party administrator so the results of these tests are unknown. Of note, this was an issue in prior year as well, per review of Principal website, the test passed all tests in 2023.

NOTE I: SUBSEQUENT EVENTS

The Plan evaluated events and transactions occurring subsequent to December 31, 2024, through September 18, 2025, the date the financial statements were available to be issued. During this period, there were no subsequent events requiring recognition in the financial statements. Additionally, there were no nonrecognized subsequent events requiring disclosure.
