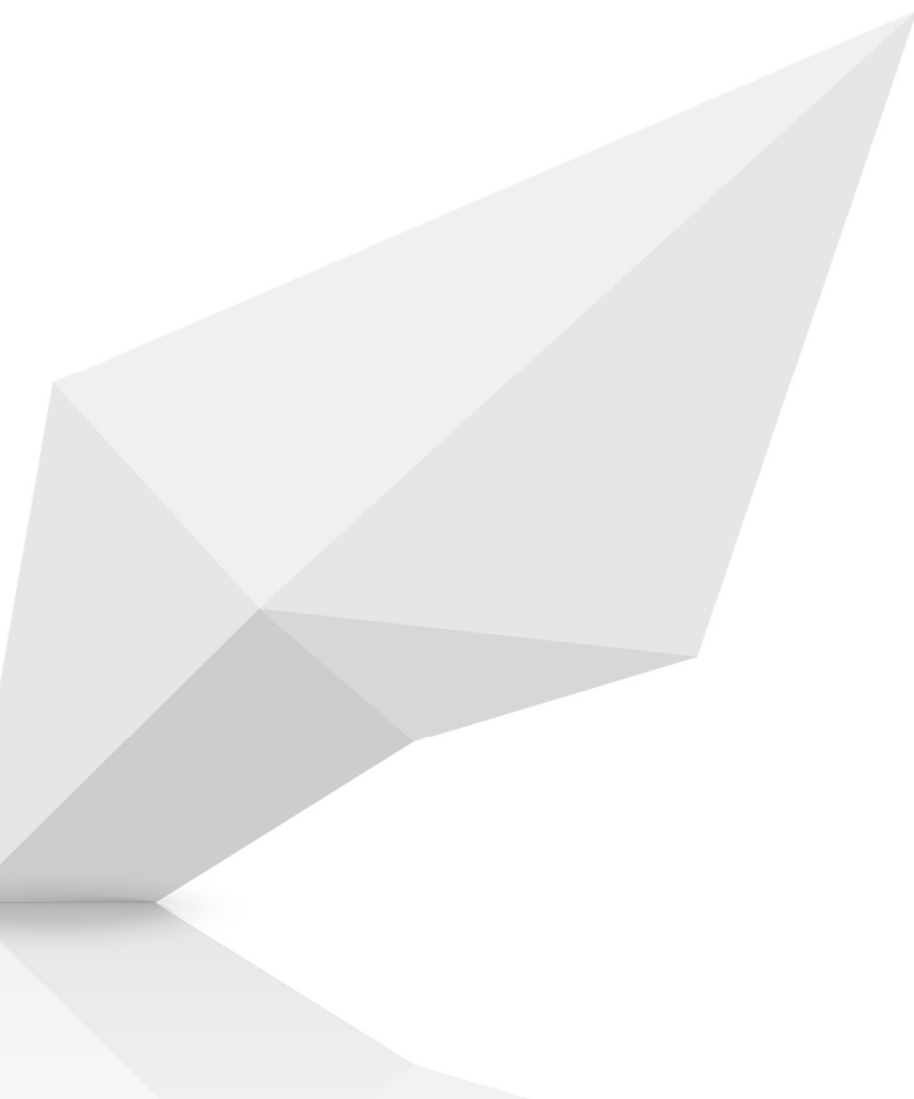

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Credit Control, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Credit Control, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1: Description of Plan

The following description of the Credit Control, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Credit Control, LLC (the Plan Sponsor or Employer) for the benefit of its employees who are not covered by a collective bargaining agreement. Employees who are at least 18 years of age and have completed one year of service, defined as 12 consecutive months of employment during which the employee has 1,000 hours of service, are eligible to contribute to the Plan and participate in the Employer match and profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Voya Financial is the custodian and Voya Retirement Insurance and Annuity Company is the recordkeeper of the Plan (collectively referred to as Voya).

Contributions

The Plan permits eligible employees, through a salary deferral election, to have the Plan Sponsor make annual contributions of up to 90% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Employer matching and profit-sharing contributions are discretionary as determined by the Plan Sponsor's Board of Directors. During 2024, the Plan Sponsor made matching contributions of 50% of employees' salary deferral amounts on the first 4% of employees' compensation. There were no profit-sharing contributions in 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Investment Account Options

Each participant has the option of directing his or her contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Plan Sponsor's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus the earnings thereon and are vested in employer contributions and the earnings thereon based on years of service, as defined. A participant is 20% vested after each year of service and is 100% vested at five years of service.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Notes Receivable From Participants

Participants may borrow a minimum of \$1,000 and up to 50% of their vested account balance; however, in no case shall the maximum loan amount be greater than \$50,000, minus the highest outstanding balance of loans in the past twelve months. The loans are secured by the balance in the participant's account. Participants may only have two loans outstanding at any given time. Interest on loans is based on local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions. The loan must be repaid, among other events, upon the participant's death, termination, distribution of account balance, or Plan termination.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a certain period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

Forfeited non-vested accounts may be used to pay Plan expenses or to reduce any employer contributions. During 2024, \$19,487 of forfeited non-vested amounts were used to pay for employer contributions. The forfeited non-vested account balance was zero at December 31, 2024 and 2023.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP, requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The custodian of the Plan determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the Plan year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Administrative expenses of the Plan are paid both by the Plan sponsor and the participants of the Plan. Certain expenses of maintaining the Plan are paid directly by the Plan's sponsor and are excluded from these financial statements. Brokerage commissions, transfer taxes, and other charges and expenses in connection with the purchase or sale of securities are charged against the trust fund and added to the cost of such securities or deducted from the sale proceeds, as the case may be. Participants are also charged check processing fees in certain circumstances.

Subsequent Events

The Plan has evaluated subsequent events through the date of September 8, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing Cash: Valued at cost plus accrued interest which approximates fair value.

Pooled Separate Accounts: The fair value of pooled separate accounts is based on the fair value of the underlying mutual funds held by the pooled separate accounts, as adjusted for earnings and certain expenses. Each pooled separate account holds shares of a single underlying fund, and although the underlying funds make distributions from time to time, the pooled separate accounts never make any distributions to unit holders. Distributions received from an underlying fund are reinvested into additional shares of the underlying fund and the reinvestment of such distributions results in the pooled separate account holding more fund shares, at a lower per share price, but the total dollar amount invested does not change. In addition, the pooled separate accounts levy administrative maintenance charges and can also include Cost of Class Funds. These are paid by each pooled separate account unit class by selling sufficient shares of respective underlying funds to pay the charges. These charges are levied daily at a class level for each pooled separate account, and therefore reduce the price per unit of each class of a pooled separate account from what it would be in the absence of these charges.

Note 5: Excess Contributions Payable

As a result of discrimination testing, excess contributions amounting to \$26,375 and \$6,708 were recorded as a liability in the accompanying Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, respectively, and as a deduction in the statement of changes in net assets available for benefits for the years then ended. The Plan reimbursed these excess contributions to its participants during the 2025 and 2024 plan years, respectively.

Note 6: Secure 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. In accordance with SECURE 2.0, the Plan increased the age for required minimum distributions (RMD) from age 72 to age 73, effective January 2023. Further changes set forth in the SECURE 2.0 Act include eliminating pre-death RMD rules for Roth accounts and several voluntary changes to distribution provisions, effective January 2024. The Plan is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 7: Tax Status

The Plan is designed to be a qualified trust under Section 401(a) of the Internal Revenue Code (IRC), which provides that a qualified trust is exempt from federal income taxes. The Plan is required to operate in accordance with the Plan agreement and the applicable federal laws in order to maintain its qualification. The prototype plan received a favorable opinion letter, dated June 30, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently being operated in accordance with the IRC. The Plan sponsor is not aware of any action or event that has occurred that might affect the Plan's qualified status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8: Related Party and Party In Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan Sponsor provides certain administrative services at no cost to the Plan.

Note 8: Related Party and Party In Interest Transactions (Continued)

Certain Plan investments were managed by Voya. Voya is the custodian as defined by the Plan, therefore, these transactions qualify as party in interest transactions. The Plan paid \$74,937 of record keeping fees to Voya during 2024.

Notes receivable from participants also qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

Note 9: Plan Termination

Although it has not expressed any intent to do so, Credit Control, LLC, the Plan's sponsor, has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 10: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
