**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the SEIU Local 1021 Retirement Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

**Opinion on the Financial Statements**

### **Basis for Opinion on the Financial Statements**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the Financial Statements.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

#### 1. DESCRIPTION OF PLAN AND SIGNIFICANT ACCOUNTING POLICIES

The following description of the SEIU Local 1021 Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and related Adoption Agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan originally established by SEIU Local 535 effective August 1, 2000, and was amended and restated as of March 1, 2007, concurrent with the formation of SEIU Local 1021, the Plan Administrator and successor Plan Sponsor. The Plan has also been subsequently amended and restated effective January 1, 2022 to conform to certain tax laws changes and most recently amended on August 1, 2022 to modify the definition of excluded employees, eligibility conditions and entry dates.

The Plan generally covers substantially all employees of SEIU Local 1021 that work greater than 1,000 hours during the year, except leased employees, temporary employees, reclassified employees, independent contractors and non-resident aliens of the United States with no U.S. source income from SEIU Local 1021. Eligible employees are generally entitled to participate in the salary deferral portion of the Plan upon hire. Prior to August 1, 2022, eligible participants were required to meet a two-year service requirement before receiving an allocation of employer contributions. Effective August 1, 2022, eligible participants are entitled to receive an allocation of employer contributions immediately upon participation. For the purposes of eligibility, past service is credited for former employees of SEIU Local Nos. 535, 614, 616, 707, 790, 949, 1280, 1292, and 4988 if employed at the time of the inception of SEIU Local 1021.

The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Basis of accounting*** – The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

***Administration*** - Under the terms of the Plan, Matrix Trust Company (“Matrix”) acts as custodian and Plan Trustee. Certain employees of SEIU Local 1021 serve on an Advisory Committee and work with RBC Wealth Management to provide education and investment advice to participants and to perform a review of the Plan and all funds on a quarterly basis (or more often if necessary). Based on advice of the Advisory Committee, SEIU Local 1021 has contracted with Milliman, Inc. to act as the Plan’s third-party administrator and with RBC Wealth Management to act as the registered investment advisor. The day-to-day administration of the Plan is handled by the SEIU Local 1021 human resources department. Administrative expenses may be paid by the Plan or by the Plan Administrator.

***Employee contributions*** - Participants may elect to contribute a designated dollar amount or a percentage of their pre-tax compensation to the Plan, up to 100% of pretax eligible compensation per payroll period, as defined in the Plan, up to the amount allowable under current income tax regulations. Participants who have attained age 50 may also elect to make an additional catch-up contribution up to the amount allowable under current income tax regulations. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants who elect to have SEIU Local 1021 contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation.

***Employer contributions*** - The Plan allows for discretionary employer qualified non-elective and matching contributions. Beginning in August 2022, the Plan Sponsor elected to make matching contributions of 2% of eligible compensation contributed by the participant, including unrepresented employees and employees represented under CWA Local 9404. During 2023, the Plan Sponsor elected to also make matching contributions of 2% of eligible compensation contributed by employees represented under CWA Local 9410 and OPEIU Local 29.

***Participant accounts*** - The participants' accounts are credited with participant contributions and allocations of employer contributions, if any, and Plan earnings. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account. Participants direct the investment of their account balances into various investment options offered under the Plan. Participant accounts are valued on a daily basis.

***Vesting*** - Participants are fully vested in their contributions and employer contributions, plus earnings thereon, at all times.

***Forfeitures*** - Forfeitures, if any, are used to reduce future employer contributions. As of December 31, 2024 and 2023 there were no unallocated forfeited amounts. No forfeitures were used to reduce employer contributions during the year ended December 31, 2024.

***Payment of benefits*** - Benefits are paid in either installments or a lump-sum amount equal to the value of the participant's vested account balance upon termination of service, death, disability or retirement. Additionally, under certain circumstances of financial hardship or upon attainment of age 59 ½, participants may be allowed to withdraw funds from the Plan while still employed by SEIU Local 1021.

Benefits are recorded on the accrual basis of accounting when all conditions for the payment of benefits have been met and approved by the Plan Administrator.

*Notes receivable from participants* - The Plan provides a provision which allows a participant to borrow up to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's vested balance and must be repaid through payroll deductions over a period generally not to exceed five years, except for the purchase of a principal residence, which may be repaid over a longer period, generally ten years. Such loans bear a reasonable rate of interest commensurate with market rates. The specific terms and conditions of such loans are established by the Plan Administrator.

*Investments* - Investments of the Plan are held by the Plan's custodian and are invested based solely upon instructions from participants.

The Plan's mutual fund investments are stated at fair value, as reported by the Plan's Trustee and custodian as determined by quoted market prices on an established exchange, which represent the net asset value of shares held by the Plan at year end.

The Plan's investment in a common collective trust is valued at fair value as reported by the Plan's Trustee and custodian. The common collective trust is credited with contributions made under the contract, plus earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

GAAP establishes a framework for measuring fair value and provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level one measurement) and the lowest priority to unobservable inputs (level three measurements). The three levels of the fair value hierarchy are described below:

Level one: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level two: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level two inputs must be observable for substantially the full term of the asset or liability.

Level three: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Investment income*** – Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost if acquired during the Plan year. In accordance with the Plan's policy of stating investments at fair value, net unrealized appreciation or depreciation is included in the statement of changes in net assets in the period in which the market change occurs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

***Excess contributions payable*** – Represents excess salary deferral contributions to be refunded to certain participants in order to satisfy the relevant non-discriminatory provisions of ERISA. Excess contributions payable totaled \$23,903 and \$21,572 as of December 31, 2024 and 2023, respectively.

*Use of estimates* – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

The financial statements include all subsequent events considered necessary for a fair presentation. Events or transactions occurring subsequent to year end through the date the financial statements were available to be issued, September 26, 2025, have been evaluated in the preparation of the accompanying financial statements.

#### **3. INCOME TAX STATUS**

The Plan adopted a non-standardized prototype plan that obtained a determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the aforementioned prototype adopted by the Plan Sponsor, as then designed, was in compliance with the applicable requirements and qualified under Section 401 of the Internal Revenue Code. The Plan has not filed for its own determination letter from the Internal Revenue Service and has been amended since the date of the aforementioned determination letter. However, the Plan Administrator and the Plan's advisors believe that the Plan is currently designed and being operated in material compliance with the applicable requirements of the Internal Revenue Code.

#### **4. PRIORITIES ON TERMINATION**

The Plan Sponsor intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to discontinue its contributions at any time for any reason and to terminate the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their employer contributions.

#### **5. RISKS AND UNCERTAINTIES**

The Plan provides for various investment securities (principally mutual funds and a common collective trust), which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As the Plan's investments are well diversified and issuers of the funds' underlying securities are dispersed throughout many industries and geographies, the concentrations of credit and other risk are limited.

#### **6. RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by the Plan's Trustee and custodian, or their affiliate. Therefore, investment transactions involving these investments qualify as party-in-interest transactions as defined by ERISA.
