### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Avivo 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 DESCRIPTION OF PLAN**

The following description of the Avivo 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established by Avivo (the Employer) originally effective January 1, 2003. The Plan was most recently restated effective January 1, 2022. The Plan covers substantially all employees of the Employer who have attained the age of 21 and completed six months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

On November 6, 2024, the Plan Sponsor entered into an agreement to terminate custodial services with Principal and transfer plan assets to the RetireReady 401(k) Plan. The Plan merger was effective as of December 15, 2024 and the date of plan liquidation was December 18, 2024.

**Contributions**

Participants must have completed six months of service before they are eligible to make salary reduction contributions. Participants may elect to make salary reduction contributions up to 100% of their compensation according to Plan provisions. The Plan includes an automatic deferral provision whereby 3% of annual compensation is automatically deducted and invested on behalf of new participants unless an alternative election is made. Participants covered by the automatic enrollment provisions will have their deferral increased automatically by 1% per year to a maximum deferral of 10%.

Participants age 50 or older are permitted to make catch-up contributions, subject to limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain limitations. Deferral contributions may be made on either a pre-tax (401(k)) or after-tax (Roth) basis.

The Employer remits a matched employee contribution in which the Employer will contribute an amount equal to 100% of the employee contribution that is not in excess of 1% of compensation, plus 50% of the employee contribution that exceeds 1% of compensation, not in excess of 6% of compensation. Effective August 12, 2024, the Employer match was suspended.

Additional discretionary contributions may be made at the discretion of the Employer's Board of Directors. In order to receive a discretionary annual contribution, a participant must have attained age 21, completed one year of service, completed 1,000 hours during the Plan year, and be employed on the last day of the Plan year unless termination is due to death, disability, or retirement. No discretionary contributions were made for 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocation of the Employer's contributions, and Plan earnings or losses. Allocations are based on participant account balances or participant compensation, as defined. Income is allocated daily based on the number of shares in the participant's account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Employer discretionary contributions is based on years of continuous service as follows:

Vesting in safe harbor matching contributions is based on years of service as follows:

Notwithstanding the above, participants shall, however, become 100% vested in their account upon attaining retirement age, their death, or disability.

**Benefit Payments**

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination, death, disability, or early or normal retirement, the participant may receive their vested account balance in the form of a lump sum or installment payments. If a participant terminates employment and the participant's account balance was never greater than \$5,000, the Plan administrator authorizes the benefit payment without the participant's consent. The Plan also allows hardship and in-service distributions subject to certain Plan provisions.

**Forfeitures**

Forfeitures are created when participants terminate before becoming entitled to their full benefits under the Plan. Forfeitures are used to reduce the Employer's future contributions to the Plan. Forfeited amounts of \$18,498 were used to reduce future Employer contributions to the Plan during the period January 1 through December 18, 2024. Forfeiture balance was \$5,533 as of December 31, 2023 (none at December 18, 2024).

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest at a fixed rate at prevailing market rates at the time the loan was processed. Principal and interest is paid ratably through payroll deductions. Notes receivable terms are up to five years, except for notes receivable to fund the purchase of a principal residence, for which the notes receivable may be repaid over a reasonable period that may exceed five years.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan governance determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

The Employer pays certain administrative expenses on behalf of the Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the custodian of the Plan, and Principal Life Insurance Company, the insurance company of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 18, 2024 and December 31, 2023 and the statement of changes in net assets available for benefits for the period January 1 through December 18, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

*Common Collective Fund:* Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*Pooled Separate Accounts:* Valued using the NAV of units, which are based on observable market prices for the underlying assets, held by the Plan at year-end. NAV is readily determinable fair value and is the basis for current transactions.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

As discussed in Note 1, the Plan Sponsor merged, effective December 15, 2024, into RetireReady 401(k) Plan. Contributions into the Plan ceased with the December 5, 2024 pay date.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Delaware Charter Guarantee and Trust Company dba: Principal Trust Company (an affiliate of Principal Financial Group) is the custodian and Principal Life Insurance Company is the insurance company of the Plan. Therefore, transactions with these entities represent party-in-interest transactions.

**NOTE 8 TAX STATUS**

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
