Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements

Note 1. Description of Plan - The following description of the Unispace 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a participant-directed, defined contribution plan covering substantially all eligible employees of Unispace, Inc. (the "Company"). The original effective date of the Plan is January 1, 2014. Office Link Design LLC 401(k) Profit Sharing Plan and Trust was merged into the Unispace 401(k) Plan as of September 1, 2017. Employees must be age eighteen or older and complete 3 months of service for participation in the employee elective deferral contributions of the Plan. Effective January 1, 2018, the Plan initiated automatic enrollment for eligible participants equal to 3% of employee's compensation. Participants who are eligible to make salary deferrals to the Plan are eligible for safe harbor contributions. Safe harbor contributions equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% to 5%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may make pre-tax or post-tax contributions from their annual compensation, up to amounts permissible under ERISA and the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible participants may defer up to 100% of their annual compensation, as defined in the Plan, as a qualified contribution subject to maximum annual dollar contribution restrictions of ERISA and the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participants direct their allocation of investments to funds managed by the trustee of the Plan, Charles Schwab Bank.

Vesting - Participants are immediately vested in their contributions, plus actual earnings thereon, and all safe harbor and profit sharing contributions.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to keep vested contributions in excess of \$5,000 in the Plan, or receive a lump-sum amount or various installment packages. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Vested amounts less than \$5,000 are paid per participant instruction or IRS regulations when participant instructions are not received.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Cash - Noninterest Bearing - Noninterest bearing cash includes time deposits and all highly liquid debt instruments with original maturities of three months or less. The Plan maintains cash - noninterest bearing at financial institutions which periodically may exceed federally insured limits. At December 31, 2024 and 2023 the Plan had no amounts in excess of federally insured limits.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Claims Payable - Certain claims that had been processed and approved for payment, but not yet paid at December 31, 2023 total \$248,614. The payable was paid in full during 2024.

Payments of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through the date of the report which is the date these financial statements were available to be issued.

Note 3. Information Prepared and Certified by the Trustee (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Bank (the trustee of the Plan).

Note 4. Party-in-Interest Transactions

Certain plan investments are managed by the plan trustee, Charles Schwab Bank. As of December 31, 2024 and 2023, Charles Schwab Bank is the trustee as defined by the Plan and, therefore, certain transactions qualify as allowable party-in-interest transactions. Fees paid by the Plan for investment and administrative services amounted to \$104,074 for the year ended December 31, 2024.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value:

Stable Value Funds - Valued at the daily closing price as reported by the fund and are invested in fixed income securities portfolios. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The stable value funds held by the Plan are deemed to be actively traded (Level 1).

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

The Internal Revenue Service (IRS) has determined and informed the plan sponsor by a letter dated April 1, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since applying for the advisory opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions and the Department of Labor; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
