### 1. Description of Plan

The following description of the Pro\*Act, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective January 1, 1992 by Pro\*Act, LLC (Plan Sponsor) and was subsequently adopted by participating employers (collectively, the Company). The Plan is a defined contribution plan covering certain employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Trustee and Administration of the Plan*

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Trustee or Principal) is the Trustee and provides recordkeeping and other administrative services. The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with provisions of the service provider contract with the Company. All assets of the Plan are in investment accounts at Principal.

#### *Eligibility*

Employees of the Company that have attained age 21 are considered eligible for participation immediately upon hire, except for independent contractors. Employees are eligible to commence contributions to the Plan the first of the month after meeting eligibility requirements.

#### *Contributions*

Participants are eligible to contribute on a pre-tax or Roth after-tax basis up to 90% of their annual compensation, subject to the limits of Internal Revenue Code (IRC) Section 402(g). In addition, participants are allowed to make catch-up contributions if they will be at least age 50 by the end of that year, subject to IRC limits. Rollover contributions from other qualified plans are permitted if certain criteria are met. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes Safe Harbor matching contributions to the Plan equal to 100% of participant's salary deferrals that do not exceed 3% of participant's compensation, plus 50% of participant's salary deferrals that are over 3%, but not over 5% of the participant's compensation each pay period. This Safe Harbor matching contribution is 100% vested.

Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations. The Company did not make a profit-sharing contribution for the year ended December 31, 2024.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, employer contributions, as well as an allocation of earnings or losses on investments and charged with certain expenses.

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are 100% vested in their pre-tax elective deferrals, Roth elective deferrals, rollovers, Safe Harbor employer contributions, and the allocated earnings thereon.

The vested portion of employer non-elective contributions and earnings made to the Plan are calculated based on the following vesting schedule:

Participants become fully vested in the event of retirement, death, or disability, as defined by the Plan.

### ***Payment of Benefits***

On termination of service due to death, disability or retirement, or other reasons, the participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

When an active participant reaches age 59½ and continues to work for the Company, the participant is eligible to receive a partial or full distribution of their account. The Plan also allows distributions to active participants for financial hardships, if certain criteria are met.

### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest commensurate with the local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions, and loan terms will not exceed five years. Two loans may be granted in any one-year period, but only one loan may be outstanding at a time.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$488, respectively. These accounts are first used to pay administrative expenses and any remaining forfeitures are used to reduce nonelective contributions or to reduce matching contributions. In 2024, forfeited non-vested accounts paid expenses of \$20 and funded employer contributions of \$463.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value except for full benefit-responsive investment contracts, which are at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

#### *Contributions and Contributions Receivable*

Participant contributions and any related employer Safe Harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation and depreciation in fair value of investments.

### 3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified that the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) as complete and accurate:

- Investments and notes receivable from participants, as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest earned on notes receivable from participants, as reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts included in the notes to financial statements.
- All investment information included in the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

### 4. Fair Value Measurements

The framework for measuring fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

*Level 1* - This level consists of quoted prices in active markets for identical assets and liabilities.

*Level 2* - This level consists of quoted prices in active markets for similar assets and liabilities, quoted prices for identical or similar instruments in markets that are not active, and model-derived valuations whose inputs are observable or whose significant value drivers are observable.

*Level 3* - This level consists of significant inputs to the valuation model that are unobservable.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the net asset value of shares held by the Plan at year-end.

*Self-Directed Brokerage Accounts* - These accounts comprise common stock, trusts, and cash and cash equivalents. The individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Group Annuity Contract with Principal Life Insurance Company

In 2023, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% or greater than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a

significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### **6. Related Party and Party-in-Interest Transactions**

The fully benefit-responsive guaranteed investment contract is managed by Principal, which is also the Trustee as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan paid \$11,049 of administrative fees to Principal. In addition, the notes receivable from participants qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules.

### **7. Plan Termination**

Although, it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time. Upon termination, all amounts credited to participant accounts will be 100% vested.

### **8. Tax Status**

The Plan adopted a pre-approved profit-sharing plan document. The sponsor of the document received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 indicating that the document is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan, as amended and restated, is currently designed and operated in compliance with the applicable requirements of the IRS. No provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. There are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### 10. Delinquent Participant Contributions

During the Plan year ended December 31, 2024, participant contributions totaling \$37 were not remitted to the Plan within the period prescribed by Department of Labor regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The related lost earnings were remitted to the Plan in 2025.

### 11. Operational Defect

During the year ended December 31, 2024, it was discovered that certain Plan provisions were not properly applied in the daily operation of the Plan. The Plan requires an annual true-up contribution for the Safe Harbor matching contributions, which was not performed for the years ended December 31, 2024 and 2023. The Plan administrator is determining the affected participants and will remit any required contributions into the Plan as soon as possible to make the affected participants and the Plan whole, including interest. The estimated true-up contribution will be recorded in the financial statements in the period the contribution is remitted to the Plan.
