Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following brief description of the Doosan 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

On January 4, 2024, the Doosan Industrial Vehicle Corp. 401(k) Plan merged into the Plan. This merger is reflected in the statement of changes in net assets for the year ended December 31, 2024.

Fidelity Management Trust Company (“Fidelity”) is the trustee of the Plan and the Plan’s assets are part of the Doosan Master Trust (“Master Trust”) maintained by Fidelity. Fidelity Workplace Services, LLC serves as the recordkeeper of the Plan.

The Benefits Oversight Committee of Doosan Bobcat North America (the “Committee”) administers the Plan on behalf of the plan sponsors Doosan Bobcat North America and Doosan Digital Innovation America, LLC (collectively, the “Companies”). The Committee designs and approves changes to the Plan. The Committee selects and approves the Plan’s investment options. Participants direct investments among the primary investment options. The Plan is intended and operated to satisfy the requirements of ERISA Section 404(c).

Participation

All individuals who are non-union, and also not temporary or seasonal employees, employed by either of the Companies or a participating subsidiary are eligible to participate in the Plan immediately upon hire, as defined in the Plan. Additionally, individuals covered by a collective bargaining agreement in Bismarck, ND or Rogers, MN and otherwise satisfy eligibility requirements are eligible to participate. Seasonal and temporary employees are not eligible to participate except as provided by law.

Contributions

For those employees who are eligible to participate in the Plan, there is automatic enrollment whereby a new employee is automatically enrolled in the Plan upon date of hire with a 3% pre-tax contribution that is invested in a default investment defined by the Plan. The employee then has a period of approximately 30 days to elect to not contribute to the Plan or to change his or her contribution percentage and investment options within the Plan. Payroll deductions, consequently, do not begin until such period has expired. Each year, participants may contribute up to 50% (in whole percentages) of their compensation, as defined in the Plan and subject to limits under the U.S. Internal Revenue Code of 1986, as amended (“IRC”). Participants may use before or after-tax dollars for part or all of their elective contributions. Participants also may rollover to the Plan amounts representing distributions from other eligible retirement plans, as defined by the Plan.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions are subject to various limitations to ensure compliance with the requirements of the IRC. Participants may change their contribution amounts in accordance with the administrative procedures established by the Committee.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers money market funds, collective trust funds, self-directed brokerage accounts, and various mutual funds through the Doosan Master Trust.

The Companies contribute to the Plan via a matching contribution. The Companies' match is 100% of participants' contributions up to 6% of eligible wages. The Companies' matching contribution is contributed in cash. The cash is immediately invested in the same manner as the participant contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Companies' contributions and plan earnings, and charged with distributions, applicable administrative expenses and allocations of plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit which a participant is entitled to receive is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in 100% of all contributions plus earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest established in accordance with specific written procedures adopted from time to time by the Committee. The rate of interest is fixed for the life of the loan. Principal and interest is paid ratably through payroll deductions. The repayment period is no more than five years.

Payment of Administrative Costs

Administrative charges are based on a flat rate per participant of \$69 per year for 2023 and through March 31, 2024. Effective April 1, 2024, the rate decreases to \$59 per participant per year.

Payment of Benefits

Upon termination of employment, retirement, disability, death, or attainment of age 72, distributions of participant account balances may occur. Plan distributions may be in the form of a lump sum or in such other manner that the Plan may permit. In addition, plan participants who terminate employment may elect distributions of at least \$500 on a daily basis up to the balance in the account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments in Master Trust

Plan investments are part of the Master Trust, which provides unified investment management. Fidelity invests plan assets in various trust investment options at the direction of Plan participants and as required

by the Plan. Separate participant accounts are maintained by investment option. These accounts record contributions, withdrawals, transfers, earnings and changes in market value. The Master Trust reports investments at fair value. See Note 5 for further discussion on fair value.

Investment Valuation

Investments in the Plan and Master Trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Security Transactions and Investment Income

Realized gains or losses on security transactions are recorded on the trade date. Net appreciation in Note 5 includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividend income is recorded on the ex-dividend date and interest income is recorded when earned.

The Statement of Changes in Net Assets Available for Benefits present interest in investment income of the Master Trust, which includes dividend and interest income, in accordance with the policy of stating investments at fair value.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Distributions are recorded in the Plan's financial statements when paid.

Administrative Expenses

Certain expenses of maintaining the plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other participant-initiated transactions as well as for recordkeeping expenses are charged directly to the participant's accounts and are included in administrative expenses. Certain investment related expenses are netted in the fair value of investments at the master trust level.

3. Investment in the Doosan Master Trust

The Plan's investments are in the Master Trust which was established for the investment of assets of the Plan and two other defined contribution plans of Clark Equipment Company. The assets of the Master Trust are held by Fidelity. Each participating retirement plan has a divided interest in the Master Trust. Fidelity maintains separate accounting of all contributions, benefit payments and expenses and allocates income earned and received or losses incurred by the Master Trust on the basis of the adjusted value of each plan at year end.

The following investments in the Master Trust and the net appreciation in fair value of investments, and interest and dividend income in the Master Trust are certified by Fidelity to be complete and accurate. Fidelity has also certified the Plan's proportionate share of such items to be complete and accurate.

5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 *Fair Value Measurement* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

At December 31, 2024 and 2023, all of the Plan's assets are held in the Master Trust. The investments in the Master Trust are recorded at fair value. The investments in the Master Trust are further discussed in Note 3.

Following is a description of the valuation methodologies used for the underlying assets in the Master Trust measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and common stock (held within the self-directed brokerage account): Valued at the net asset value ("NAV") of shares held by the Trust at year end, as determined by the administrator of the fund.

Money market funds: Funds invest in high quality, short-term securities that are quoted in an active market. The fund manager has assigned a unit price of \$1.

Collective trust funds: Valued at NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount difference from the reported net asset value.

5. Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Master Trust believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of the Plan, ERISA and the IRC.

7. Risks and Uncertainties

Through the Master Trust, the Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

8. Party-in-Interest Transactions

As of December 31, 2024 and 2023, certain plan investments held in the Master Trust are shares of mutual funds, and other investments managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions but are not deemed to be prohibited transactions. During the year ended December 31, 2024, fees were paid to the Plan's recordkeeper for participant transactions as such these expenses qualify as party-in-interest transactions but are not deemed to be prohibited transactions.

9. Tax Status

The Internal Revenue Service has determined, as stated in a letter dated March 30, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Therefore, the plan administrator believes the Plan was qualified and the related master trust was tax-exempt as of December 31, 2024 and 2023.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that is more likely than not to be sustained upon examination by the IRS. The Plan is subject to audit by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

10. Subsequent Events

Management has evaluated subsequent events through May 6, 2025 which is the date the financial statements were available to be issued.
