Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of J-M Farms Employees' 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

The Plan is a defined contribution plan covering all employees of J-M Farms, LLC, J-M Foods, LLC, Jurgensmeyer Mushroom Company, LLC, Fresh Solutions, LLC, Engelbrecht Farms, LLC and Quality Mushroom, LLC, (collectively the Company) who have at least one year of service, work at least 1,000 hours and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may make contributions through elective deferrals based on their annual compensation before bonuses, commissions and overtime. Employees may elect to defer up to 25% of any bonus. Employee deferrals are limited to the maximum allowable by Internal Revenue Service regulations related to defined contribution plans. Participants who have reached age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Employees have the option of making pre-tax deferrals or after-tax (Roth) deferrals. Participants direct the investment of their contributions as well as the Company's contribution into various investment options offered by the Plan.

The Plan has a provision whereby the Company may elect, at their discretion, to make a matching contribution and/or a profit-sharing contribution.

Participant Investment Account Options

Investment account options available include various funds at Charles Schwab. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation at their discretion.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, if any; and plan earnings, and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions plus earnings thereon. Vesting of the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. An employee is fully vested after six years of continuous service, as detailed in the following vesting schedule:

The nonvested portion of participants' account balances, which is forfeited upon termination prior to retirement, death, or becoming fully vested, is used to offset employer contributions made by the Company.

Payment of Benefits

If a participant ceases to be an employee of the Company and their vested balance is \$5,000 or more, the employee can choose from one of several distribution options. However, if a participant ceases to be an employee of the Company for any reason and their vested account balance is less than \$5,000, the Plan may elect to make a mandatory distribution.

On termination of service a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan uses the accrual method of accounting. Accordingly, revenues are recognized when earned and expenses when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America may require management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Tax Status

The prototype plan, under which the Plan operates, obtained its latest determination letter dated August 7, 2001, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter and continues to operate in compliance with IRC 401(a). The Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan was qualified and was tax-exempt as of the financial statement date.

Subsequent Events

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Furthermore, although the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure fair value of certain financial instruments could result in a different fair value at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

The fair values of common stocks, certain corporate bonds, and U.S. government securities are based on the closing price reported in the active market where the individual securities are traded, when available.

Level 2 Fair Value Measurements

Inputs to this valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in financial markets; inputs other than quoted prices that are observable for the asset(s); and inputs that are derived principally from (or corroborated by) observable market data by correlation or other means. If the asset has a term associated with it, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are not observable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

U.S. government securities: Valued using pricing models maximizing the use of observable inputs for similar securities.

NOTE 6: TRANSACTIONS WITH PARTIES-IN-INTEREST

During the years ended December 31, 2024 and 2023, the Company paid for certain legal, accounting, and other services related to the Plan which are not reflected in the financial statements. Additionally, all of the Plan's investments were held by Charles Schwab for the years ended December 31, 2024 and 2023, which represents a party-in-interest under ERISA.

NOTE 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions to the Plan at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested.

NOTE 8: DISTRIBUTION OF FORFEITURES

Forfeitures result from the non-vested portion of participant distributions and occur when an employee terminates before they are fully vested. Non-vested forfeitures are used to supplement any employer contributions. The balance of non-vested forfeitures was \$0 and \$2,121 at December 31, 2024 and 2023 respectively.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the participants account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10: UNCERTAIN TAX POSITIONS

The Plan's Form 5500 filings are subject to possible examination by the taxing authorities until the expiration of the related statute of limitations on those returns. In general, each return has a three-year statute of limitations. The Plan's management is not aware of any other uncertain tax positions.
