Management, having determined it is permissible in the circumstances, has elected to have the audits of IAPP 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 8 to the financial statements, is complete and accurate.

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the IAPP 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees of International Association of Privacy Professionals (the Company) who have been employed for three consecutive months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 100% of their eligible compensation, as defined in the Plan, up to the maximum limit set by the Internal Revenue Service (IRS) on a pre-tax or after-tax basis. Upon becoming eligible, all employees are automatically enrolled into the Plan with a 5% contribution rate of pre-tax compensation and funds are directed into whichever qualified default investment alternative (QDIA) most closely aligns with the expected retirement year unless directed otherwise by the participant. Participants' contribution rates are automatically increased annually by 1%, up to 10%, unless they affirmatively elect otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). The participants designate the allocation of their contributions among the available investment options offered by the Plan.

Per the Plan's safe harbor provision, the company contributes 100% of the first 3% and 50% of the following 2% of base compensation that a participant contributes to the Plan. The Company may also make a discretionary profit sharing contribution on behalf of eligible participants who were employed on the last day of the Plan year. Contributions are subject to certain IRS limitations. Profit sharing contributions are allocated to participants in a pro rata formula according to each qualifying participants' compensation. The Company made no profit sharing contributions in 2024.

Participant accounts - Each participant's account is credited with the participant's contributions, the employer's contributions, and an allocation of the Plan's earnings. The Plan's earnings are allocated according to participants' relative account balances.

Vesting - Participants are immediately vested in their voluntary contributions and employer matching contributions, plus earnings thereon. Vesting of employer profit sharing contributions and related earnings is based on years of continuous service and occurs 20% per year, becoming 100% vested after five years of credited service.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. No more than 1 loan can be outstanding at any one time. The loan must bear a reasonable rate of interest and be secured by the balance in the borrower's account. Principal and interest is paid ratably through payroll deductions.

## NOTES TO FINANCIAL STATEMENTS, CONTINUED

1. DESCRIPTION OF PLAN, CONTINUED

Payment of benefits - On termination of employment, disability, death, or normal retirement age, a participant may elect from a variety of options to receive benefit payments. In certain hardship situations, as described in the Plan document, participants may withdraw part of their account balance while actively employed. Such withdrawals are limited to the amount dictated by the hardship, and are limited to certain portions of participant accounts, as defined in the Plan agreement.

Forfeited accounts - Forfeited nonvested accounts totaled \$1,654 and \$689 at December 31, 2024 and 2023, respectively. Forfeitures may be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the Plan document .

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting and presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurements date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Benefit payments - Benefit payments are recorded when paid.

## NOTES TO FINANCIAL STATEMENTS, CONTINUED

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Uncertain tax positions - U.S. GAAP prescribes a comprehensive model for how an organization should measure, recognize, present, and disclose in its financial statements uncertain tax positions that the organization has taken or expects to take on a tax return. Accordingly, the Plan recognizes the tax benefits from uncertain tax positions if it is more likely than not that the tax position will be sustained on examination by the taxing authorities, based on the technical merits of the position.

Subsequent events - The Plan has evaluated events, if any, that have occurred subsequent to December 31, 2024, through September 25, 2025, the date the financial statements were available to be issued, and included information in the notes to the financial statements related to any identifiable events, if necessary.

3. FAIR VALUE MEASUREMENTS

U.S. GAAP provides the framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## NOTES TO FINANCIAL STATEMENTS, CONTINUED

3. FAIR VALUE MEASUREMENTS, CONTINUED

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Money market funds are valued at cost plus accrued interest which approximates fair value.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Vanguard, the recordkeeper, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments. In addition, loans to participants qualify as party-in-interest transactions.

5. PLAN TERMINATION

Although it has not expressed an intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants become 100% vested in the company contribution portion of their accounts.

6. INCOME TAX STATUS

The Plan is a non-standardized pre-approved plan of Ascensus, LLC which received an opinion letter dated June 30, 2020, in which the IRS stated that the form of the Plan is acceptable under the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. CERTIFIED INVESTMENTS

Certified information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable held at December 31, 2024 and 2023, and the net appreciation (depreciation) in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company (the trustee of the Plan).
