Opinion

Note 1. Description of the Plan

The following description of the L & H Company, Inc. Employee Stock Ownership Plan and Trust (Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

General

L & H Company, Inc. and its subsidiaries, Meade Electric Company, Inc. and Traffic Control Corporation (collectively, the Company), established the Plan effective as of January 1, 1999. The Plan operates as a leveraged employee stock ownership plan (ESOP). It is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended, and is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. The Plan is administered by an L & H Company, Inc. committee comprising one or more members appointed by the Board of Directors of the Company. The members of the committee serve as the Plan's trustees.

The Company has established the Plan for investment purposes benefitting eligible employees of the Company.

In 1999, the Plan purchased 76,532 shares of L & H Company, Inc. Class B common shares from the Company. This purchase was financed using proceeds of a term loan made to the Plan by the Company. Shares of the Plan are held in a trust established by the Plan. The term loan was repaid during 2013 by fully deductible Company contributions to the trust and dividends earned by the shares in the trust. As the Plan made each payment of principal, an appropriate percentage of stock was allocated to eligible employee accounts in accordance with the Internal Revenue Code (IRC).

Eligibility

Full-time or part-time employees who have completed at least one year of consecutive eligibility service, worked 1,000 hours during the plan year, are employed on the last day of the plan year with the Company and have attained age 21, except employees covered by a collective bargaining agreement as defined in the Plan, are eligible to participate. Participants who have not completed one consecutive year of eligibility service on or before the last working day of the plan year are not eligible for an allocation of Company contributions for such year.

Vesting

Participants who leave the Plan because of death, disability or normal retirement, as defined in the Plan, are considered 100% vested. The portion of the participants' accounts attributable to the Company's contributions becomes vested based on years of service. A participant is 100% vested after six years of credited service.

Contributions

The Company is obligated to make contributions in cash, Company stock or dividends to the Plan, which equals the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. No obligations remain as the term loan was paid off in 2013.

Participant Accounts

An investment account is maintained for each participant. The annual allocation of the Company's contributions and forfeitures is credited to each participant's investment account as of the last day of each plan year and is based on a formula which considers annual eligible compensation levels, as defined by the Plan. Dividends are allocated based upon the number of shares held by the participant on the date of dividend declaration.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, includes a put option. Under certain plan provisions, the put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversifications

A qualified participant who has completed 10 years of service and has attained the age of 45 may diversify up to 25% of his or her allocated shares of Company stock into a participant-directed account. When an employee attains the age of 55 and has completed 10 years of service, he or she may diversify up to 50% of his or her allocated shares of Company stock into a participant-directed account. The participant-directed diversified account is held in the Company's 401(k) plan. Upon completion of a participant-directed diversified balance transfer, the diversified balances are no longer considered plan assets and are treated as a qualified rollover into the participant's 401(k) account.

Forfeited Accounts

Forfeitures are allocated among the accounts of participants in the same proportion that each participant's annual compensation for the plan year bears to the total compensation of all participants for such year. Only participants who have completed a year of service during the plan year and are actively employed on the last day of the plan year are eligible to share in the allocation. There were no forfeitures of terminated nonvested account balances allocated to remaining participants during 2024. As of December 31, 2024 and 2023, there were no forfeited, nonvested accounts.

Participant Loans

The Plan does not allow participant loans.

Voting Rights

All Company stock held in the trust is generally voted by the trustees at the direction of the committee. However, for corporate matters with respect to the approval or disapproval of any corporate merger, consideration, recapitalization, reclassification, liquidation, dissolution or sale of substantially all of the assets of trade or business, the trustee will vote at the direction of the participants.

Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the Plan's benefits of a participant who remains an employee of the Company shall be retained in the trust until after the participant's termination of employment with the Company.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Company's common stock is valued at fair value as determined by annual independent appraisals. The fair value of the common stock was \$983.67 and \$759.90 per share at December 31, 2024 and 2023, respectively.

Net appreciation of investments included in the accompanying statement of changes in net assets available for benefits includes unrealized appreciation in fair value of the investments. Net unrealized appreciation in the fair value of investments represents the net change in the fair value of the investments held during the period.

The total investment in the Company's common stock by the Plan represents approximately 16.6% of the Company's outstanding common stock at December 31, 2024, and 17.1% of the Company's outstanding common stock at December 31, 2023.

Investments, in general, are subject to various risk, including credit, interest rate and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses not paid by the Plan are paid directly by the Company.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the L & H Company, Inc. Class B shares is valued at estimated fair value based upon an independent appraisal. Three valuation methods were employed by the independent appraiser in valuing the stock: the Guideline Company Method, the Capitalized Cash Flow Method and the Capitalized Future Cash Flow Method. Consistent with the prior year, the independent appraiser valued the stock using the Capitalized Cash Flow Method as of December 31, 2024 and 2023.

Note 5. Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated September 22, 2000, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Party-in-Interest Transactions

The plan investments are Class B common shares of the Company and, therefore, qualify as party-in-interest items. These transactions are not considered prohibited transactions under 29 CFR 408(b) or the ERISA regulations.

Note 7. Subsequent Events

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
