## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Heath Ceramics, Ltd. 401(k) Plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Heath Ceramics, Ltd. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from Reliance Trust Company (Reliance Trust), the trustee of the Heath Ceramics, Ltd. 401(k) Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information as described in Note 7 to the financial statements is complete and accurate.

### Opinion

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Heath Ceramics, Ltd. 401(k) Plan (the Plan) provides only general information. Participants and others should refer to the plan document or summary plan description for a more complete description of the Plan's provisions.

**General:** Heath Ceramics, Ltd. (the Plan Sponsor) established the Plan on January 1, 2005. The Plan is a defined contribution profit sharing plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee is responsible for oversight of the Plan. Reliance Trust Company (Reliance Trust) serves as the trustee of the Plan.

In October 2020, the Plan was amended with respect to how employer contributions will be calculated effective January 1, 2021. This amendment (a) eliminated Employer Qualified Safe Harbor Contributions (QACA) and changed the related vesting schedule, (b) converted automatic employee deferrals to Eligible Automatic Contribution Arrangement (EACA), (c) changed the profit sharing contribution formula to tiered based on years of service and (d) changed the employer nonelective profit sharing contributions to be immediately and fully vested when received.

Effective April 1, 2021, the Plan was amended with respect to how employer contributions will be determined, annual conditions for employer profit sharing contributions, age requirements for normal and early retirement, and union employees' eligibility to participate in the Plan.

Effective May 24, 2021, the Plan was amended to merge the Supplemental Income 401(k) Plan (Heath Ceramics Union Employees) into the Plan.

**Eligibility:** The Plan covers all employees of the Plan Sponsor except for part-time, temporary and seasonal employees who have not met plan requirements and certain non-resident aliens. Participants who are not employed on the last working day of the plan year are generally not eligible for an allocation of company contributions for such year.

**Contributions:** Participants may make voluntary elective deferral contributions subject to prescribed limitations as well as rollover contributions from a qualified plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. A participant may enter a salary deferral agreement at any time to select an alternative deferral amount or to elect not to defer in the Plan. The Plan includes an EACA. Under the EACA, if an eligible participant does not complete a salary deferral agreement, the Plan Sponsor will automatically withhold 3% of compensation and contribute that amount to the Plan as a salary deferral, increasing every year after two years of participation by 1% with a maximum deferral of 10%.

Each year, the Plan Sponsor may also contribute discretionary amounts to the Plan as determined by the Board of Directors. These discretionary amounts may be comprised of an employer matching contribution (a designated percentage of a participant's elective contribution) and/or a discretionary employer profit sharing contribution based on the participant's years of service. An employee must have completed at least one year of service during the plan year and be employed with the Plan Sponsor on the last day of the year to be eligible for a discretionary employer matching and/or profit sharing contribution. The Plan Sponsor made discretionary employer profit sharing contributions totaling \$180,250 for the year ended December 31, 2024.

#### NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

**Participant Accounts:** Separate accounts are maintained for each participant (an elective deferral contribution account, an elective Roth deferral contribution account [if applicable], a matching contribution account, a discretionary employer contribution account and a rollover contribution account). Each participant's elective contribution accounts are credited with the participant's elective contributions and an allocation of plan earnings (losses) attributable to the elective accounts. Each participant's account is credited with the Plan Sponsor's discretionary contributions, along with an allocation of plan earnings (losses) attributable to the accounts. Investment direction for each participant's accounts is provided by the participant.

**Vesting:** Participants are fully and immediately vested in their elective deferral contribution accounts and rollover contribution accounts together with allocated plan earnings (losses) thereon. Discretionary employer profit sharing contributions are fully and immediately vested. Employer safe harbor QACA matching contributions and discretionary employer matching contributions are vested according to the following schedule:

If employed on or after normal retirement age, death or disability, a participant's accounts become fully vested.

**Notes Receivable from Participants:** Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. The repayment term of the loans may not exceed five years (with the exception of a loan used to purchase a primary residence, whereby the term of the loan may exceed five years but no more than ten years). The loans are secured by the participant's interests in the Plan's assets and bear interest at the prime rate at which the loan is issued. The Plan Administrator requires the participant receiving a loan from the Plan to enter into a payroll deduction agreement to repay the loan.

**Payment of Benefits:** Upon termination of service due to death, disability or retirement, a participant is entitled to receive their vested aggregate account balance and may choose to leave the assets invested in the Plan or take a lump-sum distribution. However, the Plan Administrator, without the consent of the participant, may distribute a participant's vested aggregate account balance in a lump sum any time after a participant terminates employment if the participant's account balance does not exceed \$5,000.

**Forfeited Accounts:** Forfeited nonvested accounts can be used to reduce employer contributions or pay plan expenses. There were no forfeitures during 2024 and 2023. For the year ended December 31, 2024, no forfeited nonvested accounts were used to reduce employer contributions or pay for plan expenses.

**Investment Options:** Participants may direct both employee and employer contributions to be invested among various investment options as made available and determined by the Plan Administrator, which are more fully described in the plan literature.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan were prepared using the accrual method of accounting. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The statements of net assets available for plan benefits present the fair value of the investment contracts as well as an adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The statement of changes in net assets available for plan benefits was prepared using the contract value basis for fully benefit-responsive investment contracts.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Fair Value Measurements:** The Accounting Standards Codification (ASC) establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The guidance also establishes a three-level fair value hierarchy that describes the inputs used to measure assets and liabilities.

- Level 1 asset and liability fair values are based on quoted prices in active markets for identical assets and liabilities.
- Level 2 asset and liability fair values are based on observable inputs that include quoted market prices for similar assets or liabilities, quoted market prices that are not in an active market, or other inputs that are observable in the market and can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 assets and liabilities are financial instruments whose value is calculated by the use of pricing models and/or discounted cash flow methodologies, as well as financial instruments for which the determination of fair value requires significant management judgment or estimation.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 compared to December 31, 2023.

- **Mutual Funds** – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

**Benefit Payments:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions, terminated employees' accounts and certain fees related to maintaining the Plan are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included under net appreciation in fair market value of investments.

**Subsequent Events:** The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

#### NOTE 3 – FAIR VALUE MEASUREMENTS

#### NOTE 4 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan maintains a fully benefit-responsive guaranteed investment contract with The Standard Insurance Company (The Standard). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

As described in the basis of accounting disclosure, because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the statements of net assets available for plan benefits at fair value with an adjustment to contract value in arriving at net assets available for plan benefits. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The fair value of the guaranteed investment contract approximates contract value. The crediting interest rate is based on a formula agreed upon with the issuer and may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event that would limit the Plan's ability to transact at contract value with participants is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The average yields based on actual earnings and interest rate credited to participants were 3.04% and 2.78% for the years ended December 31, 2024 and 2023, respectively.

#### NOTE 5 – TAX STATUS

The Plan adopted the Standard Retirement Services Inc Non-Standardized Pre-Approved Profit Sharing Plan/Money Purchase/CODA. Standard Retirement Services Inc received its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt as of the date of the financial statements.

US GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

The Plan is required to disclose significant concentrations of credit risk regardless of the degree of such risk. As of December 31, 2024 and 2023, the financial instruments that potentially subject the Plan to a concentration of credit risk consist principally of investments and notes receivable from participants.

**NOTE 7 – TRUSTEE CERTIFICATION**

The investment information, notes receivable from participants and related income information included in the financial statements, accompanying notes and supplemental schedules of assets and delinquent participant contributions, summarized below, were derived from statements certified by Reliance Trust as of December 31, 2024 and 2023 as complete and accurate in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The guaranteed investment contract maintained in the Standard Stable Asset A (SSAA) is managed by The Standard, which is a corporate affiliate of the third-party administrator of the Plan. Transactions in SSAA are considered to be party-in-interest investments. Fees paid to The Standard and affiliates for administrative and recordkeeping services amounted to \$72,710 for the year ended December 31, 2024.

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. These services constitute exempt party-in-interest transactions under ERISA.

#### NOTE 9 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in the Plan Sponsor's contributions.

#### NOTE 10 – CONTINGENCIES

Management became aware of delinquent participant contributions for the plan years ended December 31, 2024 and 2023. Delinquent participant contributions are considered prohibited transactions under IRC Section 4975(c)(1). The IRS may impose a nondeductible excise tax up to 15% under IRC Section 275(a)(6) on the amount involved with respect to each prohibited transaction that occurs in a year or part thereof. Additional taxes and penalties may be imposed if the transactions are not corrected within a specified period of time. Management is in the process of resolving the issues related to delinquent participant contributions and filing of all the required forms. (See the schedule of delinquent participant contributions for amounts involved.)

#### NOTE 11 – PROHIBITED TRANSACTIONS

The DOL requires plan sponsors to deposit 401(k) contributions and loan payments as soon as possible after the payroll deduction is made. Regulations state that participant contributions and loan repayments should be deposited no later than the earlier of (1) the date the amounts could have reasonably been segregated from the employer's general assets or (2) the 15th business day of the month following the month in which they were withheld or paid by the employer. In 2023, the Plan Sponsor failed to remit certain contributions and loan payments amounting to \$2,620 within the period prescribed by DOL Regulation 2510.3-102. In October 2024, the Plan Sponsor corrected the issue outside of the Voluntary Fiduciary Correction Program.

In 2024, the Plan Sponsor failed to remit certain contributions and loan payments amounting to \$42,137 within the period prescribed by DOL Regulation 2510.3-102.
