Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Individual Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Individual Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Individual Investment Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Individual Investment Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore it is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. (1) General

The Individual Investment Plan (the “Plan”) is a defined contribution plan originally established on January 1, 1985, covering employees of ClubCorp USA, Inc.’s (“ClubCorp”, the “Company” or the “Employer”) participating subsidiaries. An employee is eligible if he or she is classified as a regular full-time or regular part-time employee and has completed six months of consecutive service. The sponsoring employer of the Plan is ClubCorp. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Participants should refer to the Plan Document for more complete information. The Charles Schwab Trust Company (the “Trustee”), Cook Street Consulting and Milliman USA are the Trustee, compliance advisor and record keeper, respectively, of the Plan for 2024, and as such hold the Plan’s investment assets and execute investment transactions. The Charles Schwab Trust Company and Milliman USA were the Trustee and record keeper of the Plan for 2023, with Cook Street Consulting added as a compliance advisor in 2024.

(a) Basis of Presentation

The accompanying financial statements have been prepared on an accrual basis in accordance with accounting principles generally accepted in the United States of America.

(b) Contributions

Participants may elect to make a combination of pre-tax and post-tax contributions of up to 50% of their eligible compensation which may be invested among 13 funds plus an InvestMap option. The maximum amount which may be added to any participant’s account in any year is the lesser of \$23,000 for all ClubCorp defined contribution plans, or 100% of their compensation for that year. Participant contributions in the Plan are not matched by ClubCorp.

(c) Participant Accounts

After every pay cycle, each participant’s account is credited with the participant’s contributions. Earnings and losses from investments are allocated daily to the participants’ accounts based on their individual balances.

(d) Vesting

Participants have a 100% vested interest in the account value of their contributions and earnings thereon at all times.

(e) Payment of Benefits

Benefits are paid to participants upon retirement, permanent disability, or termination, or to beneficiaries upon death of the participant. The participant or beneficiary may elect, subject to the terms of the Plan and Internal Revenue Code (“IRC”) guidelines, to receive his or her benefits in a lump-sum cash distribution, in installments over a fixed period of time at age 70 ½, or through transfer to another retirement plan in an amount equal to the value of the participant’s account. Participants may elect, with certain restrictions, to make in-service withdrawals of their voluntary contributions.

(f) Administrative Expenses

The Plan is administered by a plan administrator appointed by ClubCorp. Direct administrative expenses of \$92,828 and \$91,455 were paid by the Plan in 2024 and 2023, respectively. Direct administrative expenses are net of Revenue Sharing, \$109,451 in 2024 and \$98,790 in 2023. Indirect administrative expenses of \$74,777 and \$71,576 were paid by ClubCorp on behalf of the Plan in 2024 and 2023, respectively.

(g) Corrective Distributions

The Plan is required to return contributions received in excess of IRC limits. Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. Corrective distributions of \$426,042 and \$681,130 were returned to participants in 2025 and 2024 for the years ended December 31, 2024 and 2023 respectively.

(h) Plan Termination

Although it has not expressed the intent to do so, ClubCorp has the right to terminate the Plan at any time subject to the provisions of ERISA. If the Plan were to terminate, the net plan assets would be distributed to plan participants based on each participant’s account balance.

(i) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

(j) Risks and Uncertainties

Financial instruments which potentially subject the Plan to concentrations of credit risk include cash. The Plan places its cash with Charles Schwab Trust Company. The Plan’s exposure to loss should this financial institution fail would be limited to any amount in excess of the amount insured by the Federal Deposit Insurance Corporation.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that losses could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

(k) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

(l) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See note 3 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

(2) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate the Trustee of the Plan.

(3) Fair Value Measurements

GAAP establishes a three-tiered fair value hierarchy that prioritizes inputs to valuation techniques used in fair value calculations. The three levels of inputs are defined as follows:

Level 1—unadjusted quoted prices for identical assets or liabilities in active markets accessible by us;

Level 2—inputs that are observable in the marketplace other than those inputs classified as Level 1; and

Level 3—inputs that are unobservable in the marketplace and significant to the valuation.

We maximize the use of observable inputs and minimize the use of unobservable inputs. If a financial instrument uses inputs that fall in different levels of the hierarchy, the instrument is categorized based upon the lowest level of input that is significant to the fair value calculation. We recognize transfers between levels of the fair value hierarchy on the date of the change in circumstances that caused the transfer.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. The fair value of investments in mutual funds is based on quoted net asset values of the shares held by the plan as of December 31, 2024 and 2023 and are considered Level 1. The mutual funds held by the plan are deemed to be actively traded.

Stable Value Collective Investment Trust: The fair value is determined by fund managers based on NAV per fund share and is considered Level 2. This fund, Galliard Stable Return Fund, invests in Galliard Stable Return Fund C, which invests primarily in investment contracts and security-backed contracts.

There are no restrictions on participant redemptions of the stable value collective trust fund measured at NAV. There were no unfunded commitments as of December 31, 2024 or 2023.

(4) Tax Status

The Plan obtained its latest tax determination letter on December 6, 2017, in which the IRS stated that the Plan was in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is not subject to income tax examinations. The Plan Administrator believes the Plan is not subject to income tax examinations in excess of three years prior to the current plan year.

(5) Benefits Payable

As of December 31, 2024 and 2023, there were no balances included in net assets available for benefits for distributions payable to participants who requested a withdrawal from the Plan prior to the end of the Plan year.

(6) Notes Receivable from Participants

The Plan permits loans to participants on a nondiscriminatory basis. Loans are not to exceed \$50,000 or 50% of the participants' vested accrued benefit in the Plan, whichever is less. The maturities of the loan are not to exceed five years unless the loan is used to construct or rehabilitate the principal dwelling of the participant in which case the maturities are not to exceed ten years. These loans will bear interest at prime (as quoted in the Wall Street Journal) plus 1%. Loans are repaid ratably through payroll deductions. No participant is allowed to have more than one loan outstanding at any one time. The minimum amount that can be loaned is \$500. As of December 31, 2024 and 2023, notes receivable to participants of \$402,124 and \$396,917, respectively, were outstanding at interest rates ranging from 4.25% to 9.50%.

(7) Related Party Transactions

Certain Plan investments are shares of funds managed by Charles Schwab Trust Company. Charles Schwab Trust Company is the trustee as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$92,828 and \$91,455 for the years ended December 31, 2024 and 2023, respectively.

During the years ending December 31, 2024 and 2023, ClubCorp paid \$74,777 and \$71,576 of indirect expenses on behalf of the Plan, respectively.

The Plan incurred audit fees in the amounts of \$14,000 during each of the years ended December 31, 2024 and 2023, respectively. The audit fees were paid by ClubCorp.

There is \$109,451 and \$98,790 for the years ended December 31, 2024 and 2023, respectively, of revenue sharing income from Charles Schwab Trust Company received that is net against administrative expense in the accompanying statement of changes in net assets available for benefits. Charles Schwab receives revenue from certain mutual funds for services that Charles Schwab provides to the funds. Charles Schwab passes this revenue to the Plan, and it is allocated to the accounts of the participants that are invested in the respective funds.

(8) Date to Which Subsequent Events Evaluated

Subsequent events were evaluated through September 5, 2025, which is the date the financial statements were available to be issued.
