Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Encova Insurance 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Encova Insurance 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

General: The Plan, a defined contribution plan, was established for the purpose of providing a savings plan for the benefit of substantially all employees of Motorists Mutual Insurance Company (the Company), and its subsidiaries. Full-time employees are immediately eligible to participate after their employment date. Temporary employees, seasonal employees, and interns must complete 1,000 hours of service to become eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2021, the companies collectively referred to as Encova Insurance were reorganized into a mutual holding company structure with Encova Mutual Insurance Group, Inc. as the ultimate parent. Affiliated mutual insurance companies of the group were converted into stock companies that are wholly owned by Encova Holdings, Inc., a stock subsidiary of Encova Mutual Insurance Group, Inc. Stock subsidiaries of the former affiliated companies remained as subsidiaries of those companies. This reorganization did not have any effect on the Plan.

Contributions: Each eligible employee (participant), as defined in the Plan, may elect to contribute, through payroll deduction, a percentage of their compensation limited to the maximum allowable under the Internal Revenue Code (IRC) for such plan year. Eligible employees are automatically enrolled in the Plan with an elective pre-tax deferral rate of 4% of compensation, increasing each year by 1% until such elective deferral rate is 10% of compensation, unless the participant affirmatively elects out of the automatic deferral feature or elects a different deferral rate. Participants may increase or decrease their contribution amount at any time. Participants may also make Roth deferral contributions. Participants may be eligible to contribute rollover amounts received as a lump-sum distribution from a qualified retirement plan of another employer if transferred to this Plan directly, or by the participant within 60 days of receipt of the distribution from the previous plan. Such amount shall have no effect on the limits for maximum benefits and contributions as defined by the Plan. Company matching contributions are made in an amount equal to 100% of the first 7% of employee contributions.

Additional discretionary amounts may be contributed by the Company at the option of the Company's board of directors. There were no discretionary contributions in 2024. All contributions are invested in the investment options at the direction of the participant. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and is charged with an allocation of administration expenses, if applicable. The allocation of the Company's contributions follows the participant's directed investment options. Plan earnings are allocated based upon the participant's shares in each investment account.

Vesting and forfeitures: Participants are immediately vested in their contributions, Company matching contributions and additional discretionary amounts contributed by the Plan, plus actual earnings thereon.

Notes to Financial Statements

Note 1. Description of the Plan (Continued)

Investment options: Upon enrollment in the Plan, participants may elect to allocate contributions between the fund options available under the Plan in increments of 1%. Earnings on all funds, including appreciation and depreciation in the fair value of investments, are determined daily by using the quoted market value of shares in each investment account. Participants may transfer account contributions on a daily basis, and may transfer account balances in 1% increments on a daily basis. Through the self-directed brokerage account option, participants may invest in most listed stocks, options (if approved for options trading), corporate bonds, zero-coupon bonds, U.S. Treasury securities, mortgage securities, U.S. government agency bonds, certificates of deposit, unit investment trusts, foreign securities and other mutual funds (subject to the limitations of the Plan).

If a participant does not make an investment option election, contributions are automatically allocated in accordance with the default investment alternatives established under the Plan. These default investments would be made in accordance with specific rules under which the fiduciaries of the Plan, including the Employer, the trustee and the Plan Administrator, are relieved of any legal liability for any losses resulting from the default investments.

Notes receivable from participants: Participants may borrow from their fund accounts once every 12 months with a maximum of two outstanding loans at any one time. The minimum loan is \$1,000 with the maximum loan not to exceed the lesser of \$50,000 or 50% of the vested account value. The loan amount will process as a reduction of the elected investment funds on a pro-rata basis. Loan terms may extend to a maximum of five years or up to 15 years for the purchase of a primary residence. The loans have a fixed interest rate of 1% over the prime interest rate. Throughout Plan year 2024 and 2023, the interest rates ranges were 3.25% to 9.50%. The interest rate is fixed for the life of the loan. Principal and interest is paid ratably through payroll deduction.

Payment of benefits: Upon termination of service due to retirement, death or disability, participants may receive the vested value of their account in a lump sum or partial distribution. Regular installments over a period not to exceed 15 years may also be elected. If service terminates for other reasons and the vested account balance exceeds \$5,000, a participant must consent to receive a lump sum or partial distribution. Benefit payments may be deferred until age 73 or retirement, if later.

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Note 2. Summary of Significant Accounting Policies

Contributions: Participant contributions and Company matching contributions are recognized when the participant contributions are earned from the participant's earnings. Additional discretionary contributions approved by the Company's board of directors are recognized in the year of service.

Payments of benefits: Distributions are recognized when paid.

Administrative expenses: Certain administrative expenses are paid by the Company, except for participant fees related to distribution and loan withdrawals, which are paid by the participant.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

Subsequent events: The Plan Administrator has evaluated subsequent events through August 25, 2025, the date on which the financial statements were available to be issued.

Note 3. Information Certified by Empower Trust Company, LLC

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Empower Trust Company, LLC, the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB guidance are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Shares of registered investment companies: Valued by published market sources at the net asset value (NAV) of shares held by the Plan at year-end.

Self-directed brokerage accounts: Valued at the closing price reported on the active market on which the individual securities are traded.

Shares of pooled stable value account and stable value account: The pooled stable value account is comprised of stable value funds and fully-benefit responsive investment contracts that are valued at the NAV of units of the pooled stable value account. The stable value account is valued at NAV. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Parties-in-Interest Transactions

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. During the year ended December 31, 2024, fees for these services were \$157,265.
