We have performed audits of the financial statements of National FFA Organization 403(b) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of National FFA Organization 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of the Plan

The following description of National FFA Organization 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan was originally effective July 1, 1982 and is a 403(b) plan sponsored by Future Farmers of America, Inc. dba National FFA Organization (FFA) for the benefit of its employees who work more than 20 hours a week. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company and Principal Life Insurance Company (Principal) is the custodian and recordkeeper of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions up to 100% of eligible compensation (up to the maximum allowed by law). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employee rollover and Roth contributions are also permitted.

FFA contributions include discretionary, non-elective contributions as determined by the FFA's Board of Directors and a matching contribution. All participants are immediately eligible to receive FFA matching contributions of 100% of elective deferrals on the first 5% of eligible compensation. Contributions are subject to certain limitations.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise. The Plan also includes an automatic deferral increase annually on January 1 of each year by 1% to a maximum of 10% of eligible compensation.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution, FFA's matching contribution and discretionary contribution, Plan earnings, and forfeitures of terminated participants' nonvested accounts, and is charged with an allocation of administrative expenses. Allocations are based on account balances. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in FFA's contribution portion of their accounts plus earnings thereon is based on the hours of service method. A participant is fully vested after three years of credited service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his account or an annual installment based upon his actuarial life expectancy. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,524 and \$4,916, respectively. These forfeitures are used to pay for Plan expenses and offset FFA contributions. Any remaining forfeitures are allocated as an additional discretionary contribution to participants. During 2024 and 2023, forfeitures of \$42 and \$124, respectively, were used to pay Plan administrative expenses. During 2024 forfeitures were not used to reduce FFA contributions. During 2023, forfeitures of \$17,752 were used to reduce FFA contributions.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. Participants are only allowed to have one outstanding loan at any particular time. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator, which is the current Prime Rate plus 1% for 2024 and 2023.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefits paid based upon the terms of the Plan Document.

Plan Termination

Although it has not expressed an intention to do so, FFA has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value).

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are valued at cost, which approximates fair value.

The guaranteed investment contract is a fully-benefit responsive account with Principal. It is valued at contract value and calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a nonstandardized prototype adoption agreement in connection with a prototype retirement plan document sponsored by Principal Life Insurance Company. The Plan has not been submitted to the Internal Revenue Service for an individual letter from the IRS because the prototype has received a favorable opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by FFA or the Plan, at FFA's discretion. During 2024 and 2023, the Plan received Plan Servicing Credit in the Revenue Credit Account. This account is credited with excess revenue generated by the Plan. The credits may be used to pay Plan expenses. Credits contributed to the Plan for 2024 and 2023 were \$21,665 and \$24,261, respectively. Unused credits for 2024 and 2023 were \$6,742 and \$6,556, respectively. The credits and expenses run through a separate ERISA Budget Account that is held separate from the Plan's activity.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets held at year end as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Recurring Measurements

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and a money market fund. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. There are no Level 2 securities included in the Plan. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities in the Plan.

Note 5. Investment Contracts With Insurance Company

The Plan has entered into fully benefit-responsive investment contracts with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive (FBRIC). Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts permit the insurance company to terminate the agreement prior to the scheduled maturity date under certain circumstances.

Note 6. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan custodian. The Plan paid administrative fees of \$53,291 and \$46,730 to Principal for 2024 and 2023, respectively. Expenses paid to the Plan's investment managers through revenue sharing credits for 2024 and 2023 were \$21,665 and \$24,261, respectively. FFA provides certain administrative services at no cost to the Plan.

Note 7. Nonexempt Transactions

Defined-contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets.

Although all contributions and loan repayments were deposited to the Plan as of December 31, 2023, participant contributions and loan repayments totaling \$30,056 from the April 28, 2023 pay date were not remitted in the required time period for the year ended December 31, 2023. The lost earnings were deposited in the Plan in 2024.

Although all contributions and loan repayments were deposited to the Plan as of December 31, 2022, participant contributions and loan repayments totaling \$27,027 from the November 10, 2022 pay date were not remitted in the required time period for the year ended December 31, 2022. The lost earnings were deposited in the Plan in 2024.

Participant contributions and loan repayments totaling \$23,661 from the December 23, 2021 pay date were not remitted in the required time period for the year ended December 31, 2021. These late remittances were deposited in the Plan in January 2022. The lost earnings were deposited in the Plan in 2023.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participant's account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Effective January 1, 2025, the plan was amended to allow for immediate vesting in employer contributions.

Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.
