INDEPENDENT AUDITOR'S REPORT

To the Participants, Retirement Plan Administrative Committee, and
Audit Committee of the Oral Roberts University Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Oral Roberts University Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Information Required by ERISA

The supplemental information, schedules of delinquent participant contributions and assets (held at end of year) as of or for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental information, other than the information in the supplemental information that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

Note 1 – Description of the Plan

Oral Roberts University (the University or Employer) sponsors the Oral Roberts University Retirement Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established and maintained for the benefit of the University's employees, except for employees who are eligible to participate in the 401(k) plan sponsored by the Employer, students, or nonresident aliens. The Plan is intended to satisfy all of the requirements for a 403(b) plan under the appropriate provisions of the Internal Revenue Code (the Code) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Retirement Plan Administrative Committee, which is a committee of individuals appointed by the University's board of trustees. The Plan's investments are managed by Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF). TIAA and CREF serve as agents for TIAA Trust, N.A. TIAA is an insurance company; CREF is a registered investment company, as well as an insurance company; and TIAA Trust, N.A., is a national trust bank. TIAA maintains the records of the participant data.

Eligibility

Nonexcluded employees of the University are eligible to participate in the Plan upon the first day of employment.

Contributions

Participants may contribute up to 100% of their compensation, as defined in the Plan document, as either pretax or Roth deferrals. Participants who have completed at least 15 years of service or attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan also provides for Employer matching contributions to participants who have reached 21 years of age and completed one year of service, as defined in the Plan document. The University matches 50% of deferrals up to 6% of a participant's compensation. Employer matching contributions are based on deferrals made each payroll period.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations of the Code.

Participant accounts

Each participant's account is credited with participant contributions, Employer matching contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses

that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in Employer matching contributions and their own contributions plus actual earnings thereon.

Notes receivable from participants

Participants may borrow from their vested accounts, except for Roth deferrals, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding loan balance during the preceding 12-month period over the loan balance on the date of the loan, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which is based on prime rate plus 1% on the date of origination. Participants may only have three loans outstanding at any given time. Terms range from one to five years or up to ten years for the purchase of a primary residence. Principal and interest is paid ratably by the participants directly to TIAA.

Plan loans

TIAA offered loans to participants, which were issued from funds directly owned by TIAA and not from participant accounts. Participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their balance in the TIAA Traditional Annuity account. To secure Plan loans, participants were required to pledge as collateral their TIAA Traditional Annuity account value equal to 110% of their outstanding loan balance in the event of default. Plan loans bear interest at rates that range from 4.00% to 5.58%. Principal and interest is paid by the participant directly to TIAA.

Loan balances outstanding between TIAA and Plan participants are approximately \$16,000 and \$17,000 as of December 31, 2024 and 2023, respectively. As such, approximately \$18,000 and \$19,000 of TIAA Traditional Annuity account balances as of December 31, 2024 and 2023, respectively, serve as collateral for the related loans.

In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the participant or the participant becomes eligible to receive a distribution under the terms of the Plan. As of December 31, 2024 and 2023, loans in default total approximately \$11,000 and \$10,000, respectively.

Payment of benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive benefits in any of the forms of benefit available from the relevant funding vehicles. Forms of benefit available under the Plan, but not necessarily from all funding vehicles, include: 1) a lump-sum amount, 2) a partial payment, 3) installment payments over a period not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and their designated beneficiary, or 4) applied to the purchase of an annuity contract or converted to an income option. Participants who have invested in TIAA Traditional Annuity are limited in their ability to elect a lump-sum distribution depending upon the year in which contributions were made; however, they may receive the value of their accumulated benefits over a ten-year period.

Additionally, participants are allowed to take in-service withdrawals upon reaching age 59½. Further, in-service distributions are allowed at any time from a participant's rollover account. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

Upon termination, automatic distributions are required for balances of less than \$7,000. Automatic distributions made without the participant's consent are rolled into an individual retirement account designated by TIAA.

Forfeitures

Forfeitures are first used to restore participant balances previously forfeited, then may be used to pay Plan administrative expenses, and lastly to reduce Employer contributions. The Plan had no unallocated forfeitures as of December 31, 2024 and 2023. For the year ended December 31, 2024, no forfeitures were utilized.

Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan assets. Investment expenses netted against investment income represent amounts associated with the net expense ratios of the investments in the Plan's fund lineup. The Plan participates in an agreement with TIAA, where fees are credited and allocated to certain participants through a fee leveling credit. There were no fee leveling credits received for the year ended December 31, 2024. Additionally, the Plan participates in an agreement with TIAA, where excess revenue may be returned and deposited into an unallocated revenue credit account. The amounts in the unallocated revenue credit account may be used to pay reasonable and necessary Plan expenses or may be allocated to participants. There were \$37,795 and \$19,066 of unallocated funds in the revenue credit account as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, the Plan used \$8,922 from the revenue credit account to pay certain Plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the valuation policies utilizing information provided by TIAA and CREF. See Note 4 for discussion of fair value measurements and Note 5 for contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Allowances for delinquent notes receivable from participants in the amounts of \$1,025 and \$1,215 have been recorded as of December 31, 2024 and 2023, respectively. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Contributions

Participant contributions, and the related Employer matching contributions, are recorded in the year in which the participant deferrals are withheld from compensation.

Payment of benefits

Benefit payments are recorded when paid. There were no benefits requested before year-end that were not paid.

Subsequent events

The Plan administrator has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.

Note 3 – Information Certified by TIAA and CREF

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF have certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1

measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value:

Fixed annuity contracts - nonfully benefit responsive – This account is valued at contract value, which equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. The TIAA Traditional Annuity is reported at contract value and segregated between nonfully benefit responsive and fully benefit responsive contracts based on the terms of the individual contracts. Contract value approximates fair value.

The participant owns the nonfully benefit responsive TIAA Traditional Annuity through the Retirement Annuity (RA) and the Retirement Choice (RC) contracts. The RA contract does not allow lump-sum withdrawals, and transfers must be spread over ten annual installments. The RC contract allows lump-sum withdrawals only within 120 days after termination of employment subject to a 2.5% surrender charge, and transfers must be spread over 84 monthly installments. The RC contract allows institutional withdrawals over 60 monthly installments with 90-day advance notice from the institution.

The Plan administrator has selected TIAA as a vendor to provide funding vehicles under the Plan and has selected the TIAA Traditional Annuity as an investment option to be offered under the TIAA funding vehicles. TIAA has provided specific information to the Plan administrator regarding TIAA's assumptions and analysis on which TIAA has based the valuation of the TIAA Traditional Annuity. This information includes but is not limited to: (1) TIAA's analysis of how, in the absence of a principal market, participant investment allocation decisions support the conclusion that contract value approximates fair value; and (2) TIAA's application of a discounted cash flows model to conclude that the present value of future accumulations would reasonably approximate current contract values. The Plan administrator has utilized and relied on the information provided by TIAA to determine the Plan's valuation policy for the TIAA Traditional Annuity.

Mutual funds and variable annuities in mutual funds – Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end. Variable annuities in mutual funds have no unfunded commitments, offer daily liquidity (pending market conditions), and are not subject to any redemption restrictions at the measurement date, except as described herein. With the exception of the CREF Money Market Account, variable annuities in mutual funds are subject to certain

restrictions. The units in the CREF variable annuities in mutual funds are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange is open for business. In an effort to reduce market timing and excessive trading for variable annuities in mutual funds, shareholders will be locked out of an account for 90 days if a purchase, sale, and repurchase within that account is made within a 60-day period.

Variable annuity in pooled separate account – Valued at quoted market prices, which represent the NAV of units held by the Plan at year-end, based on the underlying real estate holdings which are valued principally using external appraisals. Unit value is calculated daily. Transfers and distributions are allowed once per calendar quarter unless set up as part of a systematic distribution or transfer. There were no unfunded commitments as of December 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Fully Benefit Responsive Investment Contracts with TIAA

The Plan has traditional fully benefit responsive investment contracts (FBRIC) with TIAA. TIAA maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TIAA is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

The contracts meet the FBRIC criteria and therefore are reported at contract value. Contract value, as reported to the Plan by TIAA, represents contributions under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The participant owns the TIAA Traditional Annuity through either the Retirement Choice Plus (RCP), Group Supplemental Retirement Annuity (GSRA), or the Supplemental Retirement Annuity (SRA) contracts. The type of contract through which a participant owns the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional amounts paid, the degree of liquidity of the participant's account, and the options for receiving income upon retirement. Certain contract types contain liquidity restrictions on the redemption of TIAA Traditional Annuity accumulations, which could impact the value realized upon exiting the contract. The guaranteed annual interest rate is 3% for all premiums remitted since 1979 under SRA and GSRA contracts. For the RCP contracts, the guaranteed rate is between 1% and 3%. Plan withdrawals from the RCP are allowed over a 60-month period with a 190-day advance notice. The crediting interest rate is calculated on a daily basis.

The Plan's ability to receive amounts due in accordance with the FBRICs is dependent on the TIAA's ability to meet its financial obligations. TIAA's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with TIAA. These events may be different under each contract. Examples of such events include, but are not limited to the following:

1. The Plan's failure to qualify under Section 401(a) of the Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example divestures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow TIAA to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Examples of such events include:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 6 – Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers and employees of the University. No officer or employee receives compensation from the Plan for these services.

Investments are managed by TIAA, CREF, and Nuveen, LLC. Nuveen, LLC is a wholly owned subsidiary of TIAA. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to service providers which were not covered by revenue sharing.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 – Tax Status

To Company adopted a volume submitter 403(b) Plan (the Volume Submitter Plan) sponsored by TIAA. The Internal Revenue Service has determined and informed the Volume Submitter Plan sponsor by a favorable opinion letter dated August 7, 2017, that the Volume Submitter Plan is designed in accordance with the applicable sections of the Code. The Volume Submitter Plan's opinion letter is being related on by the Plan. Although the Plan has been amended since receiving the opinion letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

TIAA and CREF issue various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of the contract accumulations, which could impact the value realized upon exiting the contract.

Note 10 – Prohibited Transactions

During the year ended December 31, 2024, the University inadvertently failed to deposit \$130,999 of participant contributions within the required timeframe as stated by the DOL. The DOL considers late deposits to be nonexempt prohibited transactions. The University will pay lost earnings in 2025.
