To the J.F. Shea Retirement Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of J.F. Shea Company, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of J.F. Shea Company, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTE A - DESCRIPTION OF THE PLAN

The following description of the J.F. Shea Company, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan was created on January 1, 1966 as a defined contribution plan established by J.F. Shea Company, Inc. and eligible participating employers (collectively, the “Employer”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan provides for a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Employer. The J.F. Shea Retirement Committee, appointed by the management of the Employer, is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance. Empower Trust Company, LLC (the “Trustee”) and Empower Annuity Insurance Company of America (the “Recordkeeper”) under a power of attorney with Massachusetts Mutual Life Insurance Company (the “Custodian”) are responsible for the custody and management of the Plan’s assets.

2. Eligibility

Prior to January 1, 2024, all non-union, non-temporary, non-leased and non-project team employees who were U.S. residents could participate in the Plan. Effective January 1, 2024, the Plan allowed for temporary employees with more than 1,000 hours in the plan year, and project team employees, to be eligible to elect deferrals, however these employees are not eligible for any Employer contributions (see Note L). Employees may begin contributing to the Plan upon 60 days of continuous employment with the Employer. Certain employees that may be covered under Davis-Bacon provisions are also eligible to participate in the Plan if designated as government contract employees, but they are not eligible for Employer discretionary matching or Employer discretionary profit-sharing contributions. All other eligible employees who are employed on the last day of the plan year are also eligible for Employer discretionary matching and Employer discretionary profit-sharing contributions upon one year of service (see Note M).

3. Contributions

Participants may elect to contribute, on a tax-deferred basis or as a Roth 401(k), up to 100% of their eligible compensation, subject to certain limitations under the IRC. Unless a participant elects otherwise, the Employer will automatically withhold 3% of the compensation as tax deferred contributions after attaining eligibility, subject to annual increases of 1% up to a maximum of 10%, unless a participant elects otherwise (see Note M). Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may direct contributions, as desired, in any of several investments offered by the Custodian and may change their investment options daily.

3. Contributions (continued)

Each participating employer may make discretionary matching contributions to the Plan subject to certain compensation limits. In addition, each participating employer may also make a discretionary profit-sharing contribution to the Plan for each active and eligible participant (with the exception to employees of Reed Manufacturing, LLC) in an amount subject to determination on an annual basis by the Board of Directors of the Employer.

4. Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's discretionary matching contribution, as well as allocations of the Employer's discretionary profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000 less the highest outstanding loan balance during the prior twelve-month period). The loans are secured by the balance in the participant's account. Participants may have one loan outstanding at any time. All loans shall bear interest at the prime rate plus 1% at the time of issuance. Loans must be paid back within five years of the date of issuance in accordance with terms established by the plan administrator. Loans for the purchase of a principal residence may be paid back over ten years. Loans are due and payable upon the participant's termination of employment with the Employer.

6. Vesting

Employee contributions, Employer qualified nonelective contributions, rollovers and actual earnings on all such contributions are fully vested at all times. Vesting of Employer discretionary matching contributions, Employer discretionary profit-sharing contributions and actual earnings thereon, are based upon the participant's years of service with the Employer as follows:

7. Benefit Payments

Upon termination of employment with the Employer, a participant may receive a lump sum disbursement if his or her vested account balance is less than \$1. If the vested account balance is between \$1 and \$5,000, a lump sum will be distributed directly to an individual retirement account unless the participant elects otherwise. For balances greater than \$5,000, the participant is entitled to a lump sum amount or installment payments. In the event of death or total and permanent disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account. In addition, upon attaining age 59½, participants may receive distributions. Hardship withdrawals are also permitted if certain criteria are met.

8. Administrative Expenses

Certain expenses of maintaining the Plan are paid from the assets of the Plan, and reimbursed subject to a plan expense reimbursement arrangement with the Custodian, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

9. Forfeitures

Forfeitures of terminated participants' non-vested accounts may be applied against future Employer matching or profit-sharing contributions or to pay plan expenses. As of December 31, 2024 and 2023, there were \$274,160 and \$353,711, respectively, of unallocated forfeitures included in net assets available for benefits. Employer contributions receivable as of December 31, 2024 and 2023 have been reduced by \$277,266 and \$280,203, respectively, for forfeitures applied in the subsequent year. In addition, plan expenses of \$1,052 were paid from the forfeitures balance during the year ended December 31, 2024.

10. Plan Amendments and Termination

Although it has not expressed such intent, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

2. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The MassMutual SAGIC Core Bond I is a group annuity contract and is considered fully benefit-responsive and is reported at contract value. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the Custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

5. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding increase to deductions from net assets. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

6. Benefit Payments

Benefits are recorded when paid.

7. Subsequent Events

Plan management has evaluated subsequent events through October 1, 2025 the date the financial statements were available to be issued.

NOTE C - CERTIFICATION BY TRUSTEE AND RECORDKEEPER

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all of the investment information, including investment income, and notes receivable from participants and related interest income, included in the accompanying financial statements and supplemental schedules has been certified as complete and accurate by the Trustee and Recordkeeper of the Plan.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the fund's NAV reflecting all investments at fair value, including direct and indirect interests in mutual funds, as reported by the fund manager, held by the Plan at year end.

Collective investment trusts: Valued at the NAV of units held by the Plan at year end. The unit value represents the fair value of the underlying assets, as reported by the fund manager. The Plan's investment in the collective trust funds have a readily determinable fair value because they invest primarily in equity investments, such as common stocks and mutual funds, and the NAV is determined and published daily, is available to participants of the Plan when they log into their online account, and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

Self-directed brokerage accounts: Includes mutual funds valued at the fund's NAV of the shares held by the Plan at year end, common stocks valued at quoted market prices, and fixed income investments valued at the corporate or government quoted market price for the number of bonds held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a benefit-responsive investment contract with the Custodian. The contract is an insurance company issued group annuity with contributions maintained in a general account.

As described in Note B, because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the Custodian. Such events include the following: (a) the complete or partial plan termination of the Plan and (b) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan, or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of subsidiary or division or as a result of group layoffs or early retirement programs. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value, is probable.

The group annuity contract does not permit the insurance company to terminate the agreement prior to ninety days written notification.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Trustee, Recordkeeper, and Custodian are parties-in-interest with respect to the Plan. Investments are held with and managed by the Trustee, Recordkeeper and Custodian. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than direct payment. Additional fees may be paid directly to the Trustee, Recordkeeper, Custodian or other parties-in-interest. Notes receivable and the related interest income are considered related party transactions.

NOTE G - INCOME TAX STATUS

The IRS has issued an opinion letter to the Custodian dated November 14, 2022, that the adopted non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan did not seek a favorable determination letter with respect to the initial adoption of the plan document, nor with any plan amendments or restatements, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expect to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J - PROHIBITED TRANSACTIONS

During the year ended December 31, 2023, the Employer failed to remit employee contributions to the Plan on a timely basis for a participating employer, as required by DOL Reg. 2510.3-102, resulting in prohibited transactions. The Employer computed and remitted the lost earnings related to the late remittances for deposit to the Plan during the year ended December 31, 2024.

NOTE K - DEPARTMENT OF LABOR REVIEW

The Plan was notified on May 3, 2021 by the Department of Labor (“DOL”) that the Plan was selected for a review of the plan information for the periods from January 1, 2018 through the date of the letter. Effective February 28, 2023, the DOL finalized their review of plan. The result of the findings had no material impact on the Plan.

NOTE L - PLAN AMENDMENTS

Effective January 1, 2024, the Plan adopted an amendment to allow for certain temporary and project team employees to participate in the Plan (see Note A-2). In addition, SH South Carolina, LLC and Shea Homes Carolina LLC were added as participating employers.

NOTE M – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to update the definition of compensation for purposes of Employer discretionary matching contributions and Employer discretionary profit-sharing contributions for certain participants. In addition, the Plan was amended to allow employees to become eligible for Employer discretionary matching contributions and Employer discretionary profit-sharing contributions on their date of hire. In both cases, employees may begin participation upon reaching the next applicable entry date (see Note A-2). There were no other material modifications to the Plan.

Effective March 1, 2025, eligible employees will be automatically enrolled at a deferral rate of 3% of compensation, with an automatic deferral increase of 1% annually, up to a maximum of 15% (see Note A-3). There were no other material modifications to the Plan.
