Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of Paramount Care Centers, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan sponsored by Paramount Care Centers, LLC (the Company) as permitted under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on February 4, 2019 with no participant activity until 2020. The Plan assets are maintained in an investment trust which are held by John Hancock Life Insurance Company (John Hancock).

(b) Contributions

Participants with twelve months of service and who are 21 years of age may make pre-tax and Roth contributions up to the maximum allowed by Section 402(g) of the IRC. Participants who attain the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also accepts contributions representing eligible rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company will make a discretionary matching contribution in an amount determined by management. Participants with twelve months of service and are 21 years of age may receive a matching contribution.

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) Plan earnings, and (c) charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of Plan, Continued

(d) Vesting

Participants' contributions, plus any investment earnings thereon, are immediately 100% vested and cannot be forfeited for any reason. Vesting in the Company's matching contributions and the Company's discretionary contributions, plus earnings thereon, is based on years of service and is determined as follows:

1	20%
2	40%

(e) Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may have four loans outstanding at any time. Loans are secured by the balance in the participant's account and bear interest at 1% higher than prime rate at the time of the loan application. Principal and interest is paid ratably through payroll deductions.

(f) Payment of Benefits

Participants (or their beneficiaries) are eligible to receive vested benefits upon retirement, death, disability, or when they cease to be an employee of the Company.

(g) Forfeitures

Forfeitures of nonvested accounts will be used to reduce Company contributions. There were no forfeitures of nonvested accounts during the years ended December 31, 2024 and 2023.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies, Continued

(c) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(e) Contributions

Contributions from Plan participants and the Company contributions are recorded in the year in which the participants compensation is earned.

(f) Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowable by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding corrective distribution. The Plan distributed the excess contributions to applicable participants prior to the deadline.

(g) Payment of Benefits

Benefits paid to participants are recorded when paid.

(h) Operating Expenses

Certain operating expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees for recordkeeping and other services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses and administrative expenses are included in net appreciation in fair value of investments.

(i) Subsequent Events

Management of the Plan has evaluated subsequent events through the date of the report which is the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Pooled separate accounts - Valued at the net asset value (NAV) of units held by the Plan at year end. The unit values are calculated based on the observable NAV of the underlying investments. Included in pooled separate accounts, is a stable value fund which represents participation units of a collective investment trust for which the net asset value is based on the market value of the underlying investments. The stable value fund is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The Plan has concluded that the NAV as adjusted and reported by the insurance company denotes readily determinable fair value. The stable value fund is classified in Level 1 in the fair value hierarchy.

(5) Party-In-Interest Transactions

The Plan's investments are managed by John Hancock, who is the custodian, as defined by the Plan. Therefore, transactions with John Hancock qualify as party-in-interest transactions. Administrative fees paid to John Hancock for the years ended December 31, 2024 and 2023 are included in net appreciation or depreciation in fair value of investments.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in all contributions in their accounts and related income and appreciation, regardless of source.

(7) Tax Status

The Plan is a volume submitter profit sharing plan and obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions and the Department of Labor; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Transfers of Assets

Transfers of assets include a transfer of participant accounts to Peace Healthcare Management, LLC Retirement Plan totaling \$524,543 for the year ended December 31, 2023.
