### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Meister Dairy 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

## 1. Description of Plan

The following description of the Meister Dairy 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering eligible employees, as defined, of Meister Cheese Company, LLC, Muscoda Protein Products, LLP and Meister Management Company, LLC (collectively, the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All regular employees of the Company (excluding leased, union, nonresident alien and reclassified employees), who are at least 18 years of age or older, become eligible to participate once certain eligibility conditions are met. For elective deferrals, employees are eligible to participate the first day of the month coinciding with or following the date on which the employee completes 60 days of service. For employer matching and nonelective contributions, employees are eligible to participate the first day of the quarter coinciding with or following the date on which the employee completes one year of service. Long-term part-time employees who met eligibility requirements under the Setting Every Community Up for Retirement Enhancement Act 2.0 (SECURE 2.0 Act) are also eligible to participate in the Plan. The Plan's administrative committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### Contributions

Each year, participants may make voluntary pre-tax and posttax Roth contributions up to an amount that does not exceed their annual compensation (salary reduction contributions), as defined in the plan document or the maximum amount defined by the Internal Revenue Service (IRS), whichever is less. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Company contributes a safe harbor match equal to 100% of employee elective deferrals that do not exceed 4% of eligible compensation and 50% of elective deferrals between 4% and 6% of eligible compensation. Catch-up deferrals will be considered for safe harbor matching contributions. Employees must complete one year of service to be eligible for safe harbor matching contributions. Additional discretionary nonelective contributions and discretionary matching contributions may be contributed at the option of the Company. To be eligible for discretionary contributions, employees must have completed at least 1,000 hours of service during the plan year and must be employed by the Company on the last day of the plan year unless the participant terminates employment following their death, disability or achievement of normal retirement date, as defined. For the 2024 plan year, the Company made a discretionary nonelective contribution, effectively matching employee contributions up to 8% of eligible compensation.

### Participant Accounts

Each participant's account is credited with the participant's salary reduction contributions, rollover contributions, the Company's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are vested immediately in their contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their participant accounts is based on years of continuous service. A participant is 100% vested after three years of credited service and 0% vested prior to achieving this service requirement. Participants who die or terminate employment due to becoming disabled become 100% vested in the Company's discretionary contribution portion of their participant accounts.

## Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

## Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 62. The total vested portion of a participant's account balance is distributed in the form of a rollover, lump sum payment or installments under several arrangements defined in the plan document. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the plan document. Hardship withdrawals are permitted for medical expenses, tuition and related educational fees, principal home purchase or eviction prevention, major repair of damage to principal residence and burial or funeral expenses.

## Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,585 and \$0, respectively. These accounts may be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, no forfeitures were applied to plan activities from forfeited nonvested accounts.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## Recent Regulatory Updates

The SECURE 2.0 Act was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions during 2024 and 2025 and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Effective January 1, 2025, and pursuant to SECURE 2.0 Act, the Plan adopted a provision to allow participants aged 60-63 to make additional catch-up contributions.

## Subsequent Events

Subsequent events were evaluated through September 15, 2025, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust funds:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Accordingly, First Business Bank, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental schedule, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

#### 6. Related-Party and Party in Interest Transactions

The Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### **8. Tax Status**

The pre-approved plan on which the Plan is based received a favorable determination letter, dated June 7, 2021, indicating that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Determination Letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **10. Delinquent Participant Contributions**

For the year ended December 31, 2024, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$3,121 in 2024. Additionally, as of August 2025, the Company has compensated participants for lost earnings resulting from the delay in contributions.
