NOTES TO THE FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE A - DESCRIPTION OF PLAN

The following brief description of the Synergy Business Innovation 401(k) P/S Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 2011, covering substantially all employees of Synergy Business Innovations and Solutions, Inc. (the “Company”) who have attained age eighteen and have completed three consecutive months of service with the Company and are not employees covered by a collective bargaining agreement or nonresident aliens. The Plan is a defined contribution plan under section 401(k) of the Internal Revenue Code (IRC) and subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 90% of their compensation on a pre-tax or after-tax basis, subject to the limits of the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Company will make a fully vested matching contribution to each participant’s account in the Plan of 100% of each dollar of 401(k) contributions up to 6% of covered compensation. This contribution is intended to satisfy a safe harbor contribution formula permitted by the Internal Revenue Service (IRS). By making the safe harbor matching contribution, the Plan will automatically satisfy the nondiscrimination requirements that otherwise would apply to 401(k) contributions made to the Plan. The Plan also allows for a discretionary matching contribution and a discretionary profit-sharing contribution on an annual basis. All participants share in the allocation of the discretionary matching employer contribution regardless of the hours of service during the year or their employment status as of the last day of the Plan year. In order to be eligible for the profit-sharing contribution, the participant must be employed on the last day of the Plan year and must have completed at least 1,000 hours of service during the Plan year. Discretionary matching contributions are allocated based on a discretionary percentage multiplied by the participant’s compensation during the year. The discretionary percentage is applied on a uniform basis for all participants. Discretionary profit-sharing contributions are allocated on a pro-rata basis to all eligible participants. There were no discretionary matching or profit-sharing contributions for 2024 or 2023. Participants direct the investment of their employer matching and discretionary profit-sharing contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s discretionary contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their contributions and employer contributions, including actual investment earnings thereon.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon death, disability, termination of employment, retirement, or a qualifying withdrawal. Hardship withdrawals from the participants' vested account balance are permitted by the Plan. A participant may request an in-service withdrawal equal to the vested interest in their account if the participant has attained age 59 ½. Benefit payments may be made in the form of a single lump sum, equal installments, or partial withdrawals. Participants who terminate employment with a balance of less than \$5,000 may receive an automatic rollover distribution of their balance into an individual retirement account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by an outstanding balance or by the highest outstanding balance in the past 12 months, or 50% of their account balance. Loan repayment periods may not exceed 60 months. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through bi-weekly payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses include amounts paid by the Plan for recordkeeping services, third-party administration services and investment advisory services. Administrative expenses are allocated to participant accounts based on a pro rata formula. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. To the extent expenses of administering the Plan are not paid by the Plan, the expenses are paid by the Company, and therefore, are not included in the accompanying financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE C - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund: Valued at the net asset value (NAV) of units of the collective investment trust fund as reported by the fund. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. The unit price of the investment is quoted on a private market that is not active; however, the unit price is based on underlying investments which are based on observable inputs. Participant transactions (purchases and sales) may occur daily. The Plan can redeem these investments daily. There are currently no redemption restrictions and no unfunded commitments on these investments.

Self-directed brokerage account: Plan participants can invest in publicly traded securities, registered investment companies (exchange-traded funds), interest-bearing cash and certain other investments through a self-directed brokerage account. The underlying investments held in the self-directed brokerage accounts are valued as follows:

Interest-bearing cash: Valued at cost plus accrued interest.

Exchange-traded funds: Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded.

Common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are managed by John Hancock Trust Company as of December 31, 2024 and 2023. John Hancock Trust Company is the trustee and recordkeeper for the Plan for the years ended December 31, 2024 and 2023, therefore these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid to John Hancock Trust Company are included in administrative expenses.

Edward Jones Retirement Plan Services is the investment advisor for the Plan. Fees paid to the trustees, recordkeepers and financial advisor all qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Notes receivable from participants are also considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE G - INTERNAL REVENUE SERVICE STATUS

The Plan has been organized as a prototype plan and is intended to satisfy the tax qualification requirements under Internal Revenue Code (IRC) 401(a) and is, therefore, not subject to tax under current income tax law. The Plan has elected not to request a separate determination letter with respect to the Plan's qualification under Section 401(k) of the IRC. The Plan is maintained to conform to the prototype and received a prototype opinion letter from the IRS dated June 30, 2020. The Plan has been amended since receiving the prototype opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market rate, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - RECONCILIATION TO FORM 5500

Certain amounts included on Schedule H, Parts I and II of the Annual Return/Report of Employee Benefit Plans (Form 5500) are presented in different groupings for purposes of the financial statements. This is due only to differences in financial statement presentation versus Form 5500 line classifications.

No reconciliation of net assets available for benefits per the financial statements to the Form 5500 is required for the years ended December 31, 2024 and 2023.

NOTE J - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would require disclosure in the financial statements.
