Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Puget Sound Pipe & Supply Co., Inc. Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Puget Sound Pipe & Supply Co., Inc. Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A.--DESCRIPTION OF PLAN

The following description of the Puget Sound Pipe & Supply Co., Inc. (Company) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) and profit sharing plan originally established by the Company effective January 1, 1977. The Plan was amended and restated January 1, 2021 to comply with both the requirements of the hardship distribution final regulations and the requirements of the Further Consolidated Appropriations Act, 2020. This restatement is considered the Cycle 3 restatement. Effective January 1, 2023, the Plan was amended to increase the automatic enrollment of participants from a 3% deferral rate to a 4% deferral rate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by Puget Sound Pipe & Supply Co., Inc. or any affiliate who has adopted the Plan. An employee becomes eligible to participate in the plan after completing six months of service and reaching 18 years of age. The entry dates are quarterly, the first day of each quarter.

Contributions: The Plan is funded by eligible participant elective deferrals which may range from 1% to 100% of eligible compensation and discretionary Company matching contributions, and non-elective contributions at the option of the Company's board of directors. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. See also Note J. Also, all participants who are eligible to make elective deferral contributions may elect to designate all or any portion of their deferrals as Roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Through December 31, 2022, participants were automatically enrolled at 3% unless they had an affirmative election in place. Effective January 1, 2023, participants are automatically enrolled at 4% unless they have an affirmative election in place. Contributions are subject to certain limitations set by law. For the year ended December 31, 2024, the Company matched 25% of elective deferrals, up to a maximum of \$1,000.

Participant Accounts: Each participant's account is credited with the participant's contribution, allocation of the Company's contributions and plan earnings (losses) and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, account balance, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

NOTE A.--DESCRIPTION OF PLAN (Continued)

Vesting: Participants are immediately vested in their rollover contributions and elective deferrals, plus actual earnings thereon. Vesting in Company discretionary matching and non-elective contributions is based on years of continuous service at the rate of 20% per year after two years of service. A participant is 100% vested after six years of credited service or upon death or disability.

Retirement: The normal retirement date is the date the participant turns 65. Early retirement for a participant is the later of the attainment of age 55 and 5 years of vesting service.

Payment of Benefits: On termination of service due to any reason other than death, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions at a minimum age of 59 ½ shall be a single lump-sum paid in cash and are only allowed if the account is fully vested. Upon death of a participant, payments made to a beneficiary shall be payable in full by the end of the fifth year. For required minimum distributions, a participant may choose a lump-sum or an amount in equal installments over the life of the participant or the participant and their designated beneficiary. In-kind distributions are only available from self-directed brokerage accounts. For terminated participants, with balances of \$5,000 or less, the balance will be rolled over to a qualified plan or IRA unless a participant elects a lump sum. Hardship distributions are allowed in accordance with the provisions of the Plan.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years, except for the purchase of a primary residence. The loans are to bear an interest rate of prime plus 1%. The loans are secured by the balance in the participant's account. Spousal consent is required. A participant may only have one outstanding loan at a time. Principal and interest are paid through payroll deductions.

Investment Options: Participants are allowed to direct their contributions and account balances in various investment options among the investments offered under the Plan. The Plan sponsor periodically reviews the investment fund options available to participants and changes them as warranted. In addition, the Plan offers a self-directed brokerage fund in which participants may select alternate funds.

Forfeited Accounts: Forfeitures of terminated participants' nonvested account balances may be used to pay Plan expenses, restore forfeitures, or reduce the Company's discretionary or non-elective contributions. Forfeitures used were \$4,880 and forfeited accounts were \$8,616 during the year ended December 31, 2024. The balance of unused nonvested account balances forfeited into the Plan as of December 31, 2024 and 2023 were \$5,780 and \$1,986, respectively.

Plan Expenses: Mutual fund expenses, including any 12(b)(1) revenue sharing fees are deducted from each fund's earnings to arrive at net appreciation (depreciation) in fair value of investments as reported in the accompanying statement of changes in net assets available for benefits. Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain Plan administration expenses are paid for directly by the Company and are excluded from these financial statements. Fees relating to administration of certain withdrawals and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by the investment advisor and custodian. See Note D for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, other than self-directed brokerage accounts and notes receivable from participants, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, (the custodian of the Plan).

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: The Plan allows participants to invest up to 100% of their Plan balance in self-directed brokerage accounts. Available funds under this feature are subject to certain limitations but generally include: Stocks, fixed income securities (including corporate and government bonds), exchange traded funds, and mutual funds. Holdings as of December 31, 2024 and 2023, included interest-bearing cash, corporate stocks, exchange traded funds and mutual funds.

Interest-bearing cash: Valued at carrying value which approximates fair value.

Corporate stocks and exchange trade funds: Valued at the closing price reported on the active market on which the individual securities or the exchange trade funds are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E.--FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invests in the Standard Stable Asset Fund II which is a deposit administration contract with Standard Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Contract value of the Plan's investment in the fund was \$2,166,433 and \$2,359,907 at December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan that is declared quarterly. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. The Standard may terminate the contract with 30 days' advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time.

Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

NOTE F.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments may be in funds managed by the custodian, Charles Schwab Trust Bank; therefore, these transactions would qualify as party-in-interest transactions. Additionally, the self-directed brokerage accounts managed by RBC Wealth Management and Morgan Stanley as of December 31, 2024 and 2023 may hold funds that would qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. Certain officers of the Company serve as trustees of the Plan. No such officer or employee receives compensation from the Plan.

NOTE G.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan including employer contributions shall become fully vested and non-forfeitable.

NOTE H.--TAX STATUS

Effective January 1, 2021, the Company adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust, along with cumulative amendments, were designed in accordance with applicable sections of the Internal Revenue Code (IRC).

The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE J.--SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan adopted the optional provision under the SECURE 2.0 Act allowing higher catch-up contributions for participants aged 60-63. The Plan has not been formally amended to reflect the adoption of the optional provision as of the date the financial statements were available to be issued.

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.
