## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Woodward Management Partners LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Woodward Management Partners LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **Note A**

**Description of Plan**

The following description of the Woodward Management Partners LLC 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. More complete information regarding items such as vesting, benefit provisions and plan termination may be found in the Summary Plan Description, and also in the Plan Document, which is available to all participants upon request.

**General:**

The Plan is a defined contribution plan established on January 1, 2009, and has been amended and restated throughout the years to comply with tax regulations. The Plan provisions cover all employees, except union employees and non-resident aliens who receive no earned income which constitutes income from services performed within the United States, of Woodward Management Partners, LLC and Inwood Holding LLC (referred collectively hereafter as the "Company"). Effective October 1, 2023, employees are eligible to participate upon completing 90 days of service and are at least 18 years of age. Prior to October 1, 2023, employees were eligible to participate upon completing 6 months of service. Employees may enter the Plan on the first day of the quarter subsequent to satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Those charged with governance of the Plan determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Plan Amendments:**

Effective October 2023, the Plan changed trustees and transferred Plan assets from Mid Atlantic Trust Company to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. As part of this change, the Plan was amended and restated effective October 1, 2023, to adopt the pre-approved adoption agreement sponsored by Principal Financial Group and to modify the eligibility requirement to 90 days of service.

**Contributions:**

Participants may contribute up to 100% of pretax annual compensation up to IRS limits, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for participants to make Roth elective contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollovers"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Company may make a matching contribution at the discretion of the Company's owners. For the year ended December 31, 2024, the discretionary matching contribution was equal to 50% of contributions up to 10% of the participant's deferral. Additionally, nonelective profit sharing contributions may be contributed by the Company. No nonelective contributions were made during the year ended December 31, 2024. Contributions are subject to certain statutory limitations.

**Note A**

**Description of Plan (Continued)**

Participant Accounts:

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of (a) the Company's nonelective contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits:

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum. For termination of service due to other reasons, a participant whose vested balance does not exceed \$5,000 will receive an automatic lump-sum distribution; participants whose vested balance exceeds \$5,000 may elect to receive the value as a lump-sum distribution. Effective January 1, 2019, a participant may make a hardship withdrawal in the event of severe financial need (as defined by Internal Revenue Service Regulations). Also effective January 1, 2019, participants are also entitled to receive a distribution of all or any portion of their vested account balances upon attainment of age 59 1/2.

Forfeited Accounts:

At December 31, 2024, forfeiture accounts totaled \$52,549 (\$31,210 at December 31, 2023). Forfeitures resulting from termination of non-vested participants are used to offset employer contributions and to pay Plan expenses. During 2024, forfeitures of \$5,986 were used to offset employer contributions and forfeitures of \$22,057 were used to pay Plan expenses.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid through payroll deductions.

**Note B**

**Significant Accounting Policies**

Basis of Accounting:

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note H for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions:

Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Note B**

**Significant Accounting Policies (Continued)**

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments to participants are charged directly to the related participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Payments of Benefits:

Benefits are recorded when paid.

**Note C**

**Party-In-Interest Transactions**

Certain Plan investments are managed by affiliates of Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company). Principal Trust Company is the trustee as defined by the Plan. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

During 2024, the Company failed to remit to the trustee certain employee contributions and loan repayments totaling approximately \$67,762 within the period prescribed by Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions. The Company intends to make corrective contributions to the Plan in 2025 to compensate affected participants for lost earnings on the delinquent remittances.

**Note D**

**Information Prepared and Certified by Trustee of the Plan**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

**Note E**

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note F**

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note G**

**Income Tax Status**

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized profit-sharing plan with CODA adopted by the Plan, as then designated, qualifies under Section 401(a) of the IRC. The Plan administrator timely adopted the approved Plan. The Plan administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note H**

**Fair Value Measurements**

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three Levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the fund.

*Interests in pooled separate accounts:* The fair value of the units of pooled separate accounts is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of the underlying assets in the account, less the liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There are no unfunded commitments for these investments.

*Interests in common collective trust funds:* Valued at the net asset value (NAV) of units of the collective trusts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There are no unfunded commitments for these investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
