### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of F.H. Paschen Companies Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

### ***Basis for Opinion***

### 1. Description of the Plan

The following description of the F.H. Paschen Companies Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all salaried union and all non-union employees of FHP Management, Inc.; F.H. Paschen, S.N. Nielsen & Associates LLC; Stalworth Underground LLC; FHP Tectonics Corp.; and F.H. Paschen Vertical Concrete LLC (the Companies) who have attained the age of 21 and have three consecutive months of service with at least 250 hours for 401(k) participation. In order to be eligible for profit-sharing participation, employees must have worked at least 1,000 hours of service per year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the F.H. Paschen Companies Retirement Savings Plan Committee (the Committee), which serves at the discretion of the Companies' Board of Directors. The Committee is responsible for all matters, including, but not limited to, determining eligibility, rights to benefits, interpreting Plan documents, and directing the Plan's trustee.

#### *Contributions*

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Code (IRC) of their pre-tax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Each year, the Companies may elect to contribute a discretionary profit-sharing contribution to the Plan, as determined by the Companies. Contribution amounts are allocated to eligible participants based upon compensation and union participation as defined in the Plan document. To be eligible, participants must have attained the age of 21, completed one year of service working at least 1,000 hours, and be classified as an active employee on the last day of the Plan year, and then eligible participants may be allocated a portion of the Companies' contribution at the discretion of the Plan administrator. For the Plan year ended December 31, 2024, the Companies did not make a profit-sharing contribution.

The Companies may also elect to make discretionary matching contributions for non-union participants who are employed by the Companies on the last day of the Plan year, and who have completed at least 1,000 hours of service during the Plan year. Contributions are subject to certain IRC limitations. Discretionary matching contributions to the Plan are based on a percentage of compensation that a participant contributes to the Plan. For the Plan year ended December 31, 2024, the Companies contributed \$722,539 of discretionary matching contributions to the Plan.

Participants may direct all their contributions among one or more funds offered by the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions; the Companies' discretionary matching contributions, if any; allocations of the Companies' discretionary profit-sharing contributions, if any; and Plan earnings or losses. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Payment of Benefits***

On termination of service due to retirement, death, disability, termination of employment, or attainment of age 59½, a participant will generally receive their vested interest in his or her account as a lump-sum amount. If the participant's vested interest in their account is less than \$1,000, a mandatory lump-sum distribution is made to the participant. If a participant's vested interest in their account is between \$1,000 and \$5,000, a mandatory rollover to an Individual Retirement Account is made in the name of the participant. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with the provisions specified in the Plan.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' discretionary matching and profit-sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant vests in increments of 25% per year and is 100% vested in the Companies' contributions after four years of service, or upon death or disability if still employed by the Companies.

### ***Forfeited Accounts***

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,551 and \$14,851, respectively. Forfeited non-vested amounts attributable to company contributions may be used to pay administrative expenses, reduce future company contributions, or may be allocated to participant accounts. Forfeitures amounting to \$10,058 and \$14,108 were used to reduce company contributions for the years ended December 31, 2024 and 2023, respectively.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Contributions and Contributions Receivable*

Participant contributions are recognized in the period during which the Companies make the respective payroll deduction from the participant's compensation. Employer matching and profit-sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### *Benefit Payments*

Benefit payments are recorded when paid.

### *Administrative Expenses*

Fees related to requested distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including October 3, 2025, which is the date the financial statements were available to be issued.

No subsequent events have occurred through that date that required recognition or disclosure in the financial statements.

## **3. Information Certified by the Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Accordingly, the Plan's trustee, Capital Bank and Trust

Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the direction of the Plan administrator, the Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information provided by the trustee to the related information included in the financial statements and supplemental schedule.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies* - These assets are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

*Common Collective Trust* - This asset is valued using the NAV provided by the administrator of the fund. The NAV is based on the fair value of the underlying assets held by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments, which are traded on an active market.

Investments in the common collective trust can be redeemed immediately at the participant level. The Plan is required to provide notice to the fund in order to terminate either its entire amount or a portion of its investment interest at the current NAV per share based on the fair value of the underlying assets. The fair value of investments in this category has been estimated using the NAV per share as a practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

\* The common collective trust, which is measured at fair value using the NAV per share (or its equivalent) practical expedient, has not been categorized in the fair value hierarchy. ### 5. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the company contribution portion of their accounts.

### 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by affiliates of Capital Bank and Trust Company, the trustee of the Plan, (i.e., American Funds Group); therefore, these transactions qualify as party-in-interest transactions. Certain employees of the Companies provide administrative services to the Plan. These employees are not paid by the Plan for their services.

First American Bank, a consultant of the Plan, receives compensation from certain investments of American Funds to offset the costs of providing administrative services on behalf of the investments. An agreement was established during 2016 to redirect a certain dollar amount of compensation to the Plan on a quarterly basis, which will be deposited in the Plan's trust account. This compensation will be used to offset certain fees owed to the Plan's service providers for administrative services to the Plan. Fees received by the Plan under this agreement are included in other income on the statement of changes in net assets available for benefits.

### 7. Tax Status

The Plan adopted a pre-approved defined contribution plan from First American Bank, which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, stating that the pre-approved defined contribution plan document, as then-designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon the examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Delinquent Participant Contributions**

The Plan sponsor inadvertently failed to deposit \$250 of participant deferrals within the required time frame as stated by the DOL's rules and regulations relating to December 31, 2024. The DOL considers the late deposits to be a prohibited transaction. Lost earnings on the deposits were deposited to the trust in 2024. The Plan sponsor has filed Form 5330 and paid the applicable excise tax in for the 2025. The excise tax payments were made from the Plan sponsor's assets and not from assets of the Plan.
